Property Overview.

Orr Road Business Center is a 280,200-squarefoot industrial park consisting of two Class-A buildings located in the North Graham Submarket of Charlotte, North Carolina.

The property offers spaces ranging from 30,000 to 155,100 square feet, with features such as 32-foot clear heights, 6-inch reinforced concrete slabs, 180-foot truck courts with associated trailer parking, 59 ample dock-high doors (28 at building one & 31 at building two) and two drive-in doors each.

The Business Center is within reach of approximately 270,000 consumers within a 5-mile radius and is in close proximity to over 8,000 service-producing industries.
