

ECONOMIC DEVELOPMENT

The City partners with the Greater Oklahoma City Chamber and the Alliance for Economic Development of Oklahoma City to create new job opportunities for OKC residents by promoting expansion of existing businesses and recruiting new business. The City's Economic Development Trust offers a number of job creation incentives to new businesses, and OKC also promotes community development through its tax increment financing (TIF) districts.

ENERGY

If you come to Oklahoma City you won't want to miss the National Cowboy Hall of Fame, The Oklahoma City Zoo, Bricktown, and the Oklahoma City National Memorial, just to name a few. 
LIFE SCIENCES & HEALTHCARE
