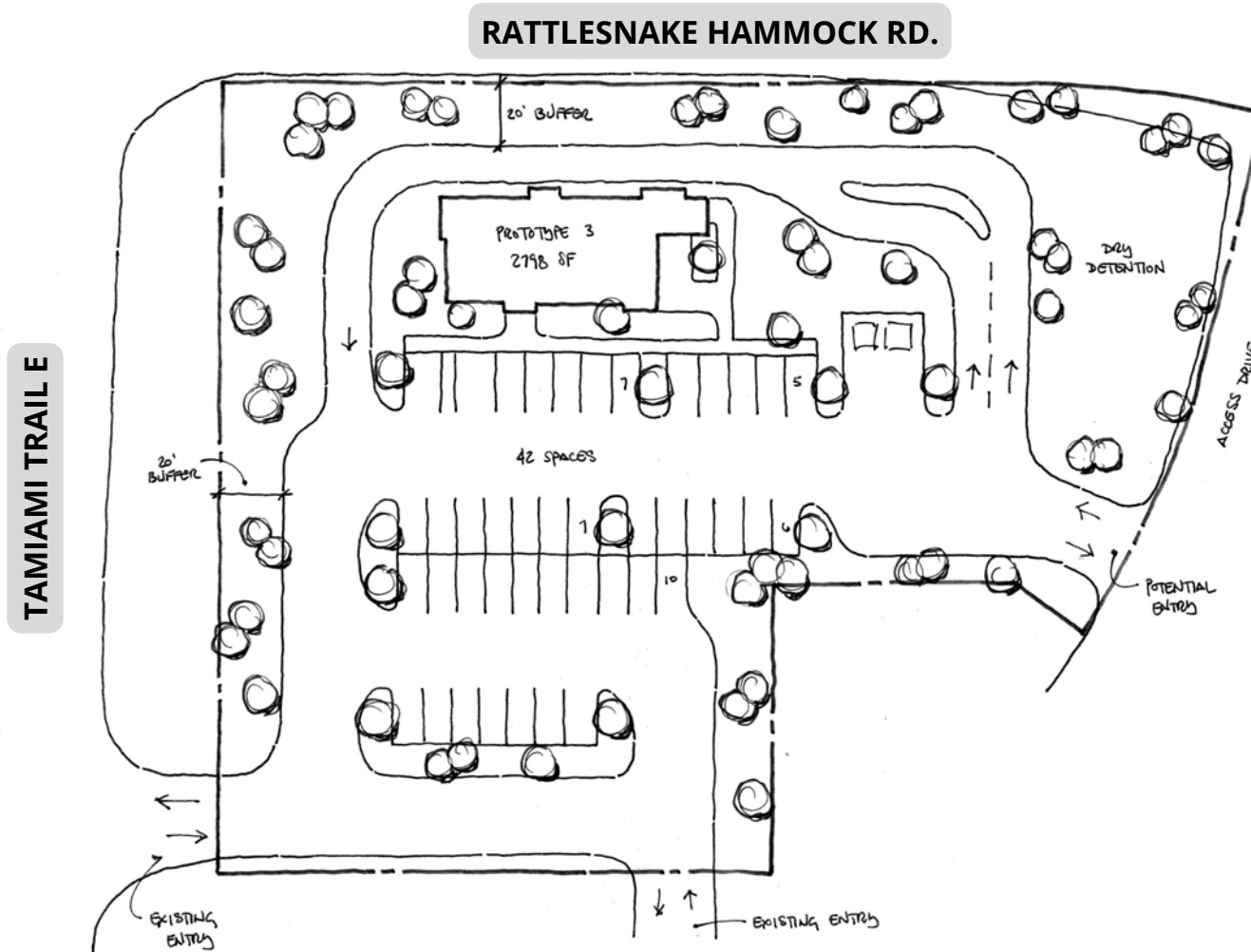

## POTENTIAL SITE PLAN





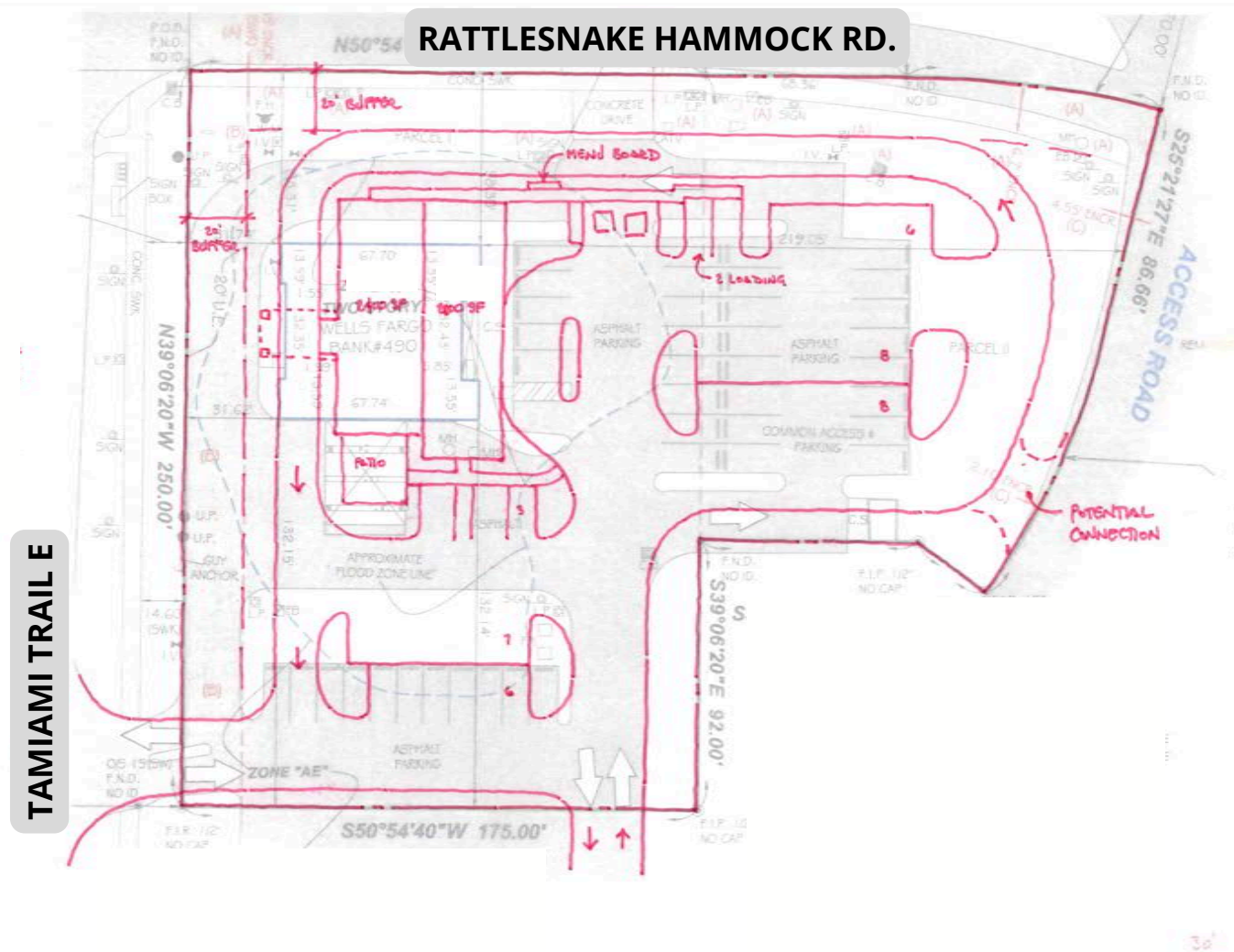
