KNOW ALL MEN BY THESE PRESENTS

THAT WE, JAMES P. SCALISE and LOIS J. SCALISE, husband and wife, of Dalton, Berkshire County, Massachusetts, for consideration paid in the amount of ONE DOLLAR (\$1.00), grant to FEDERICO REALTY CORP., a corporation duly established under the laws of Massachusetts and having its usual place of business at 2 Federico Drive, Pittsfield, Berkshire County, Massachusetts 01201, with QUITCLAIM COVENANTS, the land and buildings in Pittsfield, Berkshire County, Massachusetts, bounded and described as follows:

Lots No. 1, 6, 8, 9 and 10 as shown on a Plan entitled "BUILDING LOT PLAN Of FEDERICO OFFICE PARK Laid Out for James P. & Lois J. Scalise, Pittsfield, Massachusetts, Scale 1" = 80', December 5, 1986, Scalise-Knysh Associates, Inc.", recorded in the Berkshire Middle District Registry of Deeds in Drawer O, Plan 138 ("Plan"), and all the roadway as shown on said plan running northerly and northeasterly from East Street and identified on said Plan as Federico Drive.

Meaning and intending to convey and hereby conveying all of our right, title and interest in and to the real estate in Federico Office Park, together with and subject to all easements and encumbrances of record.
