LOCATION OVERVIEW

Swansboro, North Carolina, known as the "Friendly City by the Sea," is a quaint, historic town located on the North Carolina Coast boarding both the IntraCoastal Waterway and the White Oak River. Swansboro has historical sites to discover, eclectic shops to explore, and lots of 'family-friendly' recreation like biking, hiking, camping, and outdoor concerts.

The home of Hammocks Beach State Park and its unspoiled beaches, Swansboro boasts a beautiful small harbor adjacent to the Intracoastal Waterway and is only three miles from coastal recreational facilities in the Croatan National Forest.

Host to a wide variety of major events – from the Arts by the Sea Festival, the Mullet Festival, Candlelight Shopping, and the Christmas Flotilla to an annual Oyster Roast, an annual Pig Cook-Off, the Blue Water Fishing Tournament, the King Mackerel Tournament, and the Speckled Trout Tournament – Swansboro offers some of the best hospitality on the North Carolina coast.

Marine Corps Base Camp Lejeune is a 246-square-mile United States military training facility in Jacksonville, North Carolina, which is just 32 miles from Swasboro. Its 14 miles of beaches make the base a major area for amphibious assault training, and its location between two deep-water ports (Wilmington and Morehead City) allows for fast deployments. The main base is supplemented by six satellite facilities: Marine Corps Air Station New River, Camp Geiger, Stone Bay, Courthouse Bay, Camp Johnson, and the Greater Sandy Run Training Area.



TENANT OVERVIEW

Our story begins in 1971 along the cobblestone streets of Seattle's historic Pike Place Market. It was here where Starbucks opened its first store, offering fresh-roasted coffee beans, tea and spices from around the world for our customers to take home. Our name was inspired by the classic tale, "Moby-Dick," evoking the seafaring tradition of the early coffee traders.

Ten years later, a young New Yorker named Howard Schultz would walk through these doors and become captivated with Starbucks coffee from his first sip. After joining the company in 1982, a different cobblestone road would lead him to another discovery. It was on a trip to Milan in 1983 that Howard first experienced Italy's coffeehouses, and he returned to Seattle inspired to bring the warmth and artistry of its coffee culture to Starbucks. By 1987, we swapped our brown aprons for green ones and embarked on our next chapter as a coffeehouse.

Starbucks would soon expand to Chicago and Vancouver, Canada and then on to California, Washington, D.C. and New York. By 1996, we would cross the Pacific to open our first store in Japan, followed by Europe in 1998 and China in 1999. Over the next two decades, we would grow to welcome millions of customers each week and become a part of the fabric of tens of thousands of neighborhoods all around the world. In everything we do, we are always dedicated to Our Mission: to inspire and nurture the human spirit – one person, one cup, and one neighborhood at a time.






