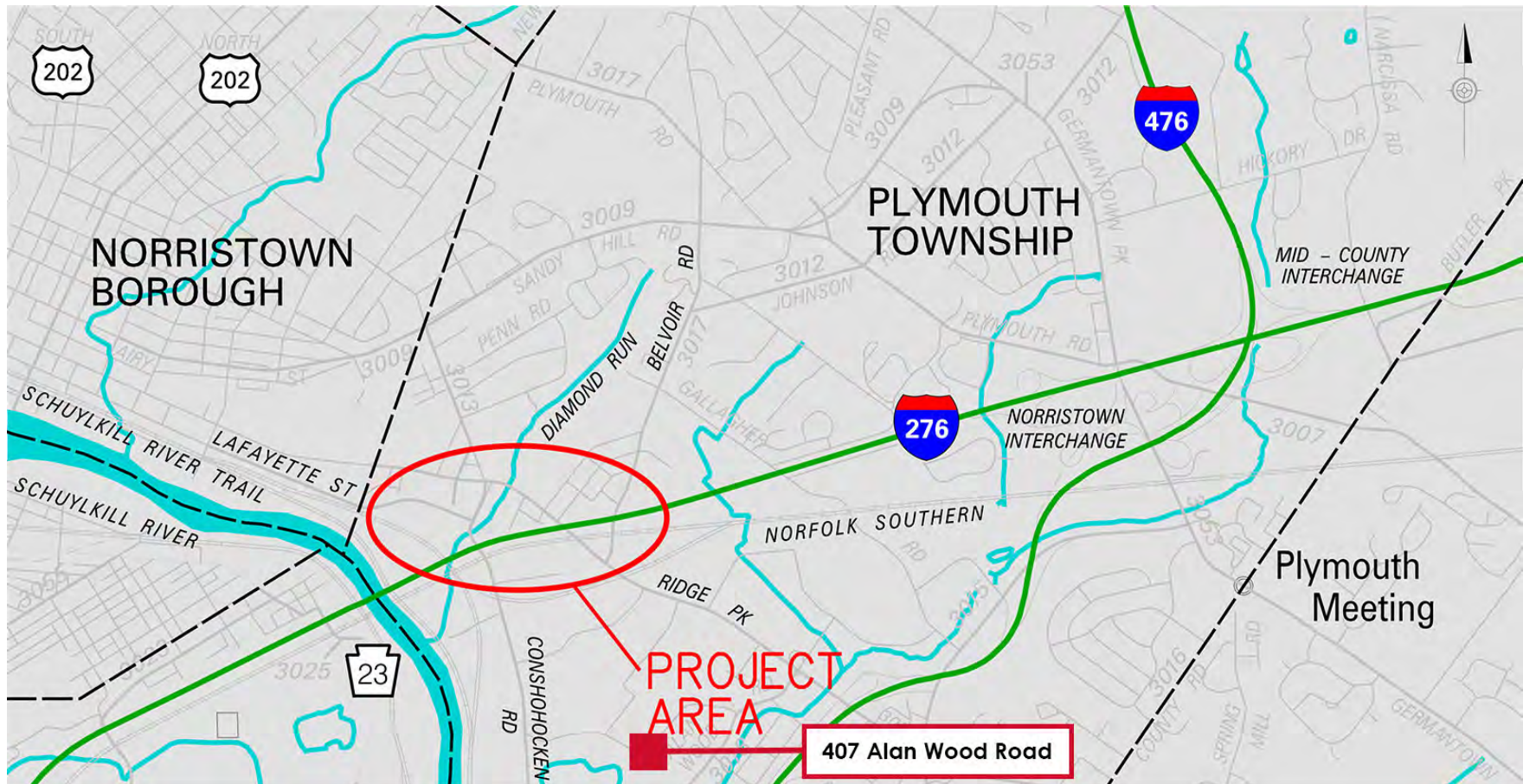

## LOCATION DESCRIPTION

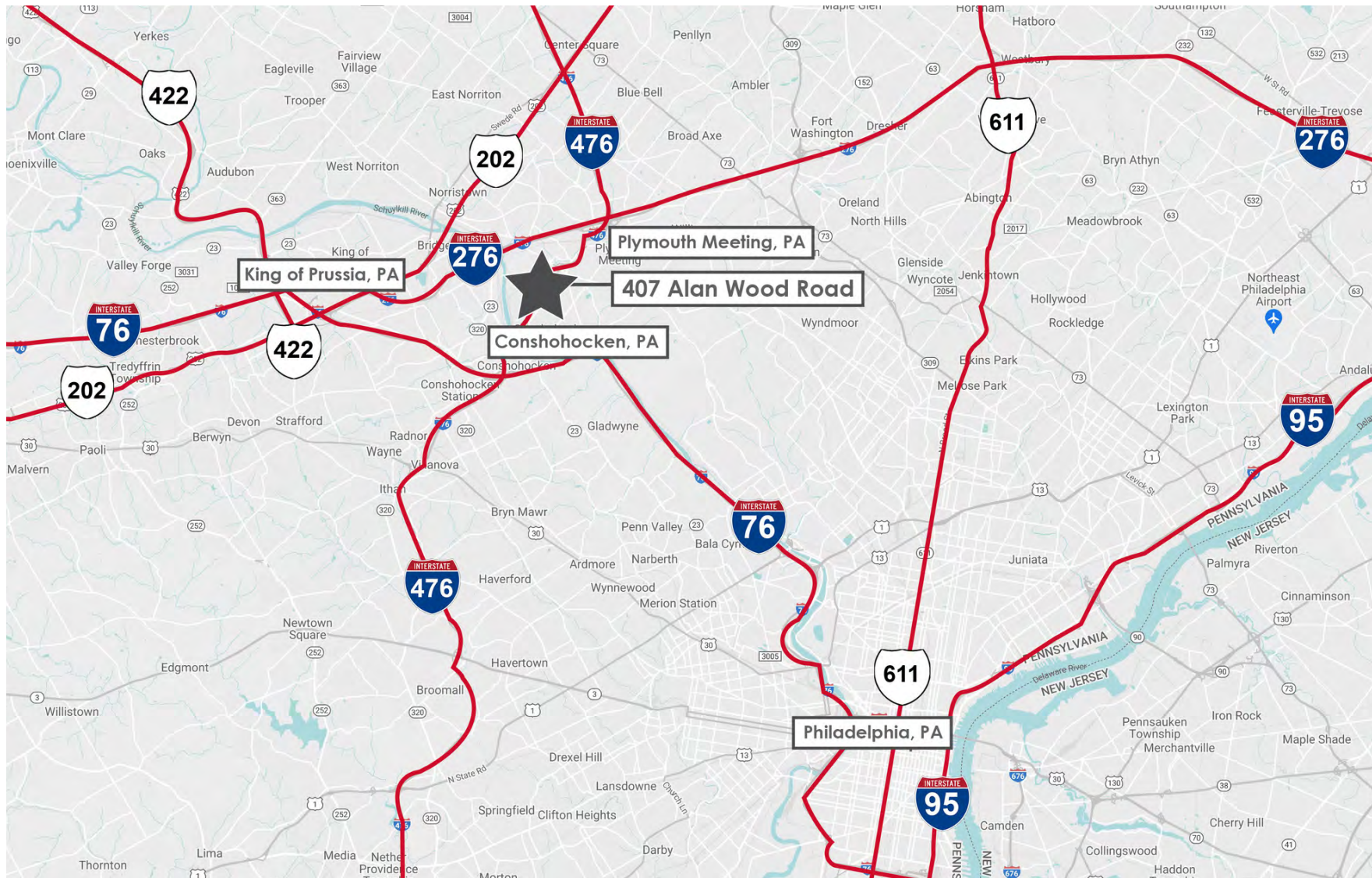
This property is located along Alan Wood Road in Conshohocken, Pennsylvania just off exit 18A on I-476 which provides quick access to I-276, I-76, Route 202, and Route 422. There is also an interchange project underway off of I-276 at the intersection of Ridge Pike and Conshohocken Road. Once completed, the subject site will provide even quicker access to the Pennsylvania Turnpike.

- **Allowable uses pursuant to municipal code:** Sanitary landfill, Trash transfer station, Waste recycling facility (recycling center), Incinerator, Resource Recovery facility, Any form of municipal solid waste disposal or processing not set forth in subsections 1 through 5 above.
- **Any use permitted in Heavy Industrial District:** Manufacturing of products from aluminum, brass, bronze, copper, iron, steel, tin, zinc or other metals; and from bone, glass, leather, paper, plastic, rubber, shell, wire or wood; or products of the same general character, Casting of such products enumerated in Section 1500.A. above, Fabrication of carpeting, clothing and clothing accessories, electric and electronic products, flooring, instruments, medical and testing equipment, and fabrication of the same general character, Processing of food and beverages, medicine and personal care products, excluding soap, and processing of the same general character, Food service or catering; provided, that no food is served to customers on-site, Printing of paper, plastic and metal, Research, development and testing of new products, laboratories, Warehousing and distributing, including storage for personal household, use.

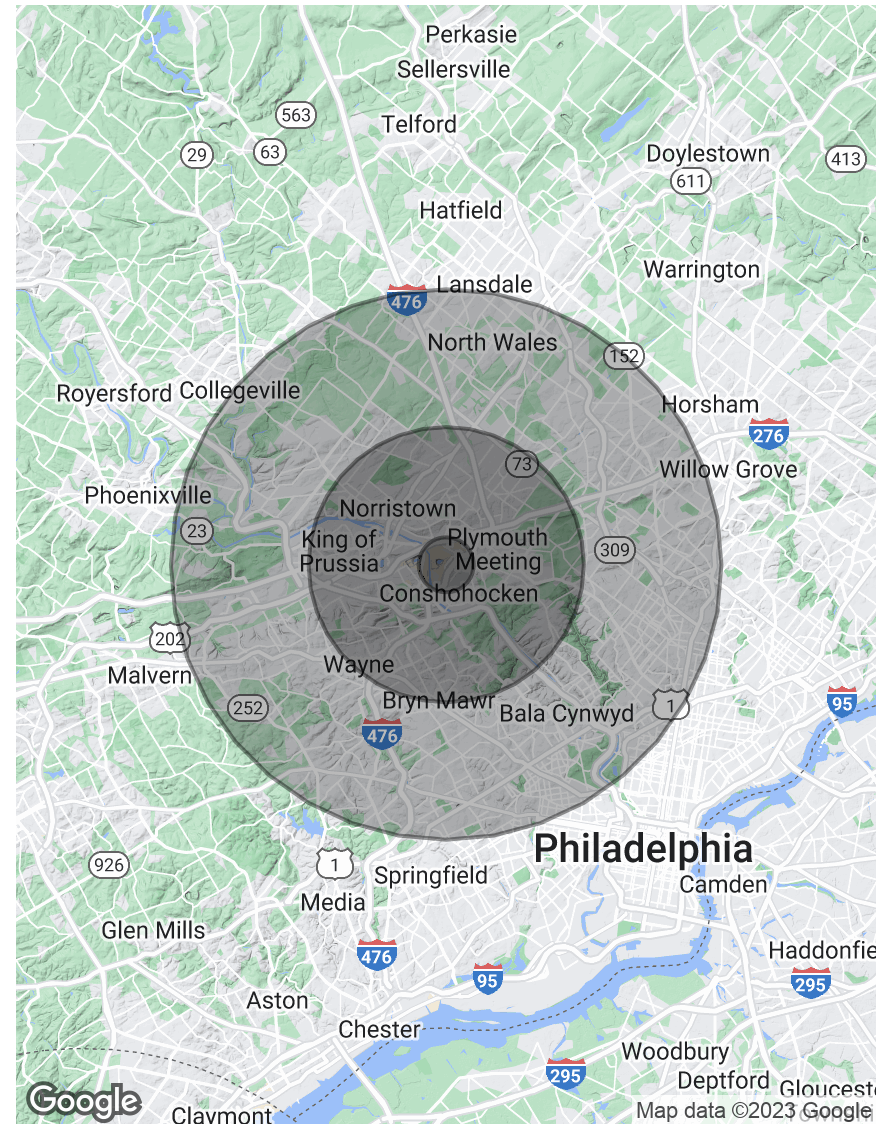
