

### Property Details

Boardwalk at Millenia is part of the Millenia masterplan, designed to be San Diego's next iconic urban village. This property is a mixed-used development with ±8,640 SF of ground floor retail in three separately demised spaces, along with 309 residential units. Location allows ease of access to SR-125 Toll Road & Birch Road. The master plan includes 3.5 million SF of retail, office, civic, hotel, non-residential uses, along with ±3,300 residential units. Nearby neighbors include Buy Buy Baby, HomeGoods, World Market and Ross. Boardwalk Apartments were completed in 2019, and have been stabilized (±90%) since 2020.






## About Millenia
