

In the identified area, the current year population is 109,427. In 2010, the Census count in the area was 74,083. The rate of change since 2010 was 3.88% annually. The five-year projection for the population in the area is 129,199 representing a change of 3.38% annually from 2020 to 2025. Currently, the population is 49.5% male and 50.5% female.

The median age in this area is 38.2, compared to U.S. median age of 38.5.

Currently, 79.4% of the 40,054 housing units in the area are owner occupied; 15.0%, renter occupied; and 5.6% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 27,718 housing units in the area - 77.3% owner occupied, 15.9% renter occupied, and 6.8% vacant. The annual rate of change in housing units since 2010 is 17.78%. Median home value in the area is \$334,865, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 0.93% annually to \$350,755.
