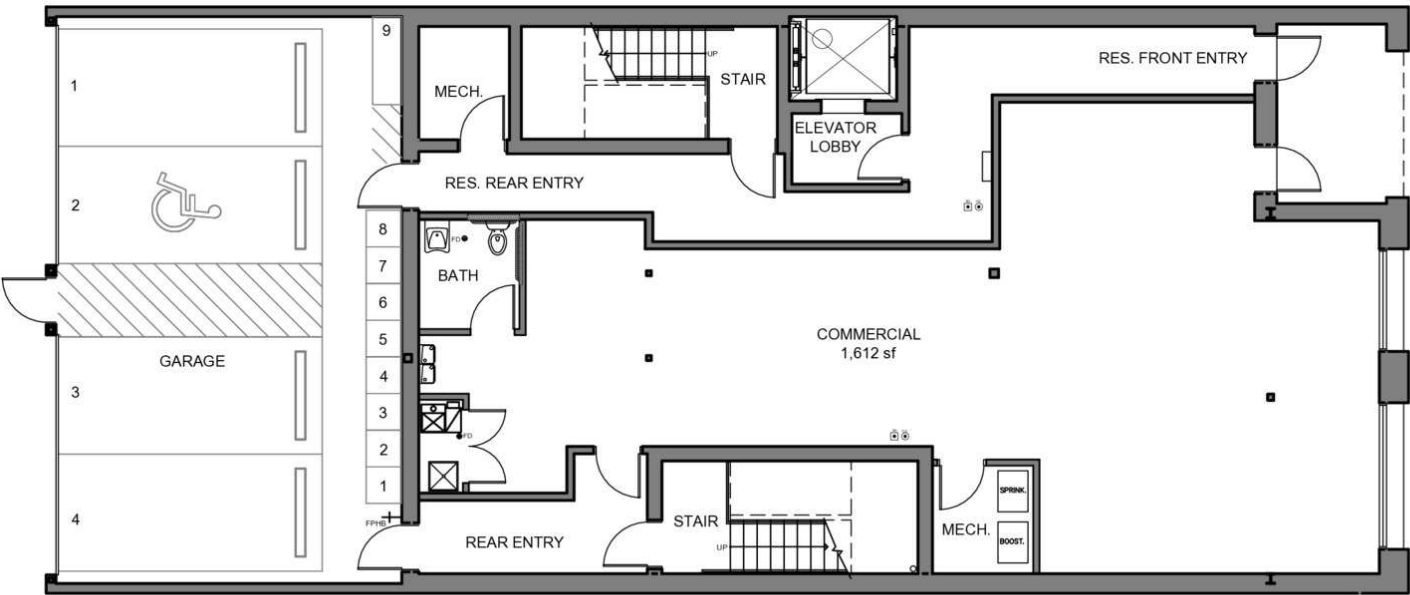

LOCATION DESCRIPTION

5630 N Broadway is located in Chicago's Edgewater neighborhood, a dense and diverse North Side community with strong renter and condo populations and a average household income of nearly \$100,000 and a population of 28,000. Within a ½-mile radius, the area supports steady foot traffic driven by nearby residential buildings, schools, and neighborhood services. The property offers excellent transportation access, with multiple CTA bus routes along Broadway and proximity to the Bryn Mawr and Thorndale CTA Red Line stations, providing direct connectivity to Downtown Chicago and Lakefront destinations. Area retailers include Whole Foods Market, CVS, Walgreens, neighborhood grocers, fitness studios, cafés, and a wide variety of local and international dining options, reinforcing Broadway's role as a well-established neighborhood retail corridor.

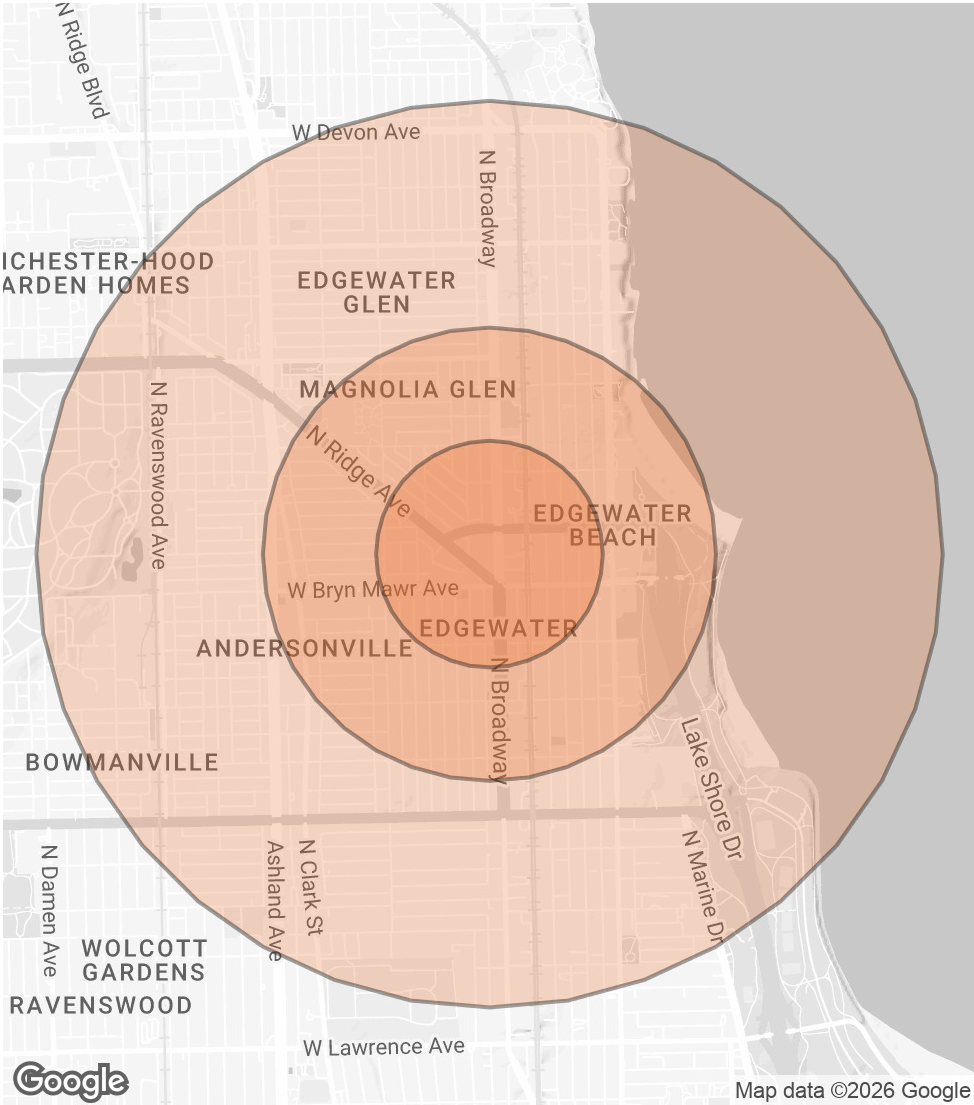
