


# PROPERTY OVERVIEW

# **TRANSPORTATION**



A major catalyst to the South Bronx's revitalization revolves around its proximity to midtown Manhattan and the various transportation options that services the residents going there. There are 7 subway stops in Mott Haven with access to the 2 4 5 and 6 subway lines. Commuters can be in Grand Central Terminal is roughly 25-minutes via the 4 5 or 6 train. Bronx residents are also serviced by over a dozen bus stops that canvass the neighborhood. The South Bronx is surrounded by a variety of interborough transportation options including the Madison Avenue Bridge, the Third Avenue Bridge, the Willis Avenue Bridge, the George Washington Bridge, the Triborough bridge and the Throggs Neck Bridge, and offers extremely convenient access to the FDR drive and major interstate highways such I-87 and I-278. The South Brox boasts elite proximity to Manhattan, Westchester, Long Island, and the State of New Jersey.
