

VICINITY MAP

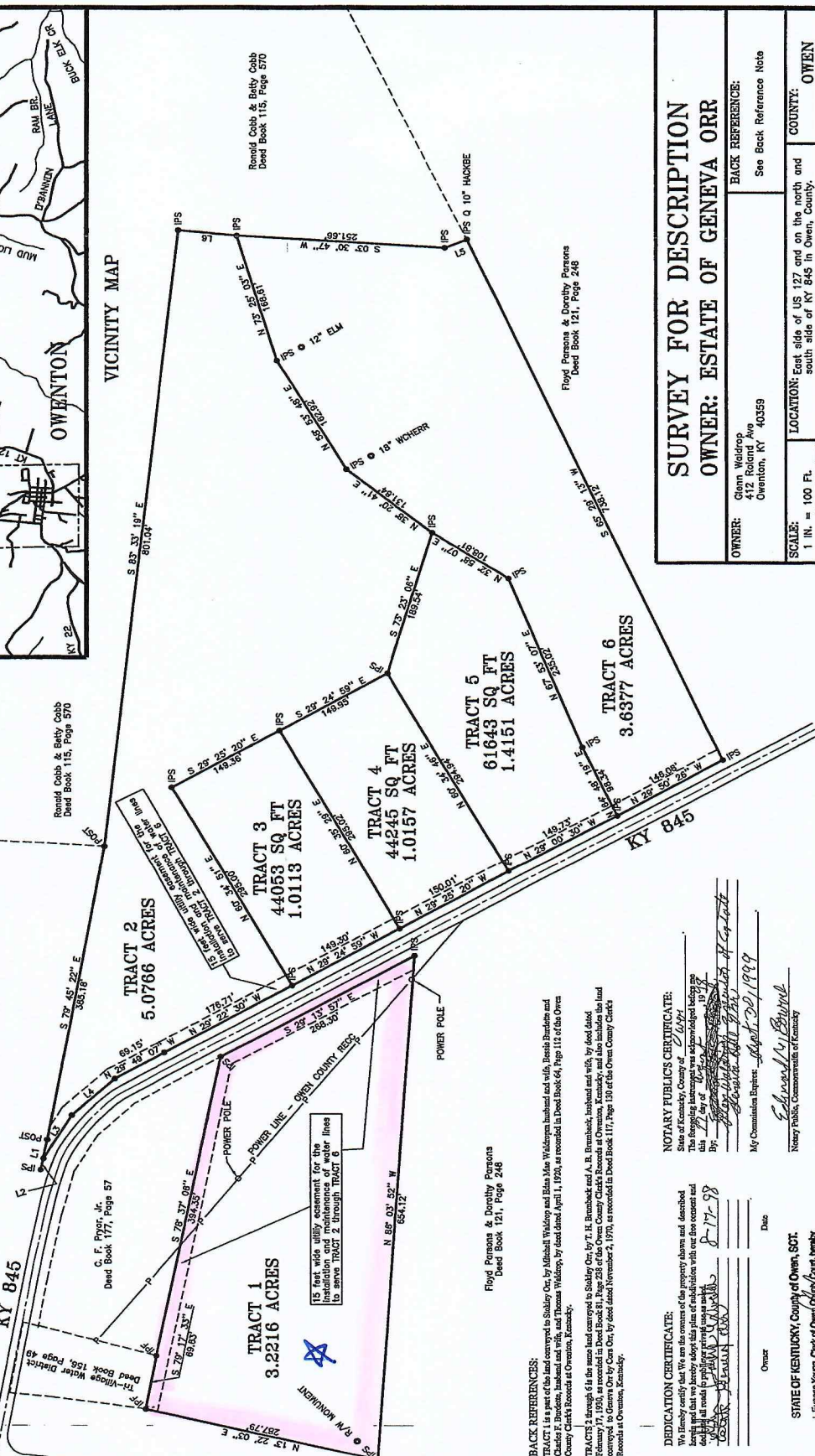
