## NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 28th day of September, 2021 by and between ROUMELCO PROPERTIES, LLC, a North Carolina Limited Liability Company, Grantor, to NATALIA SAFAR, Grantee, whose address is 3029 NE 188<sup>th</sup> Street, Unit 414, Aventura, Florida 33180.

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

## Witnesseth:

That the Grantors for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents do grant, bargain, sell and convey unto the Grantee in fee simple, all that certain tract or parcel of land situate in Nantahala Township, Swain County, North Carolina, and being more particularly described as follows:

BEING that certain tract or parcel of land lying in Nantahala Township, Swain County, North Carolina and being more particularly described as Lot Nos. 29-32 of Village Preserve at Nantahala Village Subdivision, containing 12,162.44 square feet, more or less, as described on that plat of survey entitled "Village Preserve At Nantahala Village" drawn by Sylvia E. Higdon, P.L.S. THIS CONVEYANCE IS MADE SUBJECT TO all easements for existing roads and public utilities, including water lines, power lines, cable lines, sewer lines and other similar utilities and to all easements which are shown on the various plats of the Nantahala Village Resort property which are of record in the Office of the Register of Deeds for Swain County, North Carolina, and to applicable restrictive covenants of record and to governmental rules and regulations which are applicable to said lands, if any, and to Swain County, North Carolina.

THIS CONVEYANCE IS EXPRESSLY MADE SUBJECT to those certain covenants, restrictions and conditions governing the Nantahala Village Resort and the Village Preserve at Nantahala Village contained in those certain instruments recorded in Book 125 at Page 1, Book 139 at Page 63, Book 339 at Page 951, Book 471 at Page 903 and Amended and Restated Declaration of Covenants, Conditions and Restrictions for Nantahala Village Resort in Book 495 at Page 186, Swain County Registry.

All of the lands, rights, privileges, easements and appurtenances as are described in and conveyed by the deed from William P. Eilf, Jr., joined by his wife, Samantha Eilf, to Wese, Inc. dated December 15, 2008, recorded in Book 339 at Pages 948-950, Swain County Public Records and being described therein as follows:

Lots 14-17; 25-28; 29-32; 34, 35, 36, 37, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, and 55 of the Village Preserve at Nantahala Village, as surveyed and platted by Herron Associates and shown on their boundary survey under date of December 8, 2006 Project No. 06052201, Sheet 157-377-A, which plat is of record in the Office of the Register of Deeds, Swain County, North Carolina in Plat Cabinet 4 at Slide 2030 to which plat as so recorded reference is hereby had for more complete and particular description of the lands, rights, easements and appurtenances hereby conveyed.

There are improvements located on the lands hereby conveyed and this instrument further conveys said improvements, together with all furniture, appliances, fixtures and other contents now located therein.

THIS CONVEYANCE IS MADE TOGETHER WITH AND SUBJECT to the right to use in common with all others who may now have or may hereafter acquire the right to use the same, the existing 20-foot wide road and utility right of way easement, as shown on said plat extending from the lands hereby conveyed in a general eastwardly direction to the point of intersection with US Highway 19/74.

THIS CONVEYANCE IS MADE TOGETHER WITH AND SUBJECT the right to take sufficient water for domestic residential purposes for each of the lots and improvements hereby conveyed, from the existing water system servicing the lands hereby conveyed and other portions of the Nantahala Village development, in common with all other parties who now have or hereafter acquire the right to utilize said water supply, and together with the right to maintain, repair and replace the underground water pipelines running from the reservoir to the lands hereby conveyed as the same are now in existence, the well and reservoir and the underground water pipelines connecting the same and all pumps and electric supply sources which form the water supply system.

THIS CONVEYANCE IS MADE TOGETHER WITH AND SUBJECT the right to use in common with all other parties who may now have or may hereafter acquire the right to use the same, the existing sewage disposal system, together with the right to maintain, repair and replace the pipelines, drain field areas and the disposal plant servicing the same.

The road, water and sewer rights hereby conveyed are conveyed subject to the obligation of Grantees to share in the cost of maintenance, operation, repair and replacement thereof, and to pay such fee as is established by the owners thereof, from time to time.

The rights of use are conditioned upon prompt payment of the assessments relating thereto. Grantees are additionally obligated to pay an annual improvement assessment in the amount of \$600.00 per lot, or as amended per lot, and payable on each January 1<sup>st</sup> or at a time as established by the owners.

EXCEPTED FROM THE LANDS hereby conveyed are those certain portions thereof which are described in the deeds of record in the Office of the Register of Deeds for Swain County, North Carolina.

THIS CONVEYANCE IS MADE SUBJECT to any and all Release Deeds of record in the Swain County, North Carolina Registry.
