





BACK UNIT 918 SF AVAILABLE











REGIONAL MAP

ALLEGHENY COUNTY

Allegheny County is a county in the southwestern part o Pennsylvania (PA). It is the second most populous county in PA followed by Philadelphia County. Allegheny County was the first in PA to be given a Native American name, being named aer the Allegheny River. Allegheny County was created in September o 1788 rom parts o Washington and Westmoreland counties and originally extended all the way north to the shores o Lake Erie and became the "Mother County" or most of northwestern PA before the counties current borders were set. The area developed rapidly throughout the 19th century to become the center o steel production in the nation. The county is known or the three major rivers that flow through it, the Allegheny, the Monongahela, and the Ohio Rivers. Allegheny County is home to three National Sports Teams, multiple major top ten companies as well as various colleges and universities. The county consists o 4 cities, 84 boroughs and 42 townships.


SOUTH PARK


