

Oswego is a city in northeast Kendall County, Illinois, in the United States. It is the largest municipality in Kendall County sitting at a population of 35,316 according to the 2020 census, almost tripling its count of 13,326 in the 2000 Census. Kendall County is known for being one of the top counties for families, public schools, young professionals, and outdoor activities. 85% of residents being homeowners and a strong per capita household income helps provides the community with sturdy economic base.

Downtown Oswego is home to historic buildings and homes, as well as shops and restaurants. The Village of Oswego launched a project to enhance and restore the historic downtown district.
