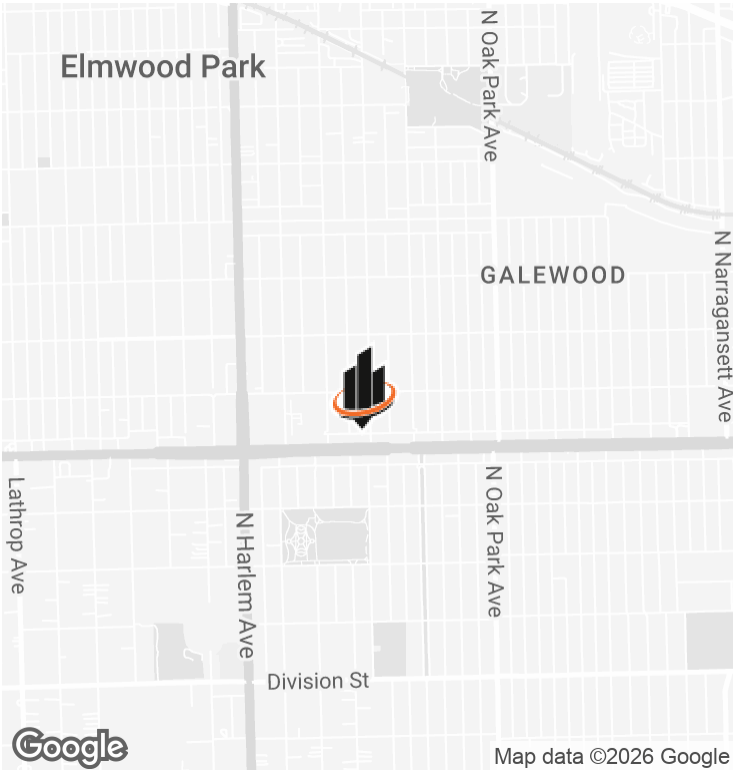

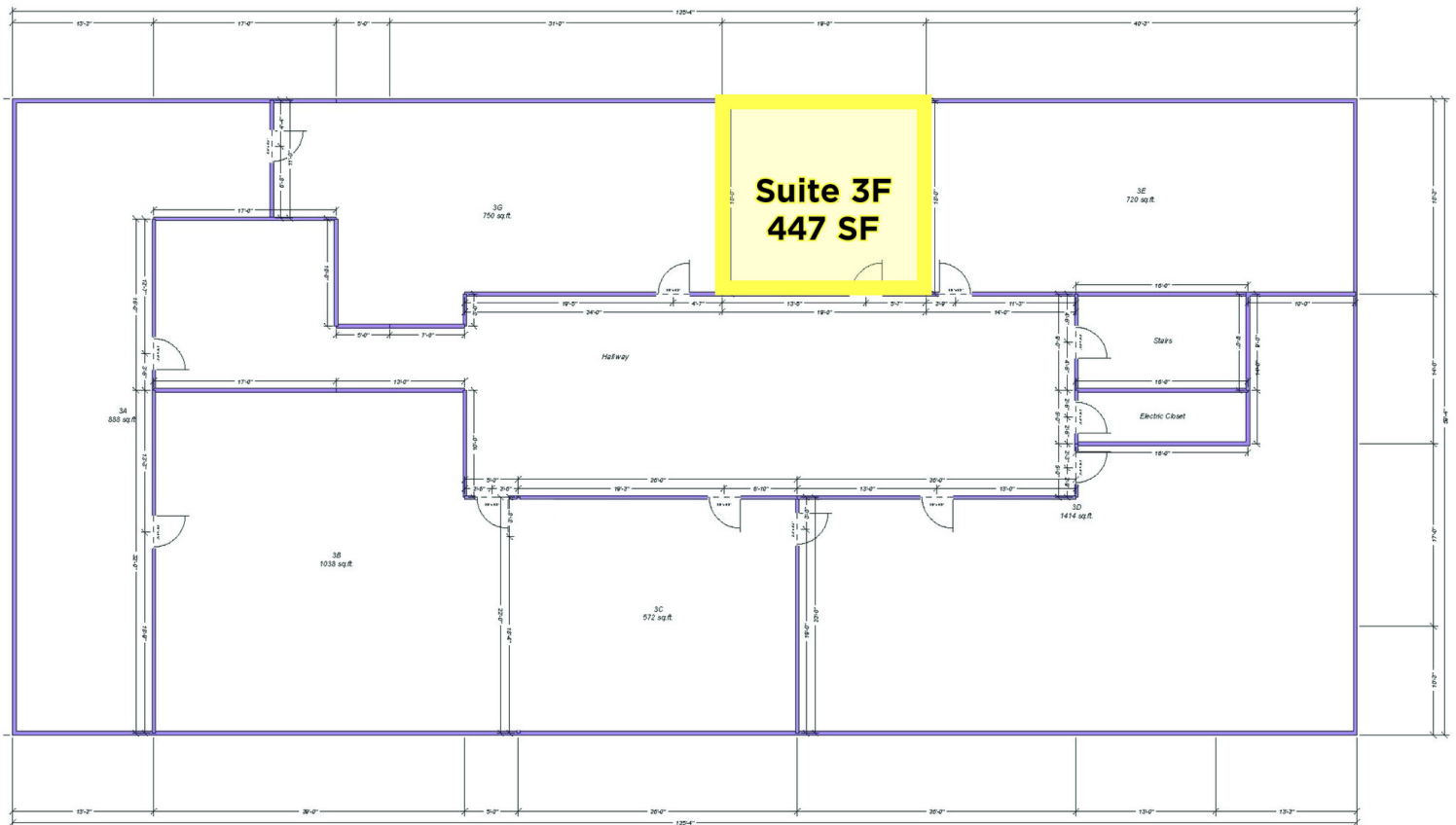

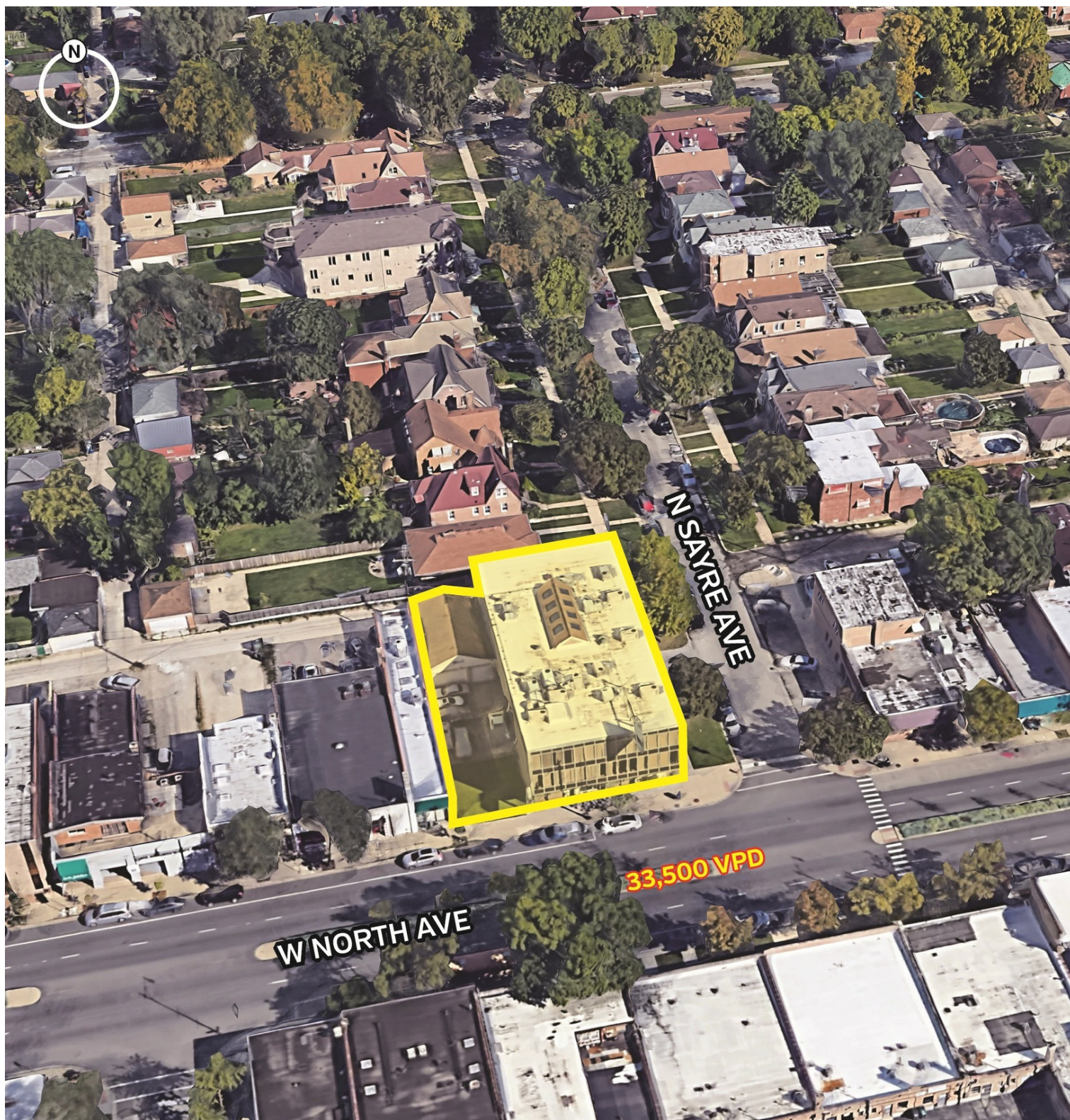

RETAILER MAP

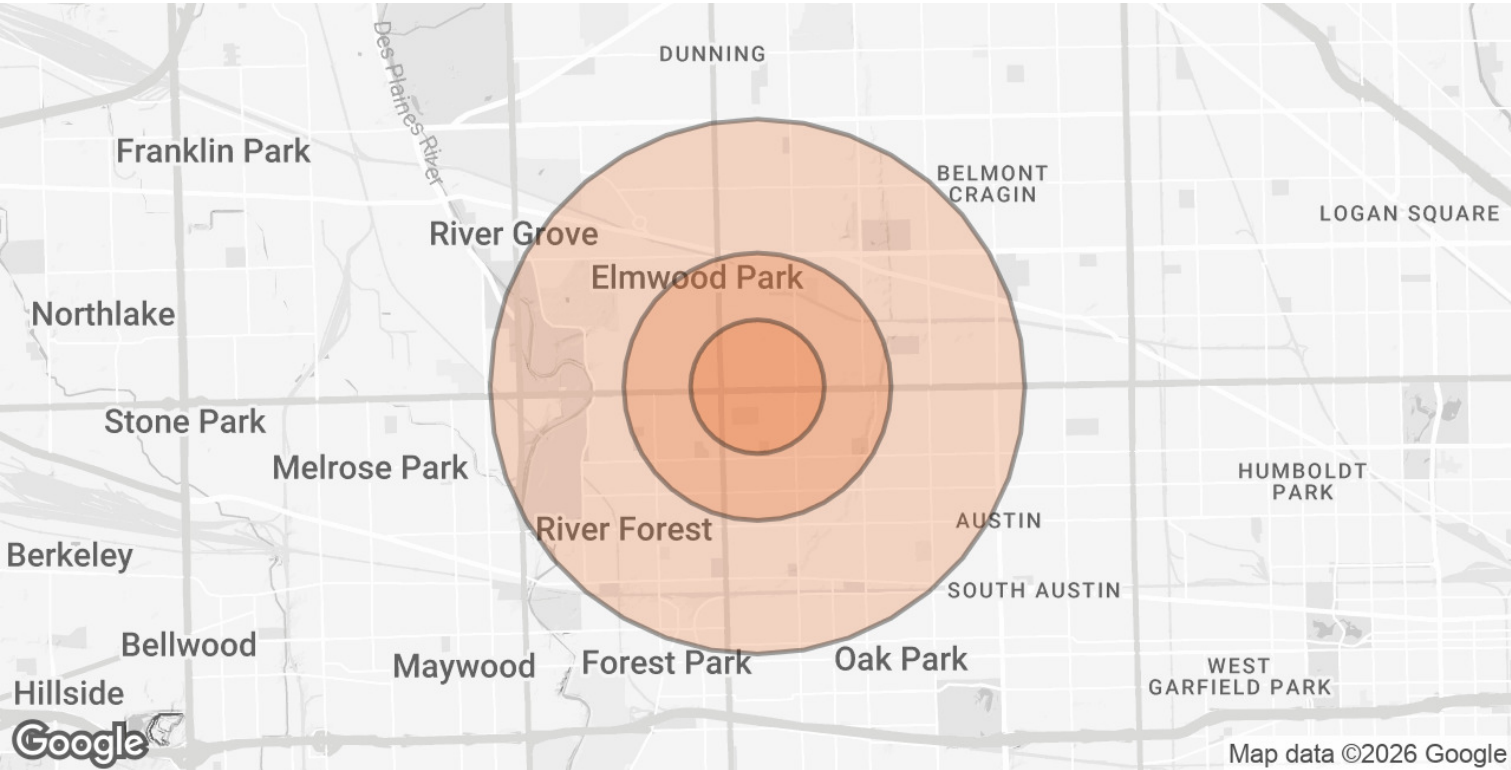
