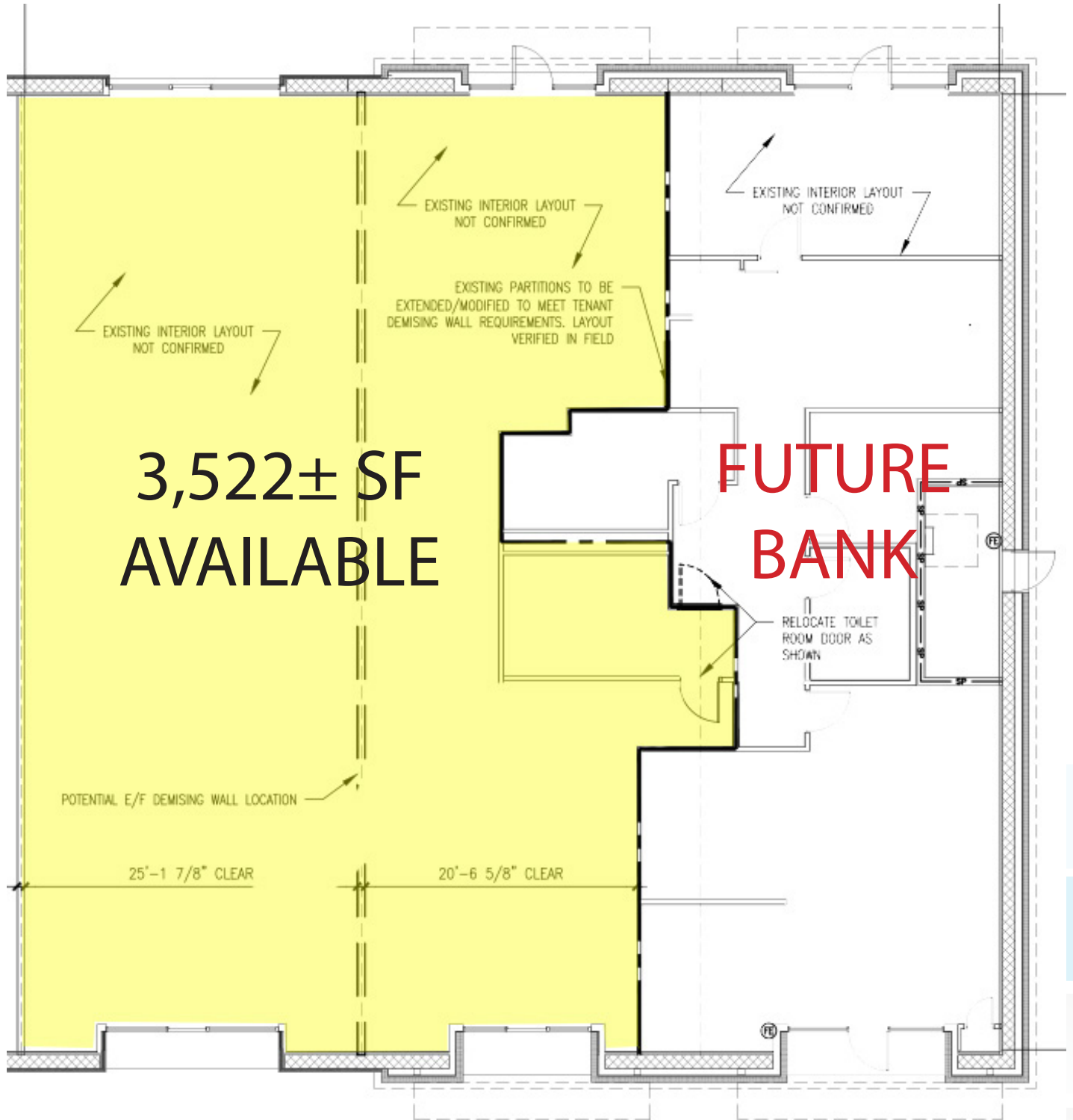

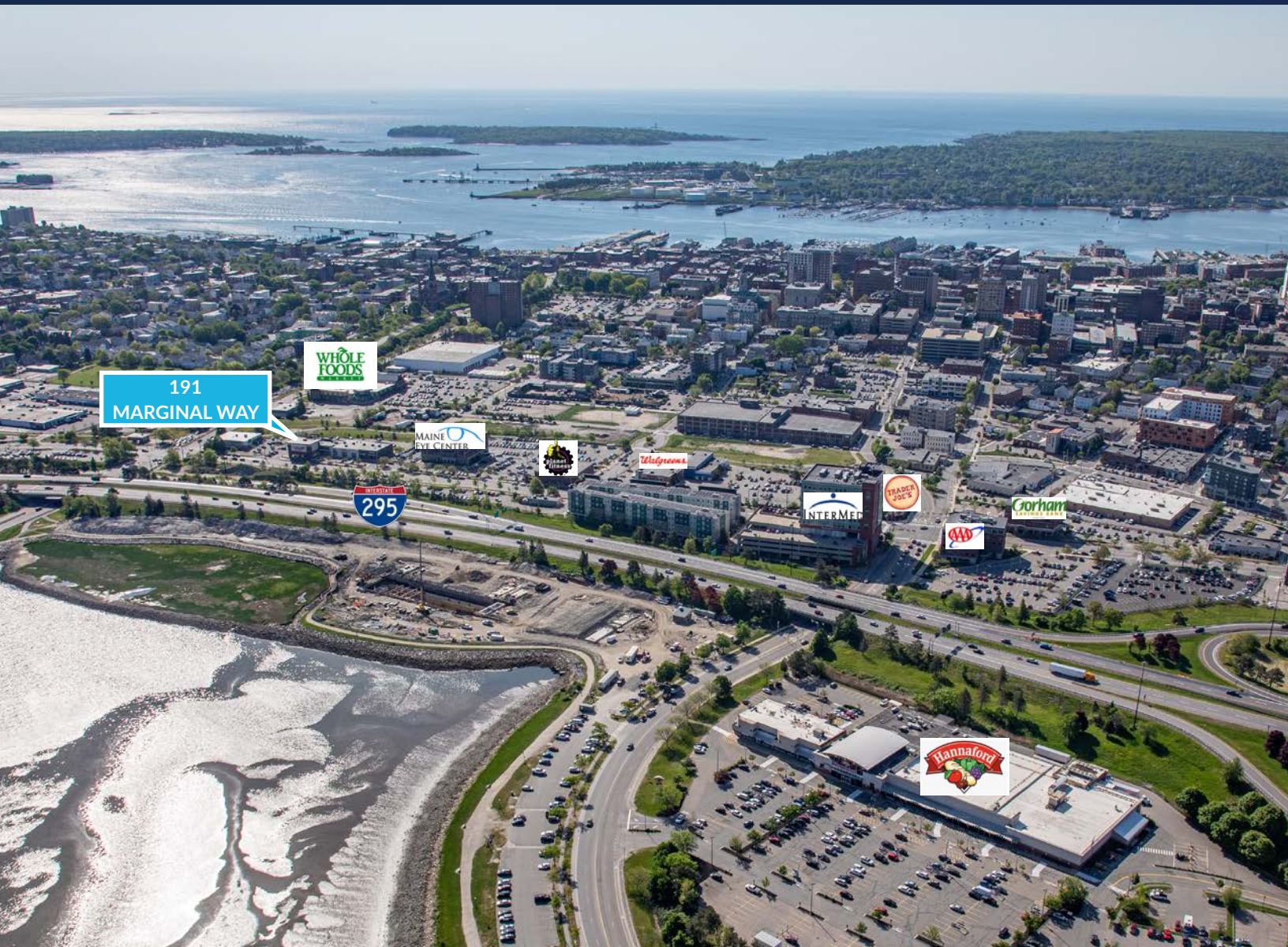


FLOOR PLAN
