




Property Overview

Building construction consists of masonry with brick and wood siding. The subject is currently 26.09% occupied. The complex currently has forty-two 1BR/1BA units and four 2BR/1BA. The subject site consists of .93 Acres of land near Jackson State University, in the city of Jackson, Mississippi.






