






PROPERTY DESCRIPTION



Information About Brokerage Services

Texas law requires all real estate licensees to give the following information about brokerage services to prospective buyens, tenents, seliens and tendionds

TYPES OF REAL ESTATE LICENSE HOLDERS:

- A SROKER is responsible for all traiserage activities, including acts performed by ealer agents operated by the broker. A SALES AGENT must be appreciated by a broker and works with clients on behalf of the broker.

CONCENTS IMPRILIABILITIES RECURRED BY LAW (A client is the pareon or party that the broken represents)

- Put the Interests of the client above all others, including the broken's own interests;
- Inform the client of any material information about the property or transaction received by the broker;
 - Anewer the clerifs questions and present any offer to or counter-offer from the cleric and
- Treat off parties to a roal actors transaction honselty and fairty.

a License Holder Can Represent a Party in a Neal Estate Transaction

AS ASSIT FOR CHRIST (BELLENLANDLORD): The broker becomes the property owner's agent through an agreement with the owner, usually in a written listing to sed or property management agreement. An owner's agent must perform the broker's minimum-duties above and must inform the owner of any material information about the property or transaction known by the agent, including information disclosed to the agent or subagent by the buyer or buyer's agent.

AS ACENT FOR BUYERTERANT: The broker becomes the buyentenents agent by agreeing to represent the buyer, usually though a willen representation agreement. A buyer's agent must perform the broker's minimum duties above and must inform the buyer of any material information about the property or transcribin frown by the agent, including information declared to the agent by the eather or eather's agent. AS ACENT FOR BOTH - ENTERMEDIANT: To act as an intermediary between the parties the broker must first obtain the written egreement of each party to the transaction. The written egreement must state who will pay the broker and, in conspicuous bold or underlined parts, est forth the broker's obligations as an intermediary. A broker who acts as an intermediary.

- Must treat oil parties to the transaction impartiefly and faitly.

 May, with the parties' consent, appoint a different license holder essociated with the broker to each party (owner and buyer) to communicate with, provide opinions and solvice to, and cany out the instructions of each party to the transaction.
 - Must not, unless specifically authorized in writing to do so by the party, disclose:
 - that the owner will accept a price has then the written assimp price;
- that the buyer/tenent will pay a price greater than the price automitted in a written offer, and ony confidential information or any other information that a party apacitically instructe the broker in writing not to disclose, unless required to do so by law.

AS SURFICENT: A license holder acts as authopent when eighty a buyer in a transaction without an agreement to represent the buyer. A subagent can assist the buyer but does not represent the buyer and must place the interests of the owner that.

TO AND DIFFUTES,ALL AGREEMENTS BETWEEN YOU AND A INCKER SHOULD BEINWRITHIS AND GLEARLY ESTABLISH

- The broker's duffee and responsibilities to you, and your obligations under the representation agreement.
- Who will pay the broker for earlices provided to you, when proment will be made and how the payment will be calculated.
