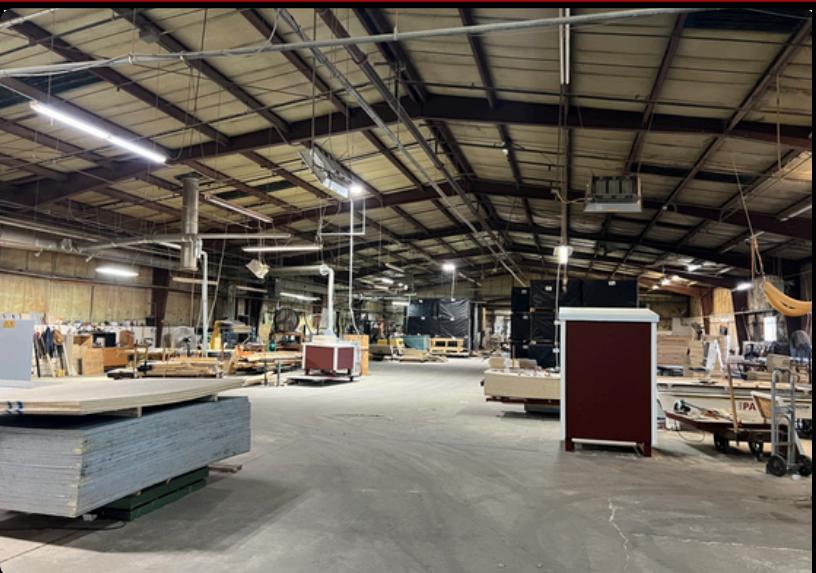

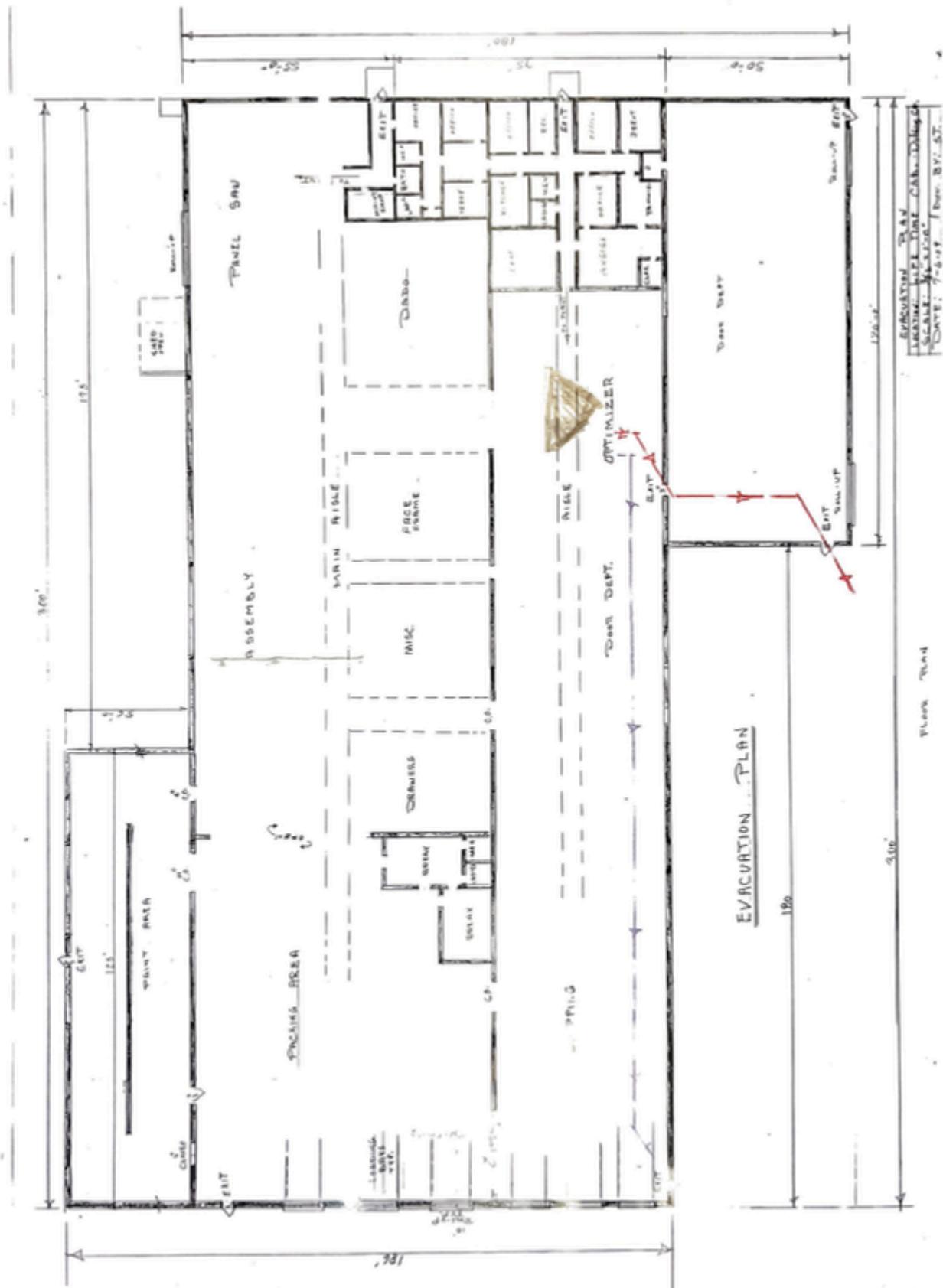

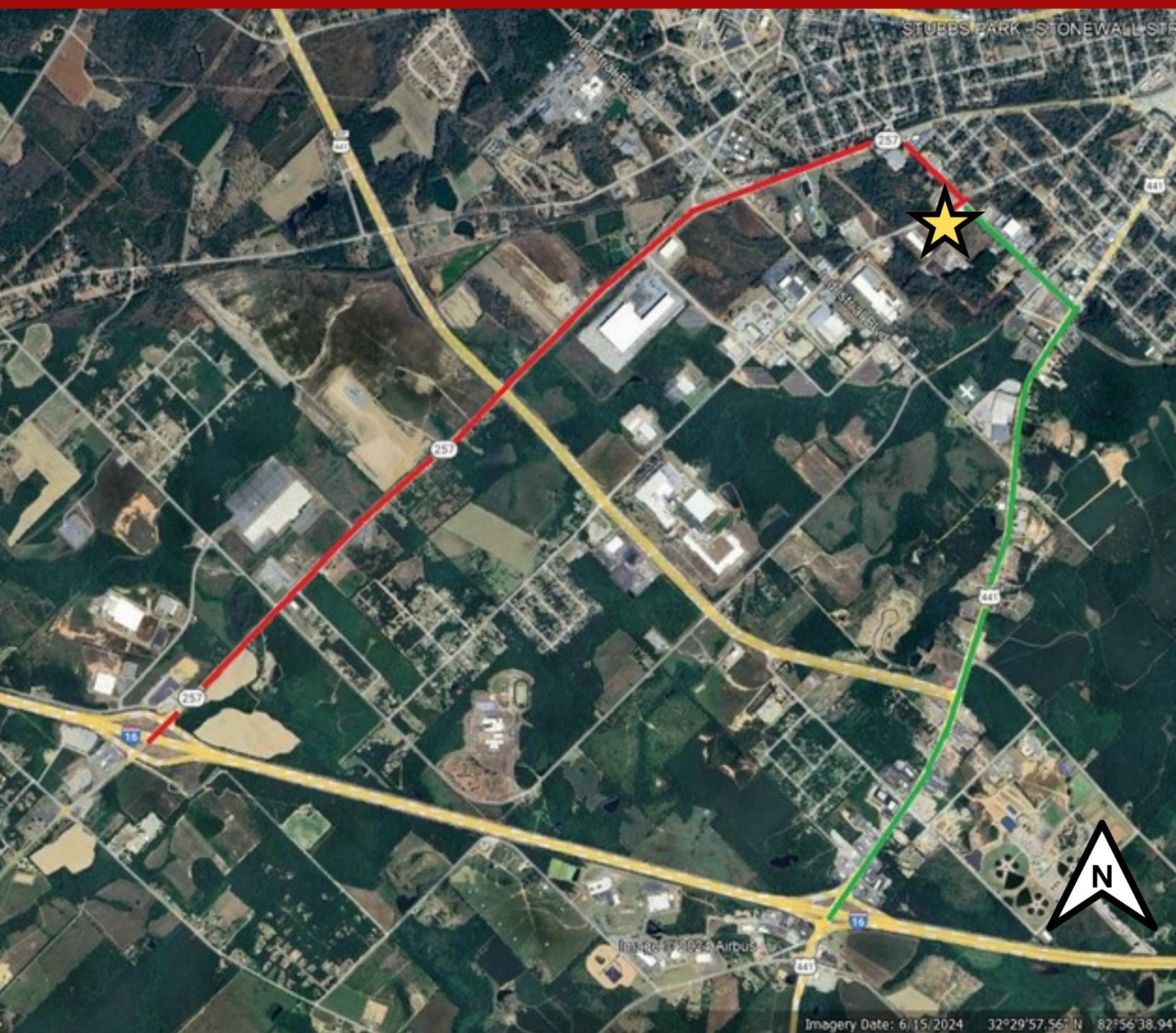

Permitted Uses: Industrial, Office, Call Center, Auto Repair, Equipment Sales/Leasing/Repairs, Warehousing, etc.

City of Dublin - Zoning Code - M-2

Section 5.12. General industrial district, M-2.

The M-2 zone is established to protect and promote a suitable environment for heavy industrial purposes, including accessibility to major transportation facilities, availability of adequate utilities and other public services and availability of large quantities of open land. Uses compatible with light and heavy industrial development are to be encouraged insofar as they are in accordance with comprehensive development plans of the city.

5.12.1. Uses permitted.

- (a) Any use permitted in the M-1 zone.
- (b) All heavy industrial uses which do not cause obnoxious noises, vibrations, smoke, gas, odor, dust, glare, fire hazard or other objectionable environmental conditions.
- (c) Pet boarding kennels (not to include animal breeding facilities), provided that:
 1. All structures shall be located and activities conducted at least one thousand (1,000) feet from any property zoned for residential purposes, unless all animals are housed at all times within a sound-proof building.
 2. Animals are not allowed in outdoor areas between the hours of 9:00 p.m. and 7:00 a.m.
 3. All outdoor exercise areas are surrounded by solid, opaque fencing a minimum of eight (8) feet high.

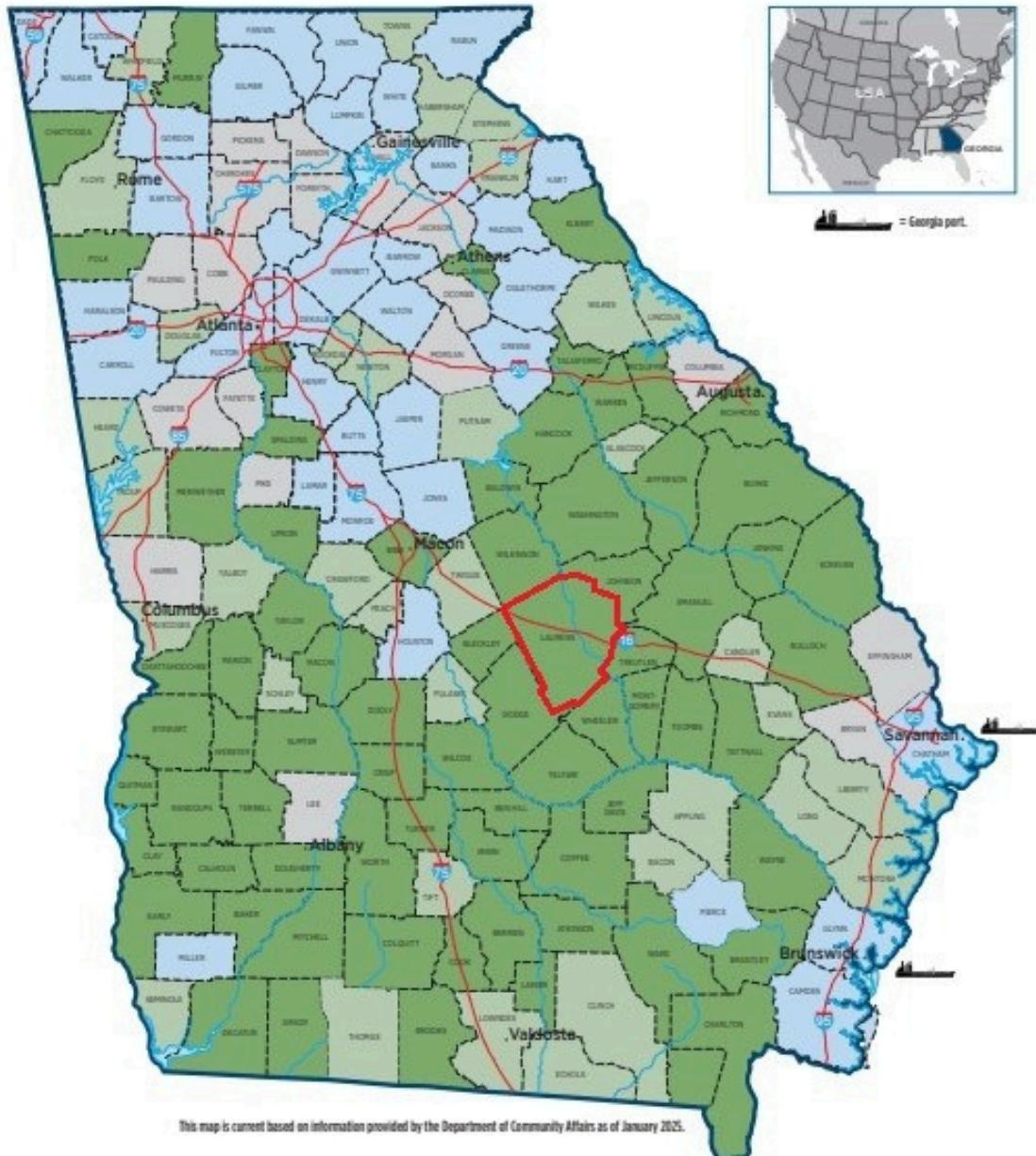
5.12.2. Uses not permitted. Junk yards will not be permitted within the city limits of the City of Dublin.

Any licensee holding a valid junk dealer license or a valid license to dismantle cars for the purpose of selling second-hand parts at retail as of December 31, 1988, shall be allowed to renew said license at the same location. Transfer of ownership and/or location will not be permitted.

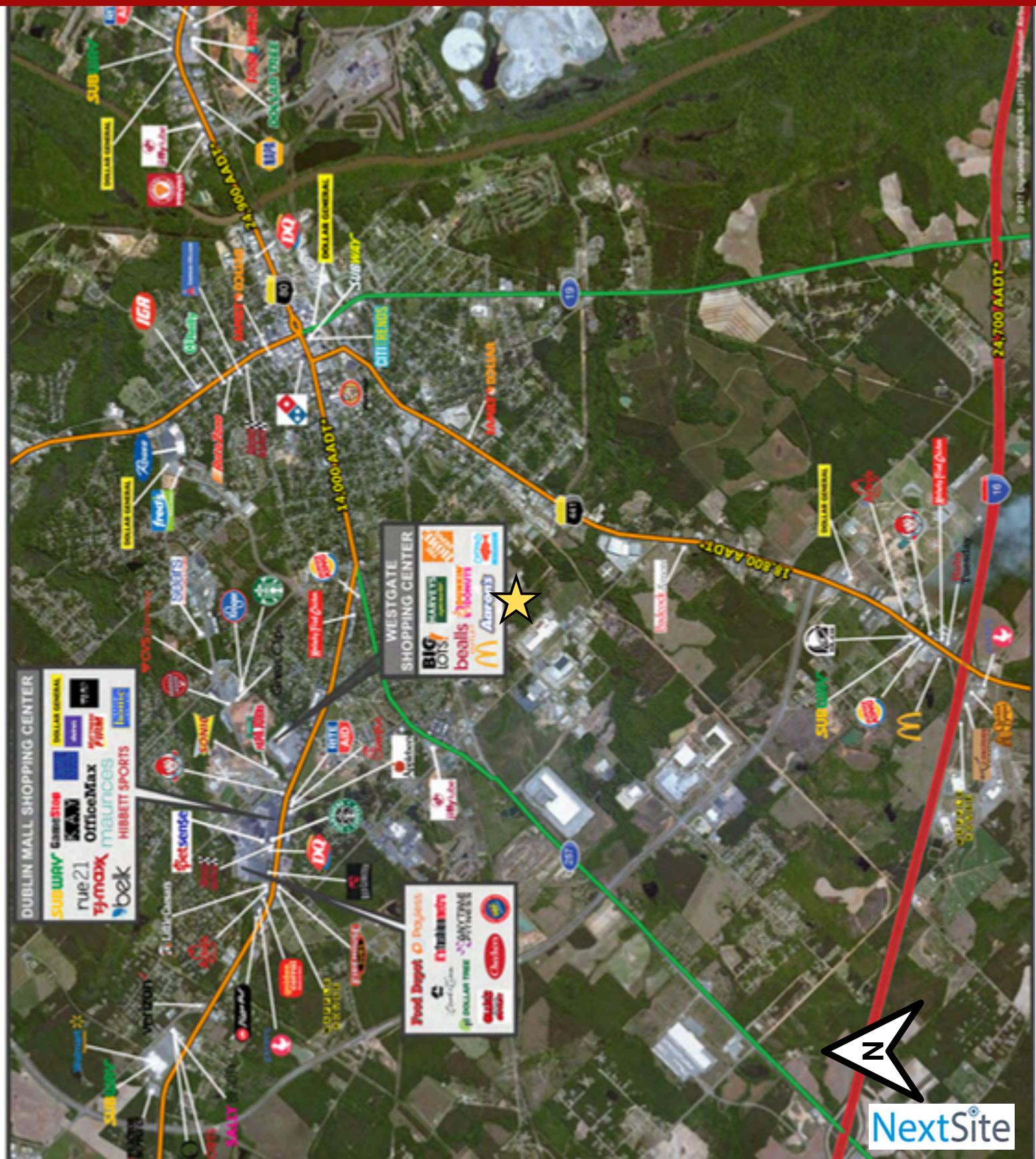
