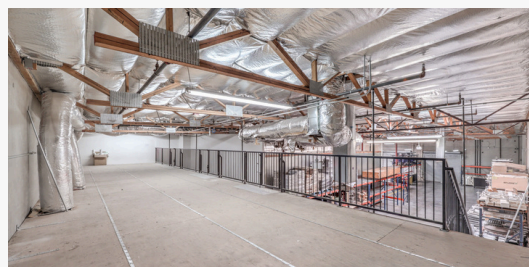

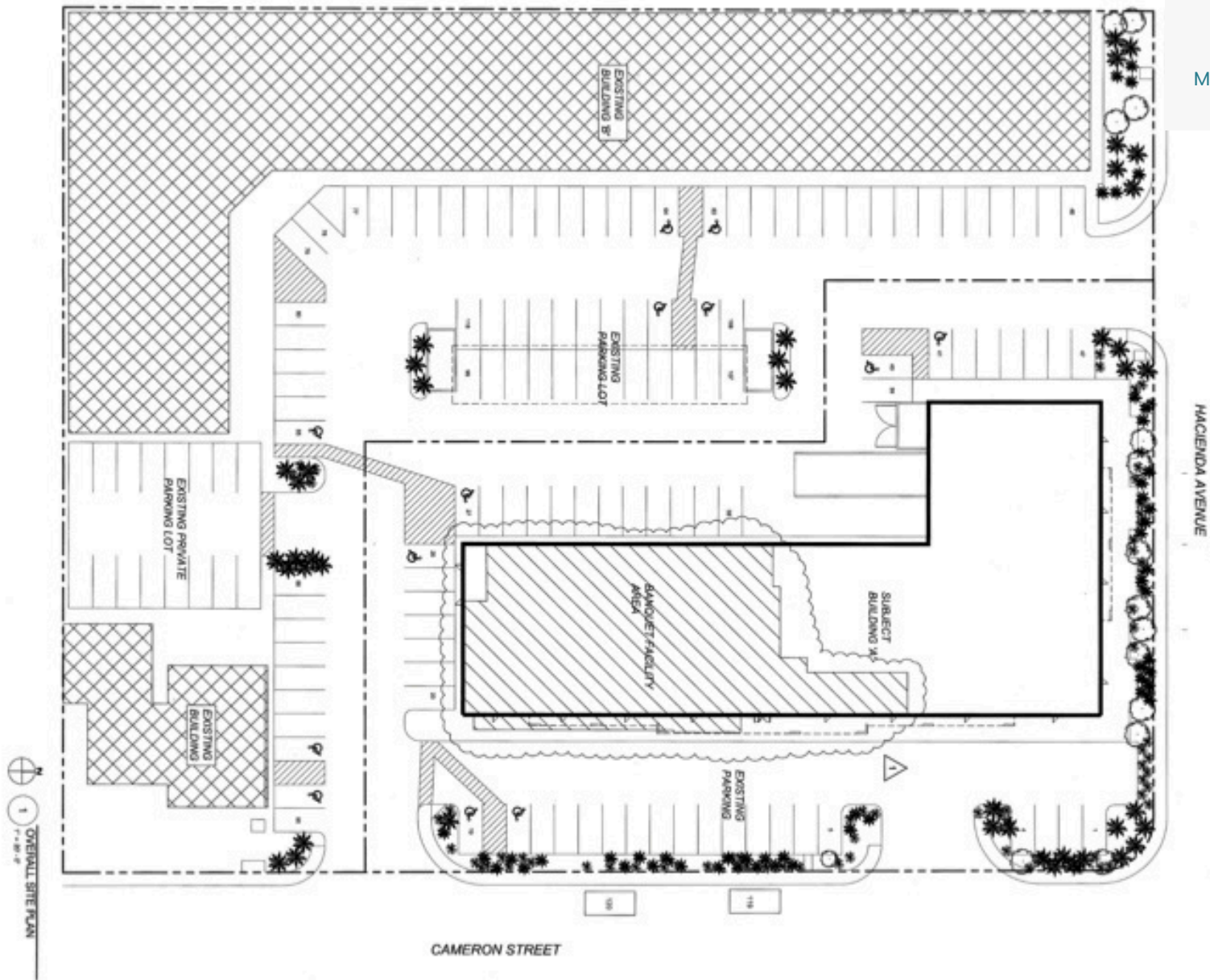




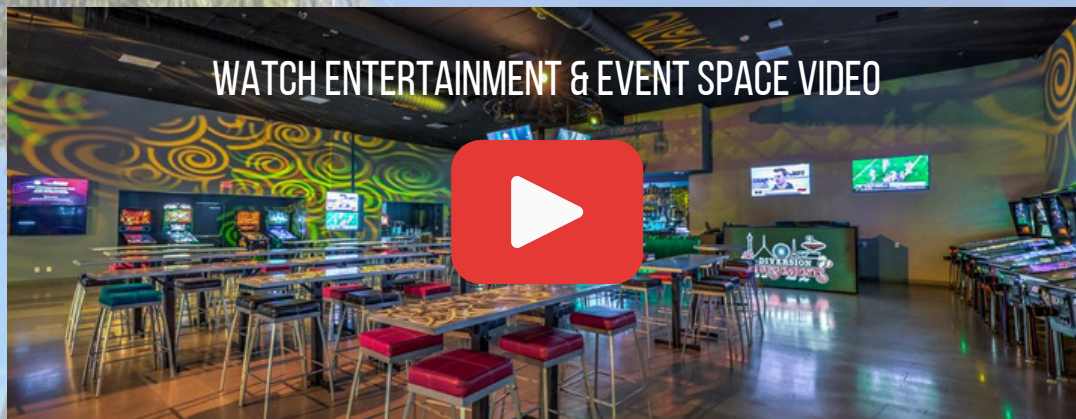
# PLOT PLAN
