
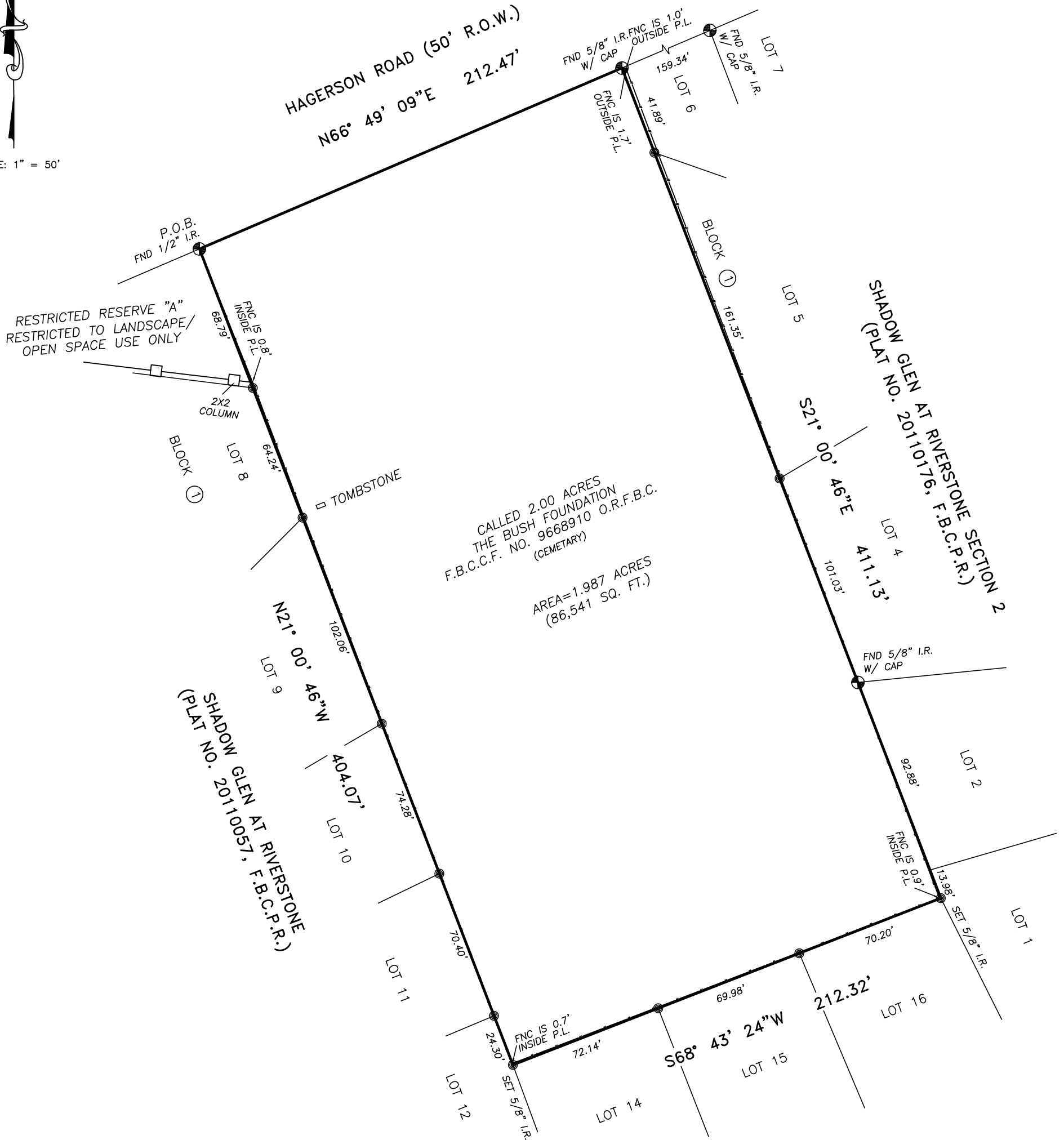


LEGEND:

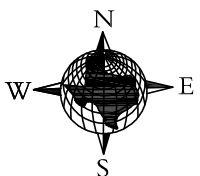

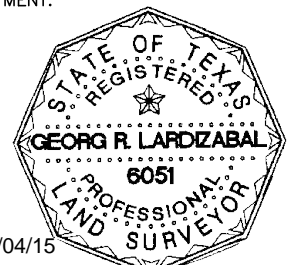
