Named Fair Oaks Dental Village, the building was originally built by the Seller and has never been on the market for sale. Built with dental/medical uses in mind, the Property consists of 8 dental/medical suites, is equipped with an elevator, centralized compressor and vacuum systems, along with a built-in Panoramic X-ray machine.

Geographically located along Fair Oaks Blvd near Sunrise Blvd, the Property offers convenient access to Fair Oaks, Gold River, Orangevale, and Carmichael. With strong demographics in Fair Oaks, medical tenants can benefit from a higher percentage of private pay patients.

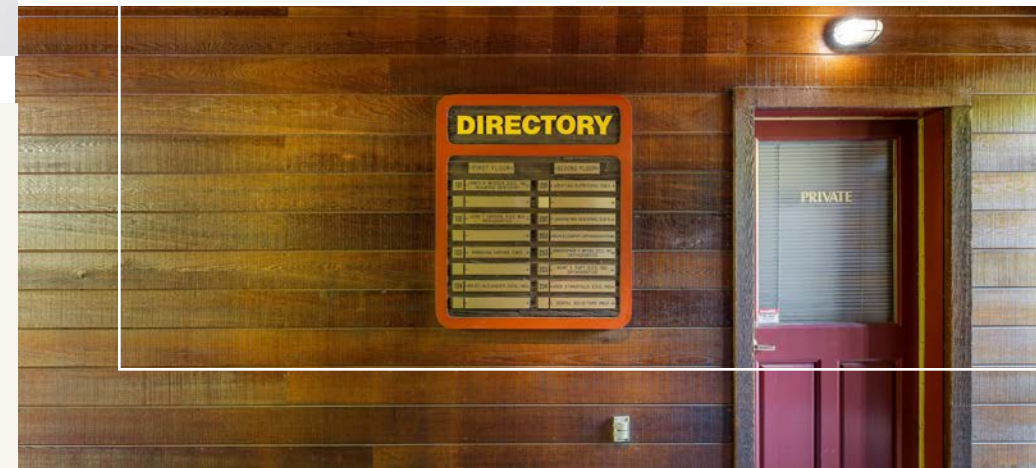
