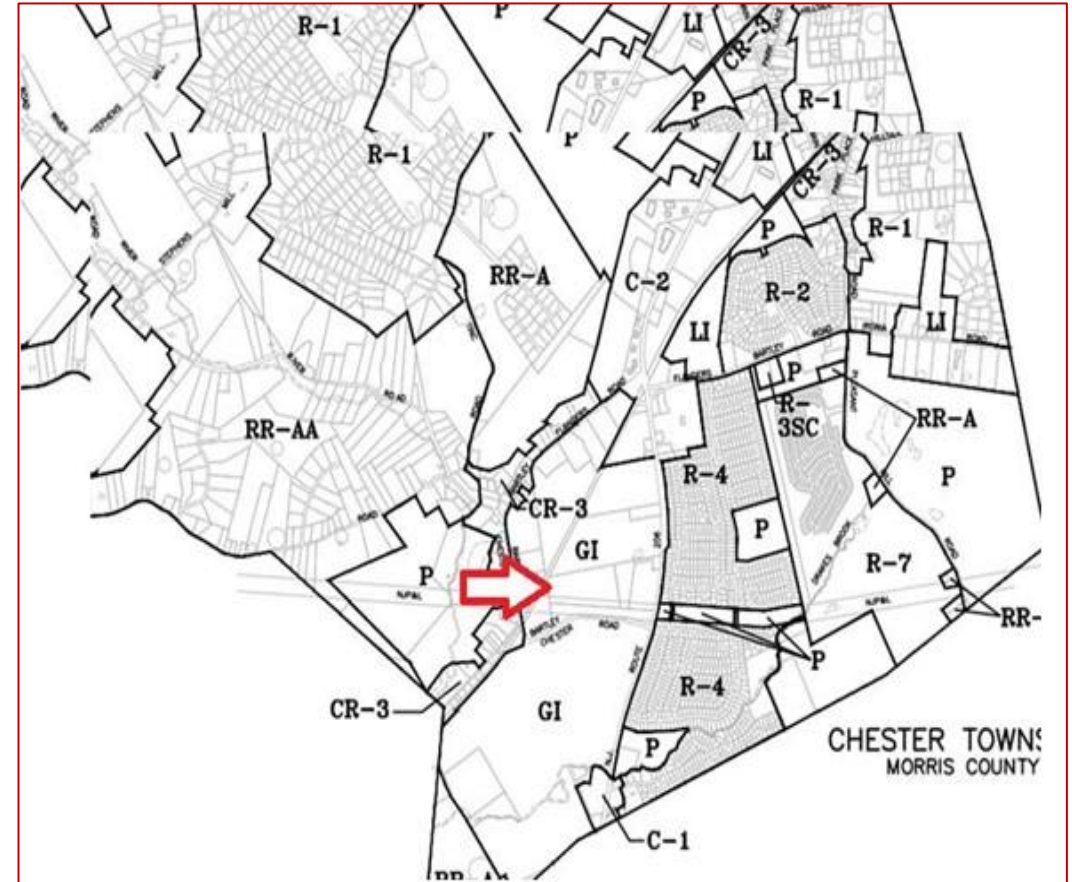

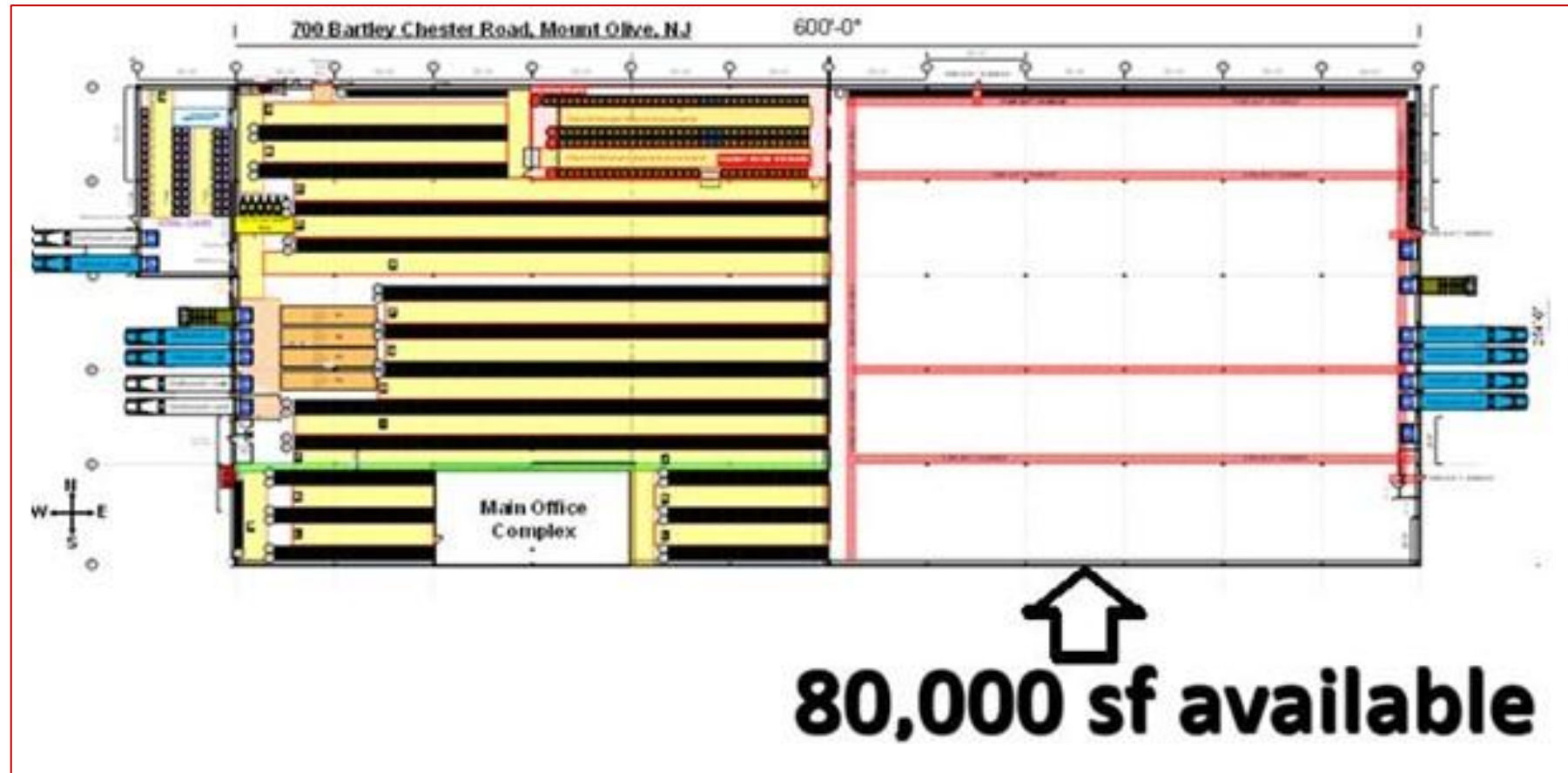

BLDG PLAN



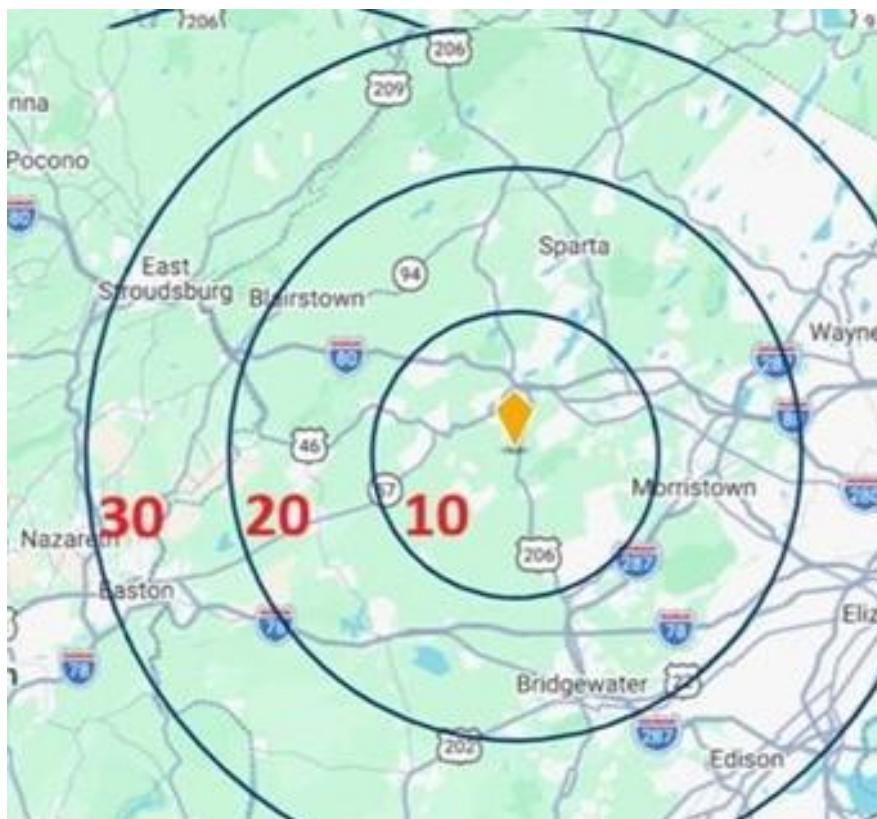
