

AM General (AMG) focuses on military-grade tactical vehicles like the Humvee, while managing potential supply chain and production challenges for its primary U.S. Army contracts. In 2023 AMG secured a 10-year contract worth over \$8 billion to produce the Joint Light Tactical Vehicles (JLTV), indicating significant revenue potential, by late 2025. The company has been privately owned by KPS Capital Partners since 2020. Although AMG does not publicly share their financial info, the KPS portfolio companies generate approximately \$21.2 billion in aggregate annual revenue.








Education Level – Elkhart & Surrounding Counties



