## PROPERTY OVERVIEW

Hood system and three compartment sink in place.

## LOCATION OVERVIEW

Paxton Plaza is situated on Highway 278 between Burnt Church Road and Malphrus Road, adjacent to Verizon, in Bluffton's main retail corridor. Easy access to the Bluffton Parkway via Malphrus Road. The property sits between the two Tanger Outlet Malls, adjacent to Lowes, Michael's, Ross, Big Lots, PetSmart, World Market, and surrounded by a plethora of other national retailers and residential developments. This is a dynamic growth area with over 50,000 vpd on Hwy 278, strong demographics including a population of approximately 37,000 people within a five mile radius with average household incomes exceeding \$131,000.



