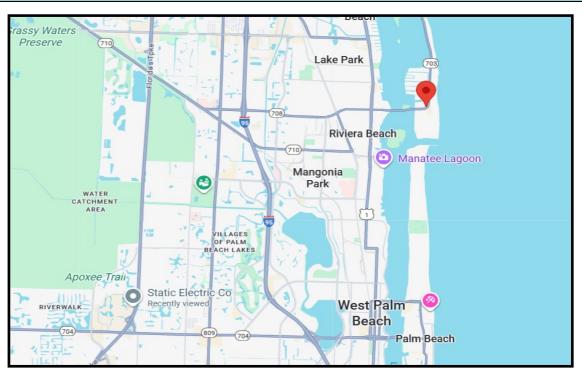

Strategic Location

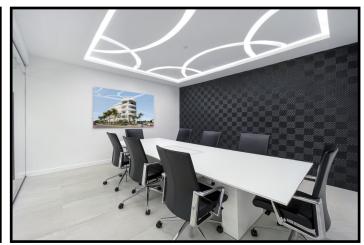
