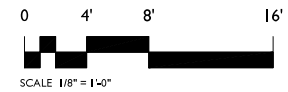
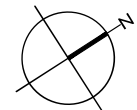




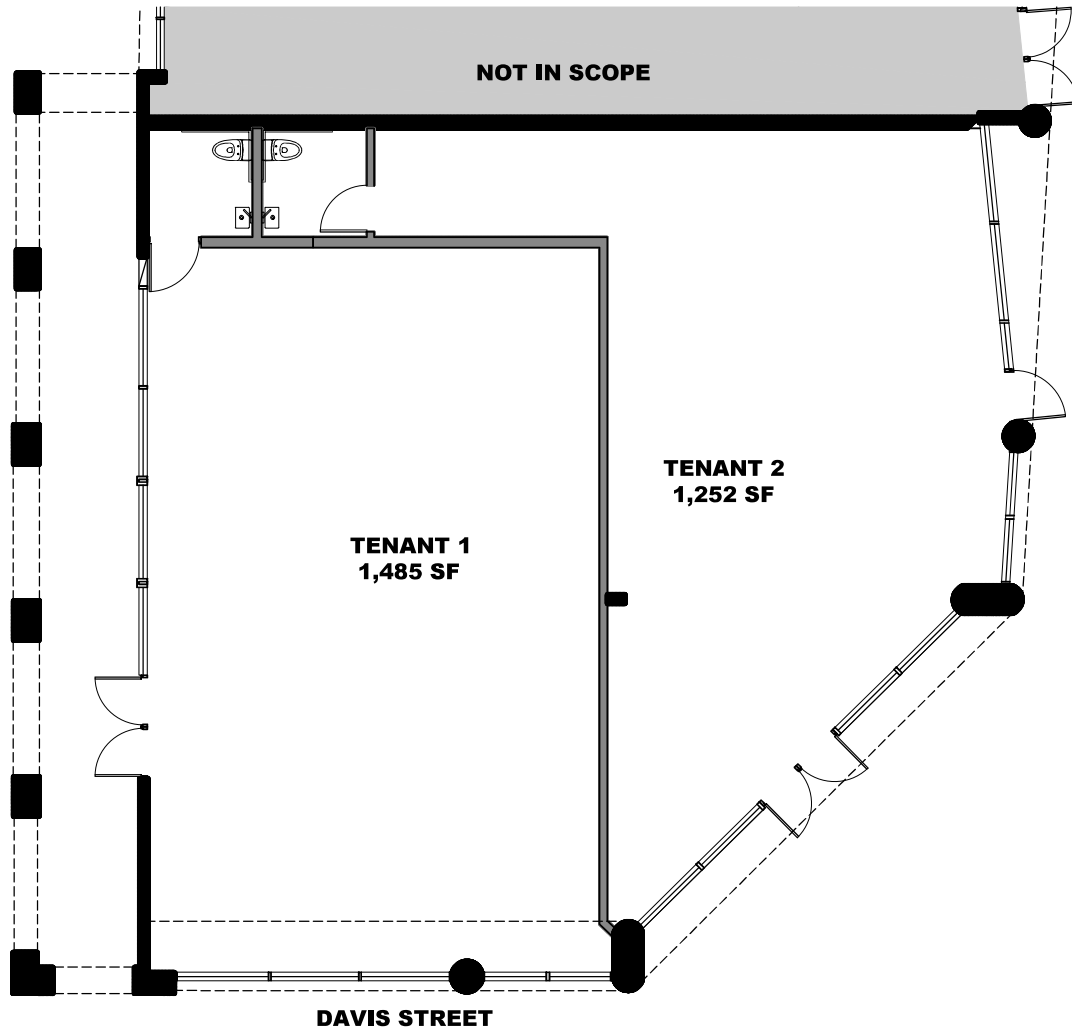
EXISTING AND DEMOLITION PLAN

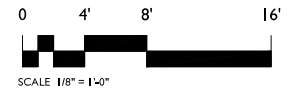
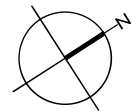
