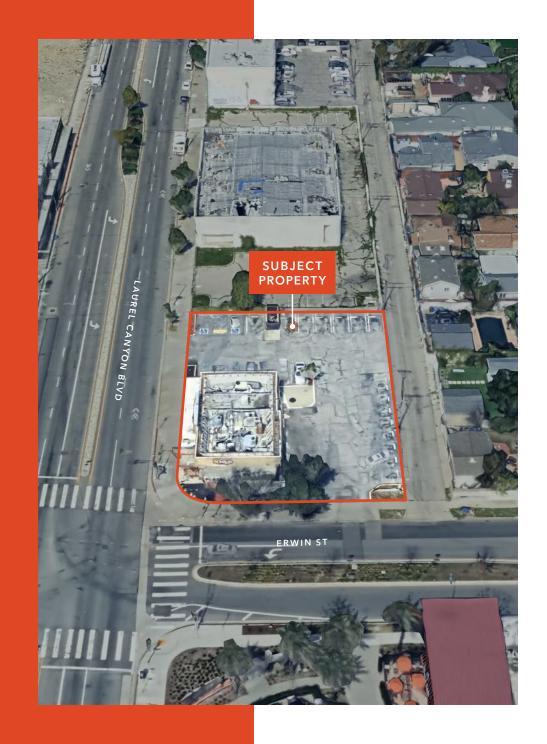

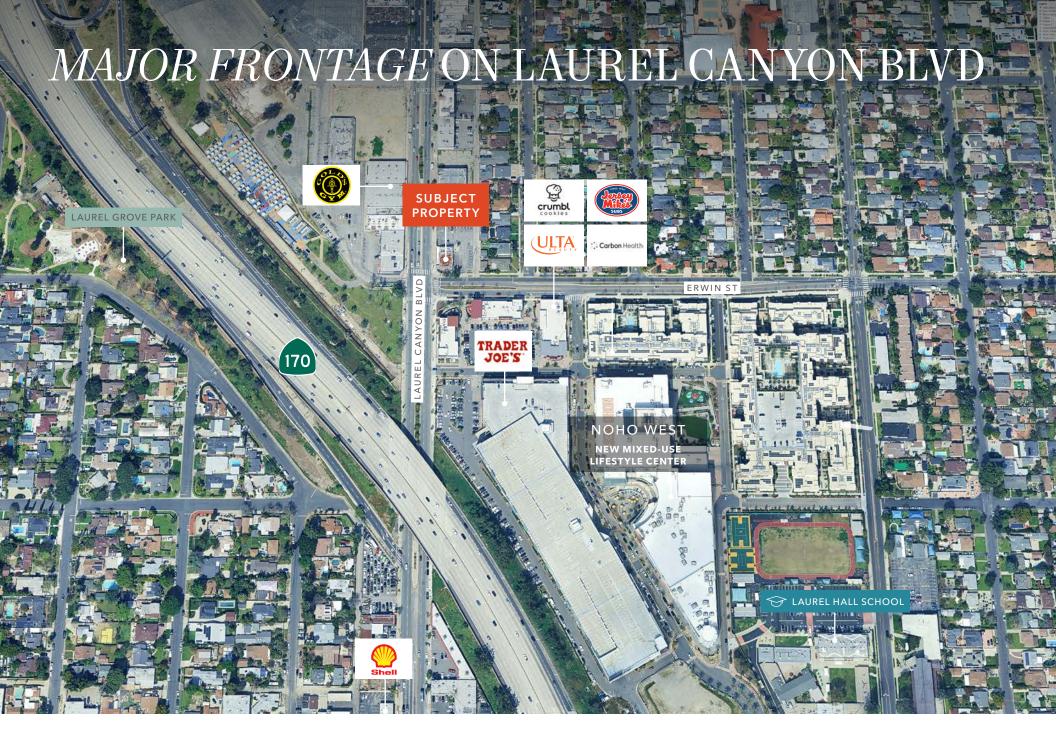

## NEARBY AMENITIES -NOHO WEST

NoHo West is a modern, large-scale mixeduse destination in North Hollywood that blends shopping, dining, entertainment, office, and residential uses into a single pedestrian-oriented campus.

Anchored by major retailers such as Nordstrom Rack, Trader Joe's, & Ulta Beauty, the development offers a vibrant "main street" experience with open-air plazas, landscaped walkways, & community gathering spaces. The 25-acre project transforms the former Laurel Plaza site into a thriving lifestyle hub that features a state-of-the-art Regal Cinemas, fitness studios, and a diverse mix of restaurants and neighborhood services. In addition to ±190,000 SF of retail & dining options, NoHo West includes ±500,000 SF of creative office space & 644 modern residential units, bringing an active 24/7 energy to the heart of the San Fernando Valley. Its thoughtful design & convenient location near major freeways & the NoHo Arts District position it as one of Los Angeles' most dynamic live-work-play communities.

The construction of NoHo West concluded in 2023 and marks the transformation of the long-vacant Laurel Plaza site into a modern mixeduse destination. Key tenants such as Trader Joe's and Regal Cinemas debuted early on, followed by Nordstrom Rack's grand opening in spring 2023. The residential portion, consisting of 644 contemporary units, reached completion in mid-2023, bringing full-time residents to the property and activating the surrounding community.
