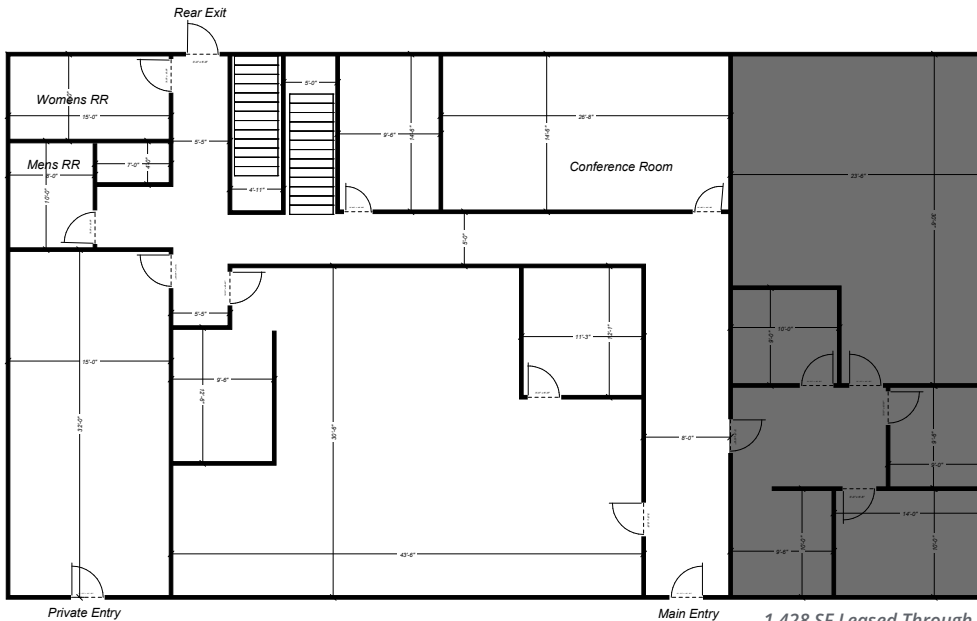

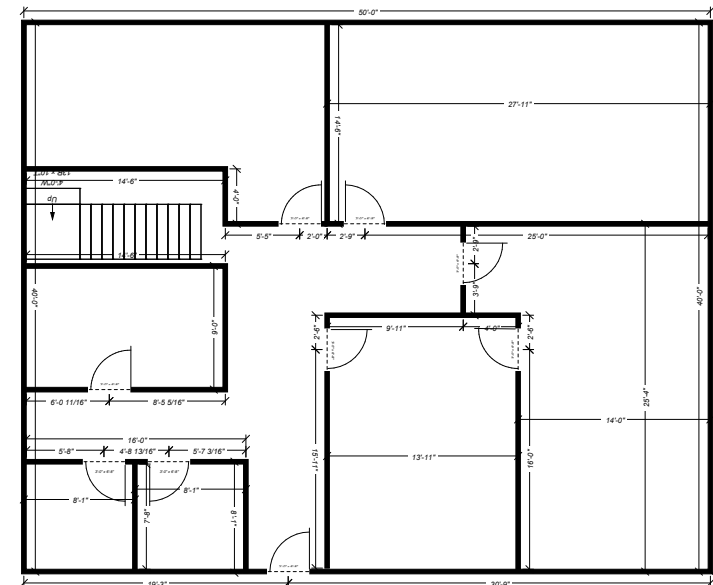


FIRST FLOOR | 4,500 SF

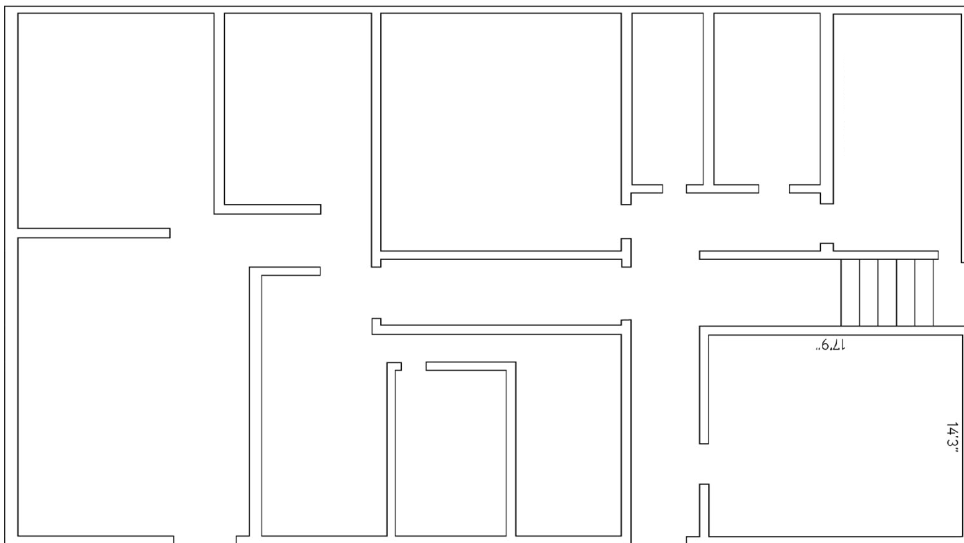

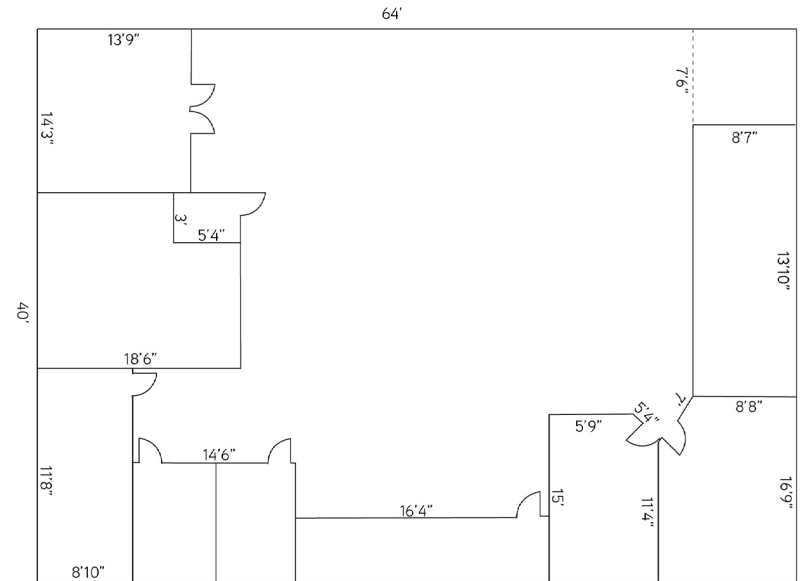

FIRST FLOOR | 2,946 SF

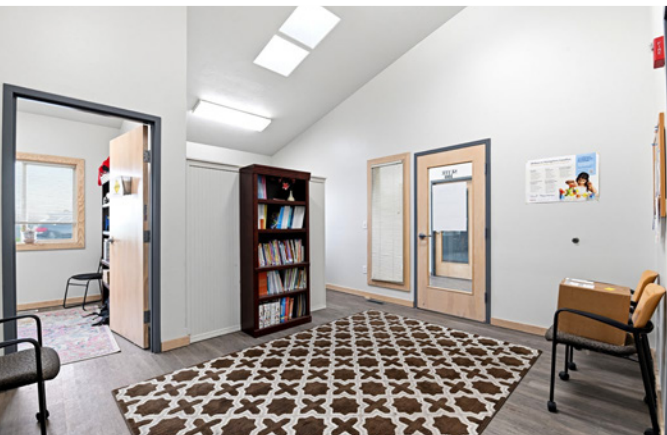


SECOND FLOOR | 2,080 SF

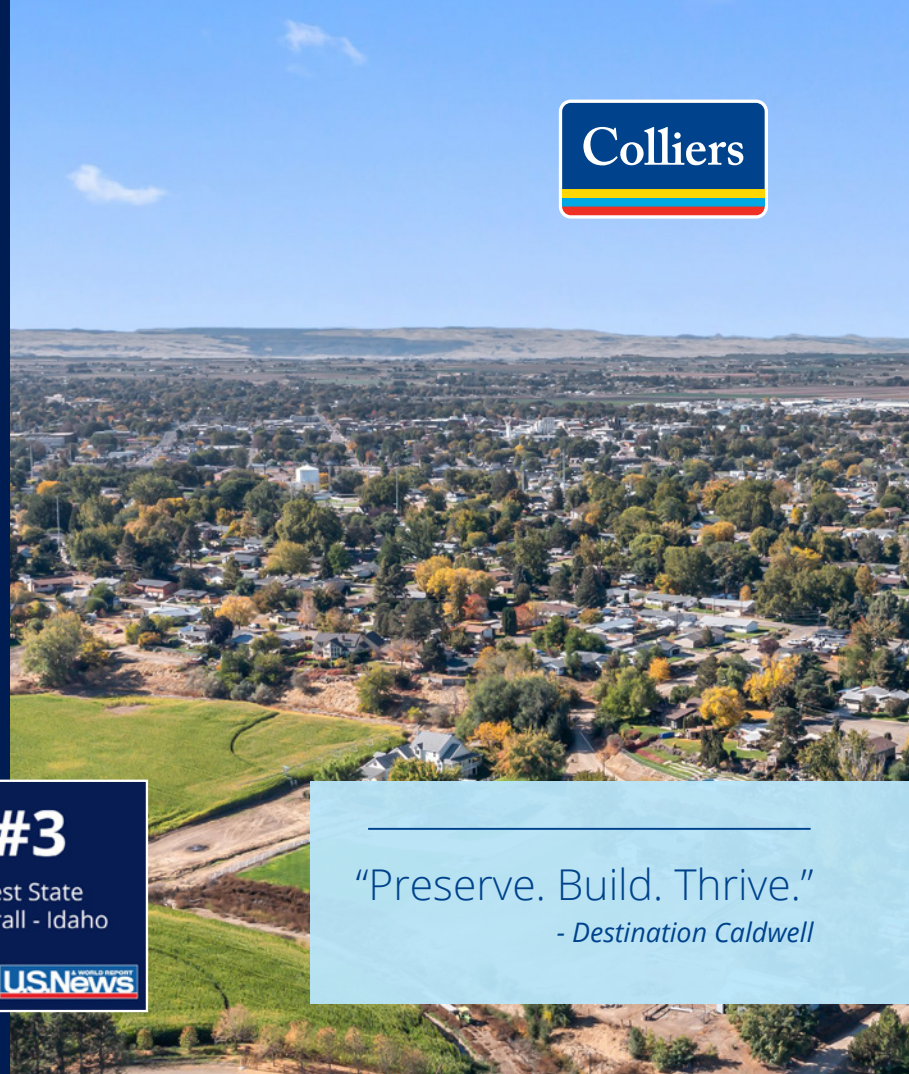

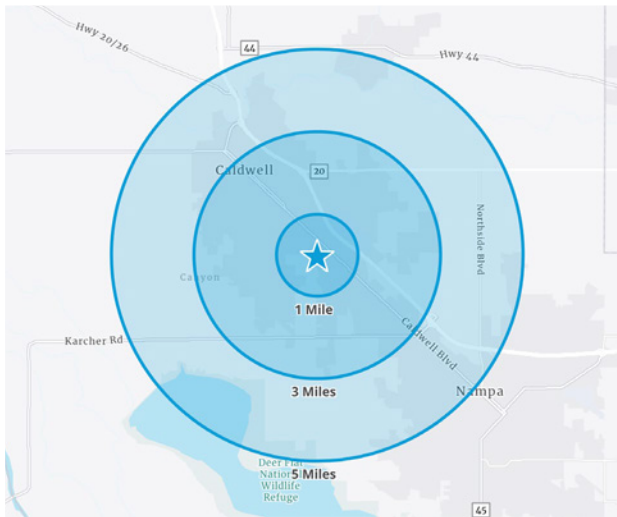

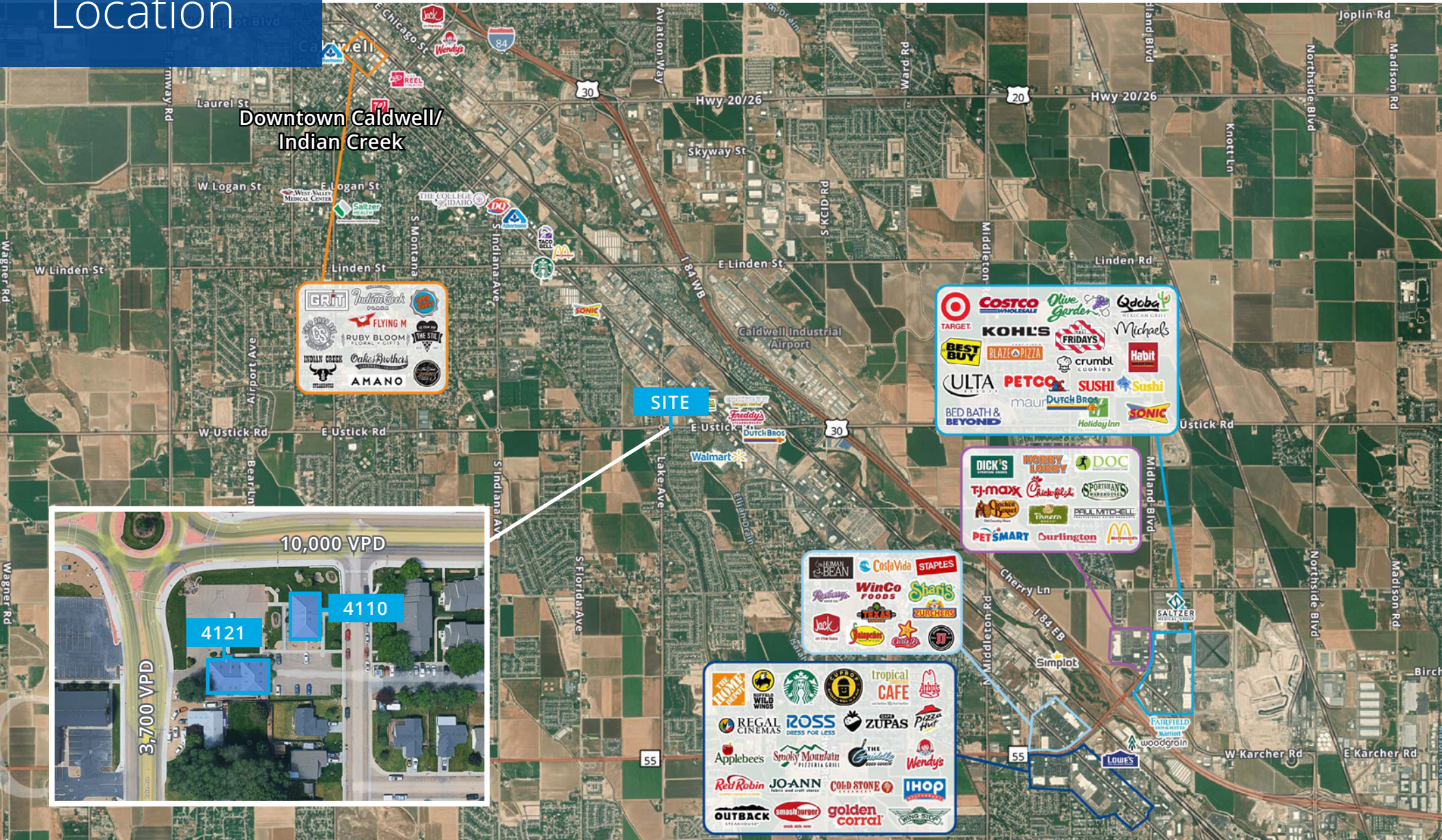
