Building #1 - 1,500sf standalone building (30' x 50') with an open work area, 3 offices, conference room, and restrooms.

Building #2 - 2,376sf suite (33' X 72' / 30' X 72' clear span) with (2) 16' overhead doors, floor drains, and 32'-34' ceilings.

Building #3 - 7,500sf (125' x 60') divisible to 1,500sf-7,500sf suites (25' x 60') with 8' overhead doors and 9'-13' ceilings.

Building #4 - 2,660sf (38' x 70') with 456sf of flex space, (2) 15' and 12' OH doors, floor drains, and 18'-20' ceilings.

PROPERTY DESCRIPTION

4 buildings totaling 14,036sf with 1,500sf-10,160sf suite sizes. The new owner is currently getting the site cleaned up and there will be parking/storage and easy access to the suites. The owner uses the large building and most of the outdoor storage leaving the rest of the buildings available for lease.

Building #1 is 1,500sf of office space (30' x 50') with an open work area, 3 offices, conference room, and 2 restrooms. Vehicle/Equipment storage can also be available. Furniture can be included. There is heat/ac.

Building #2 is a 2,376sf suite (33' X 72' / 30' X 72' clear span) with (2) 16' OH doors for easy in/out access, 32'-34' ceilings, floor drains, and 3 phase power. There is no heat/ac specific to this suite, but the rest of the connected building is heated so this space stays semi-heated as-is. A barrier/fence can be installed to keep the suites separated and a modine heater could be added.

Building #3 is 7,500sf (125' x 60') and can be split to up to (5) 1,500sf suites (25' x 60') with 8' overhead doors. Currently half of the building is office and it can stay that way or be split. Ceiling heights are 9'-13'. Modine heater. The suite can be combined with Building #4 for an extra 2,660sf totaling 10,160sf.

Building #4 is 2,660sf (38' x 70') with 1,820sf industrial space and 840sf of flex/office space plus a 456sf mezzanine (38' x 12') for extra storage space. There are (2) 15' and 12' overhead doors, floor drains. ceiling heights of 18-20', a modine heater, and a wall AC unit in the flex/office space. The suite can be combined with Building #3 for an extra 7,500sf totaling 10,160sf.






