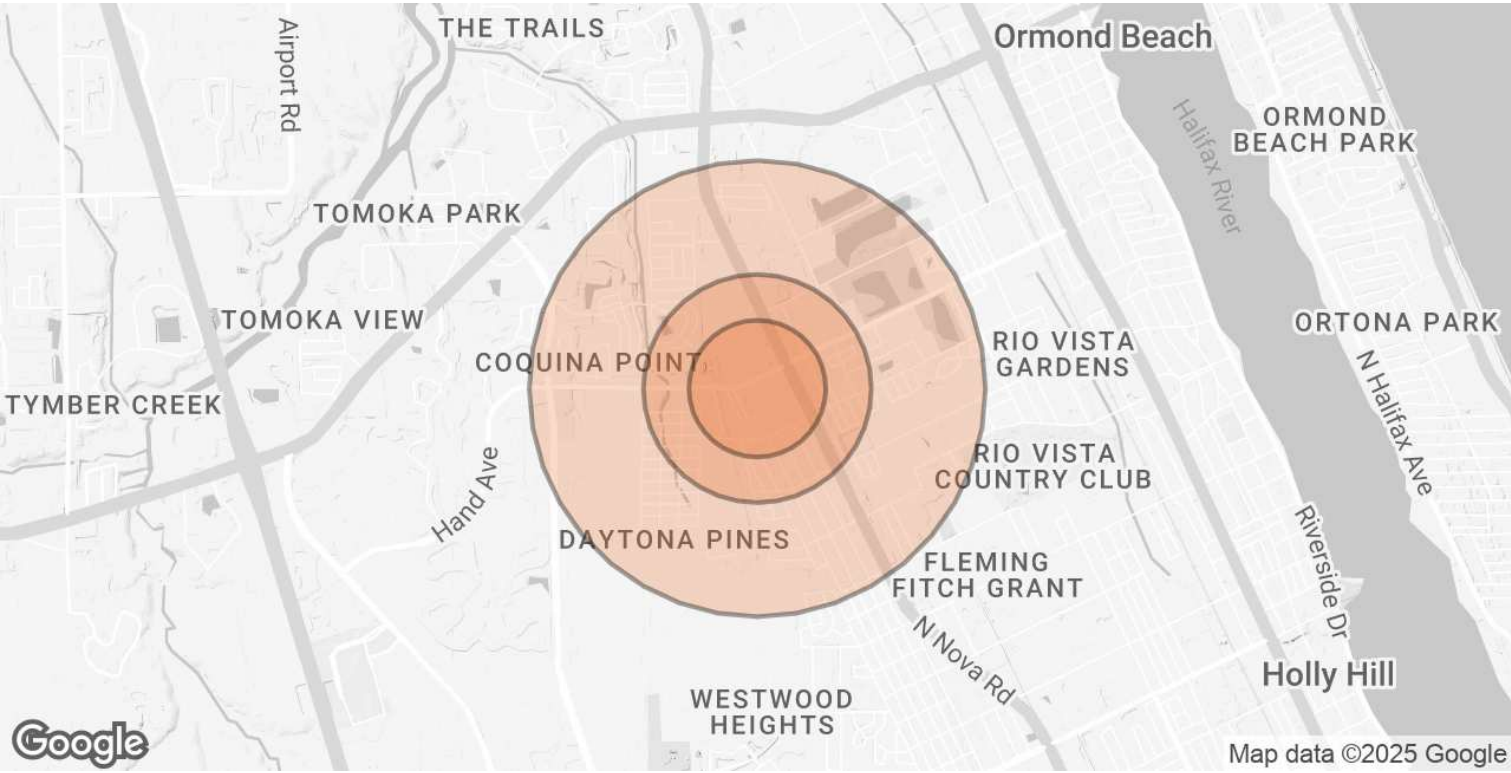
LOCATION MAP
