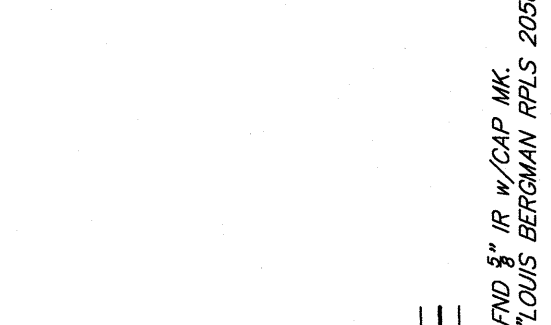


VICINITY MAP

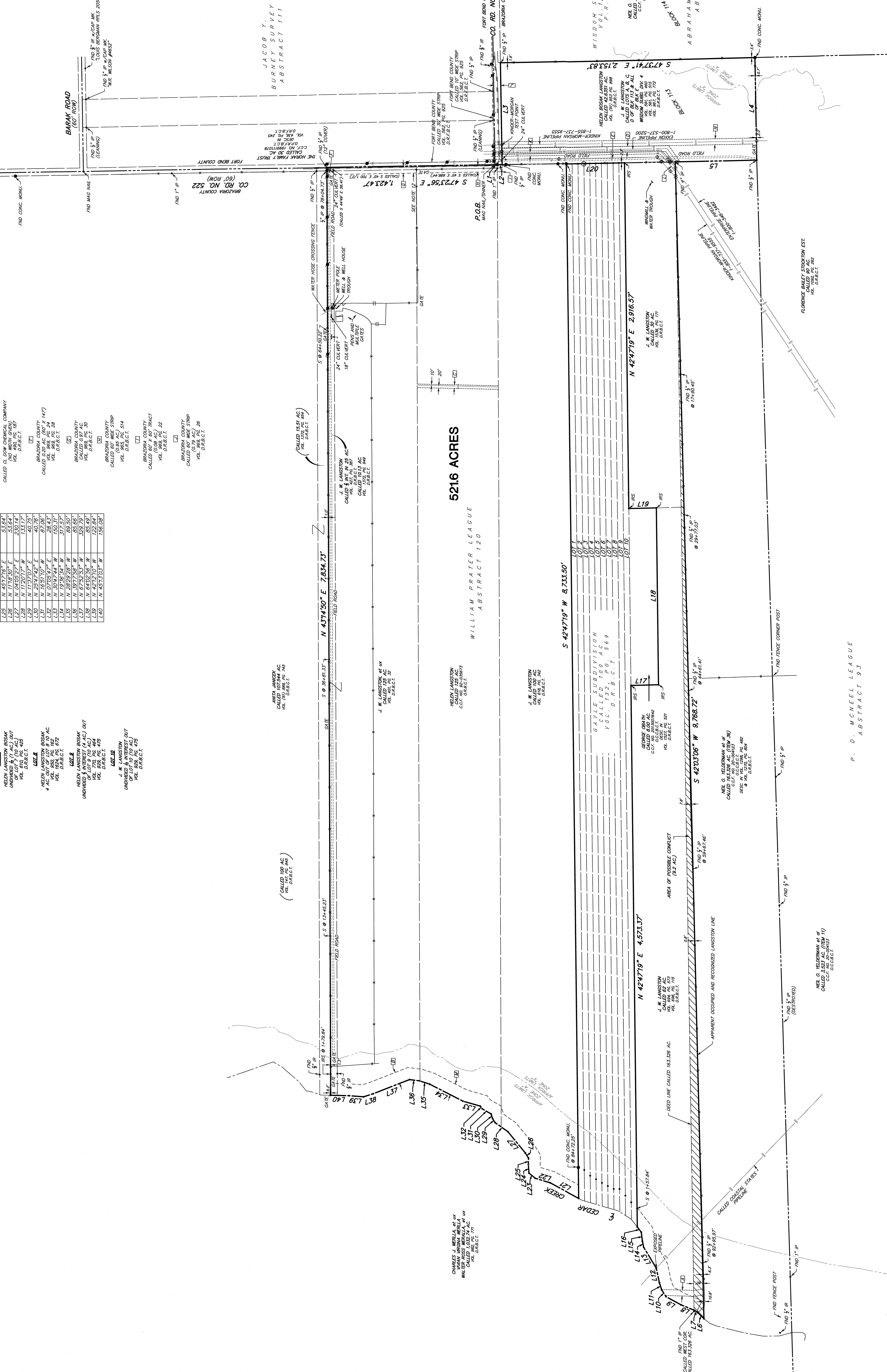
