
## Investment Highlights


The property is a single-tenant office property currently owner-occupied by the Lake Minnetonka Communications Commission. The building was constructed in 1920 and renovated in 1999; it has one level above grade with a partial second level and a partial basement that is excluded from the gross building area. The gross building area is estimated at about 5,737 square feet. The building was renovated to office use in 1999 by the current owner. Building features include wood structural framing, metal siding with some wood panels, a rubber membrane roof that includes a flat section and a Quonset section, poured concrete floors on the first floor, wood subfloors on the second level, a clear span height of about 11.5 feet in the garage, and two HVAC units (one located on the second floor and the other mounted on the flat roof section).

The building appears to have been adequately maintained over the years and in average overall condition relative to age. The effective age of the subject property is estimated to be about 25 years with a remaining economic life of about 25 years, with no major items of deferred maintenance known.


The building location, across the street from the shore of the West Arm of Lake Minnetonka, is ideal for an owner/user. The site is on the corner of Sunset Drive and Northern Avenue, across from Rockvam Boat Yards, and directly off the Dakota Regional Trail. It offers amazing views of the lake, a drive-in garage, and potential for conversion of the upstairs to an apartment or additional storage. The site is a short distance from the Mound downtown area, with grocery stores, coffee shops, the Post Office, and other amenities.




## Floor Plan













## Hennepin County Aerial Map
