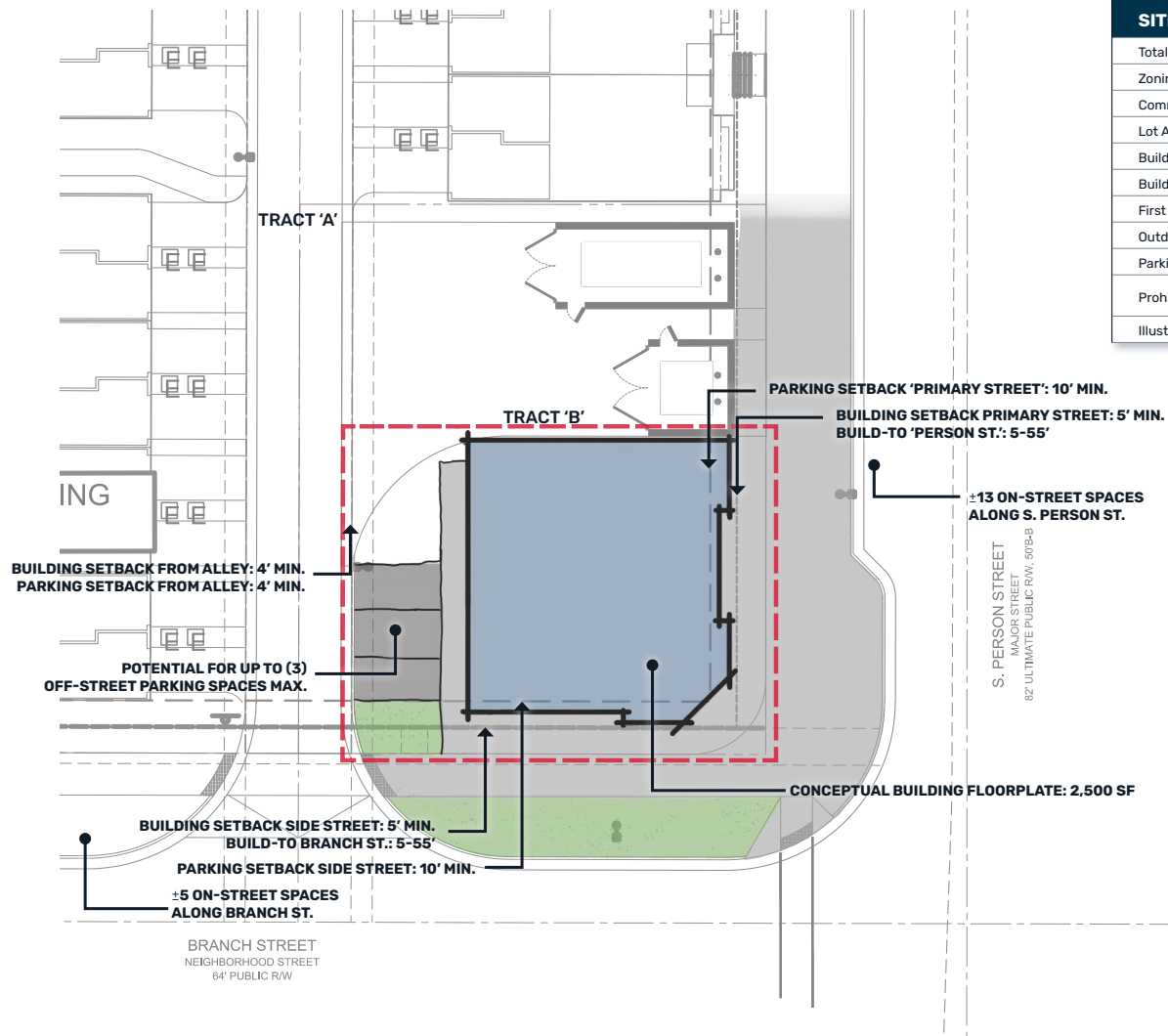
Property Highlights

CBRE is pleased to present a rare ±0.21-acre commercial development opportunity in Downtown Raleigh. Located just 0.5 miles from Martin Luther King Jr. Boulevard (21,500 VPD) and S. Wilmington Street (10,000 VPD) signalized intersection, the site is located within The Grey, a nearly sold-out, 100-unit condo community built by Stanley Martin Homes. The subject property is zoned Planned Development (PD) (City of Raleigh ETJ), which permits health clubs, medical, office, restaurants, retail sales, beauty/hair salon, etc. A current concept layout shows the potential for a 2,500-square-foot general or mixed-use building.

Commercial Concept Layout

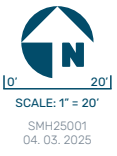

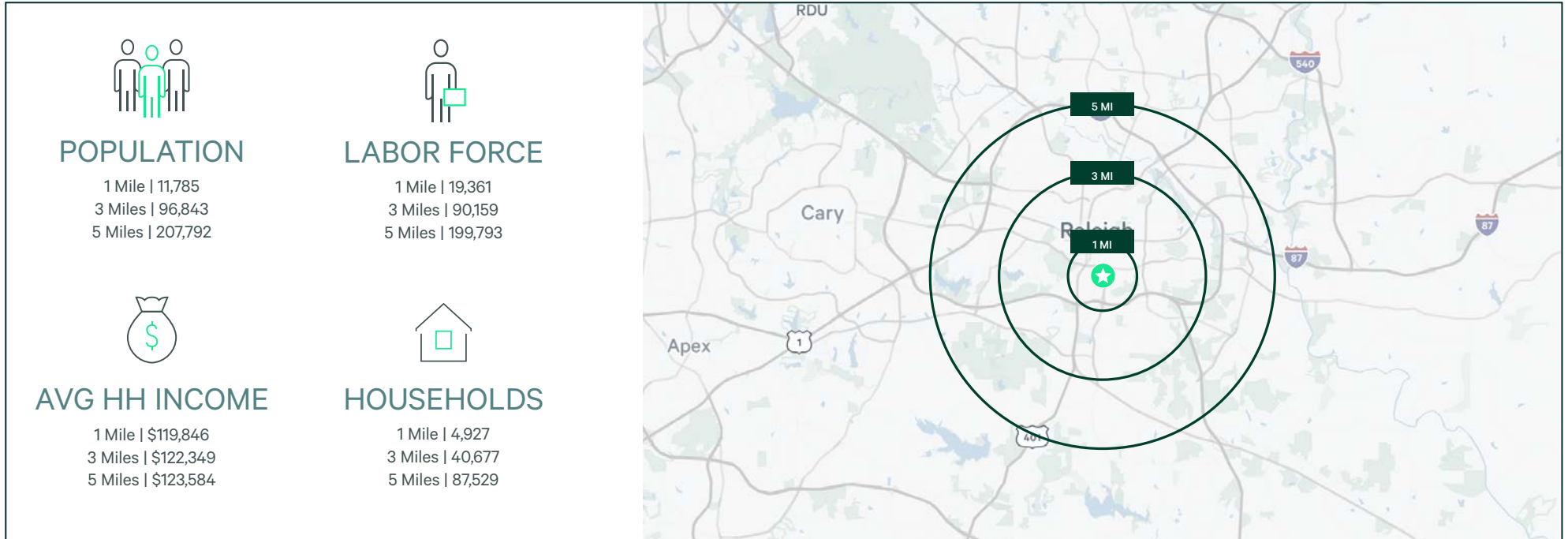
