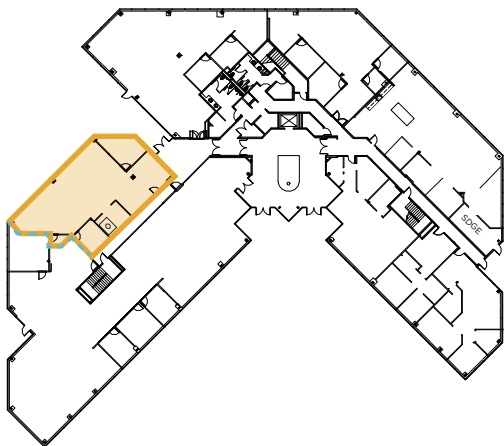
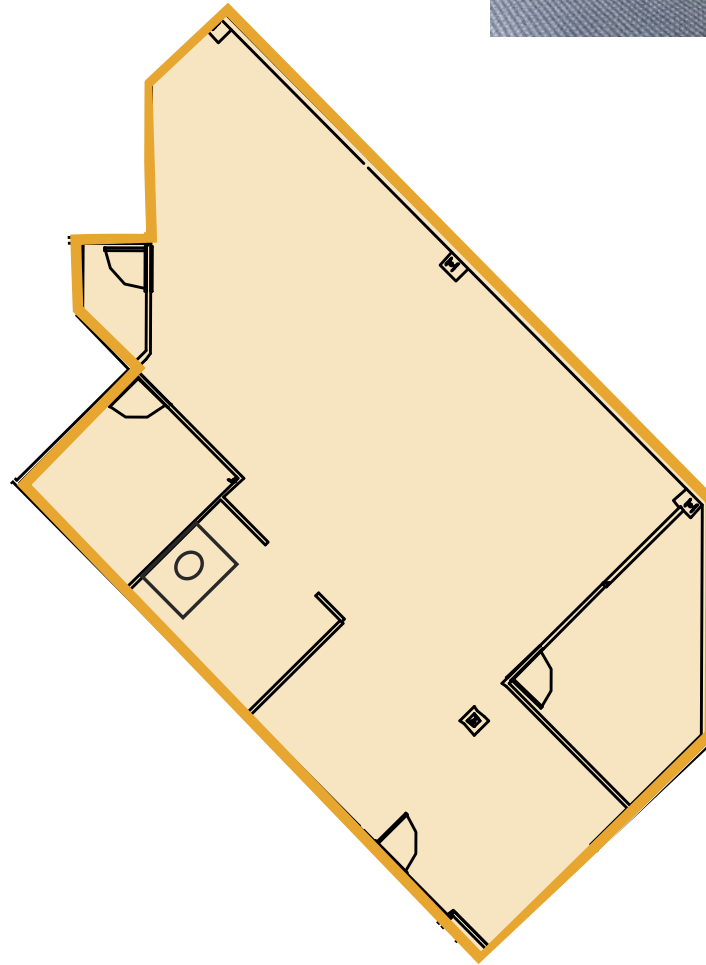


FLOOR PLANS

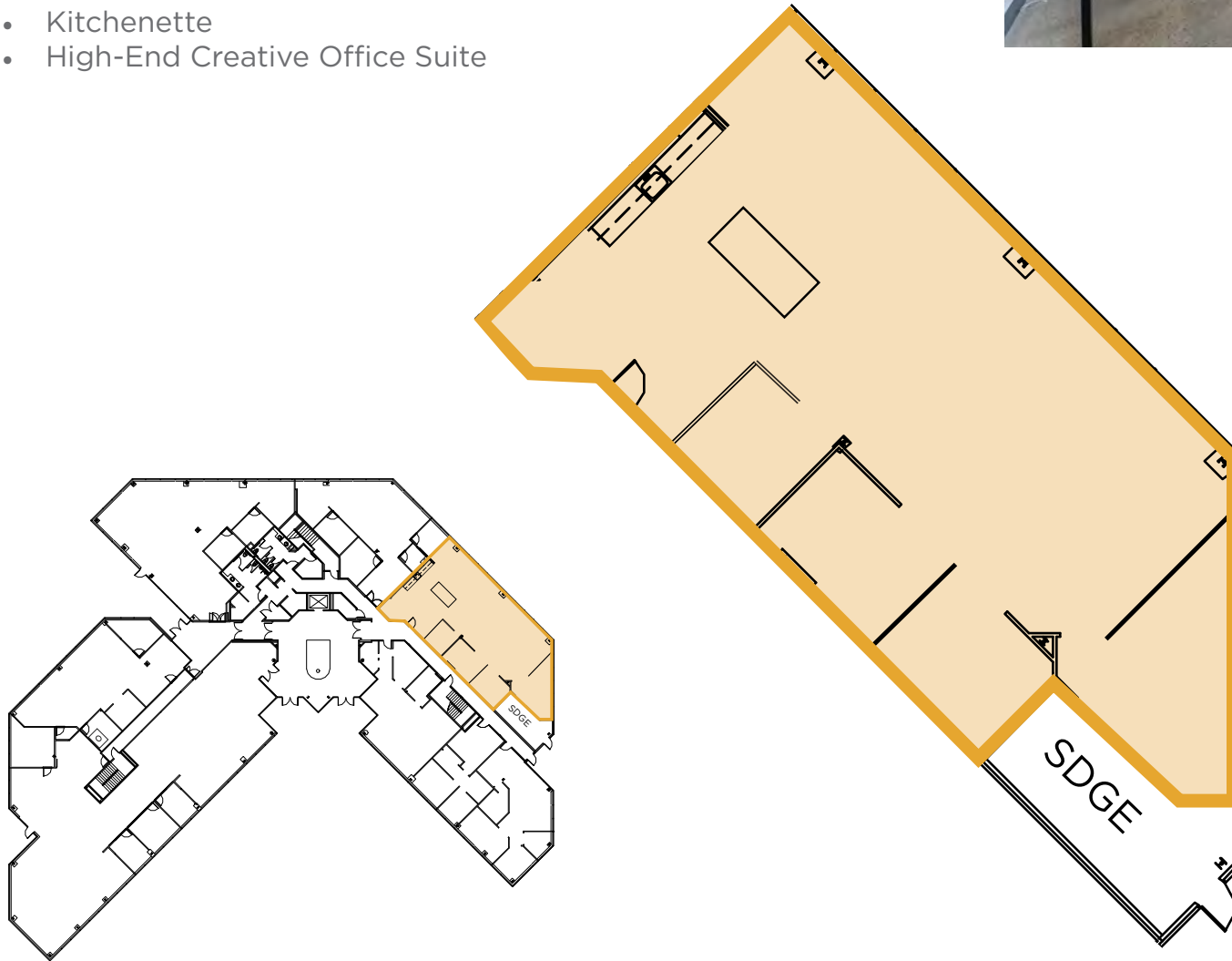

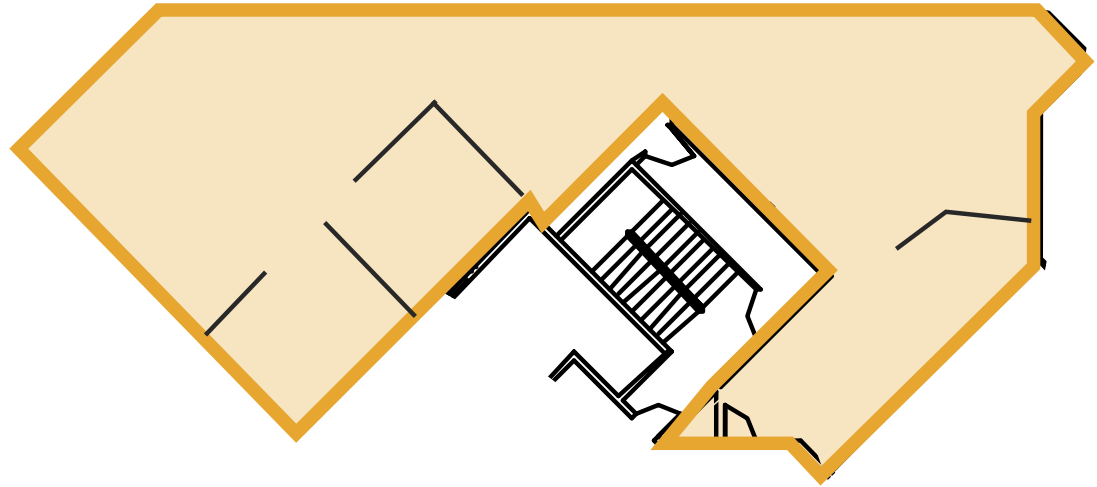

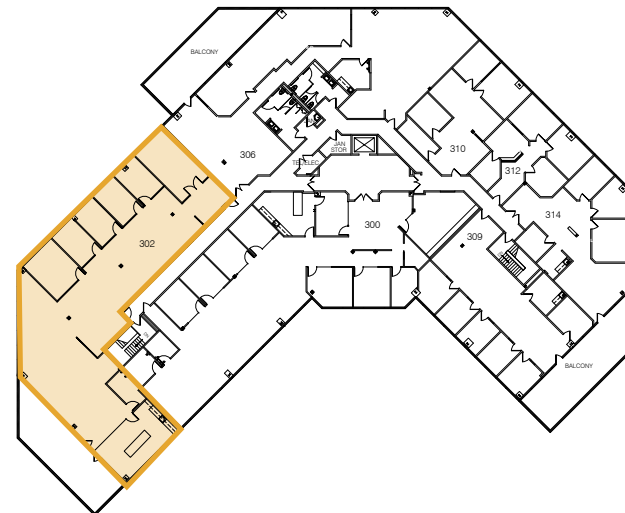

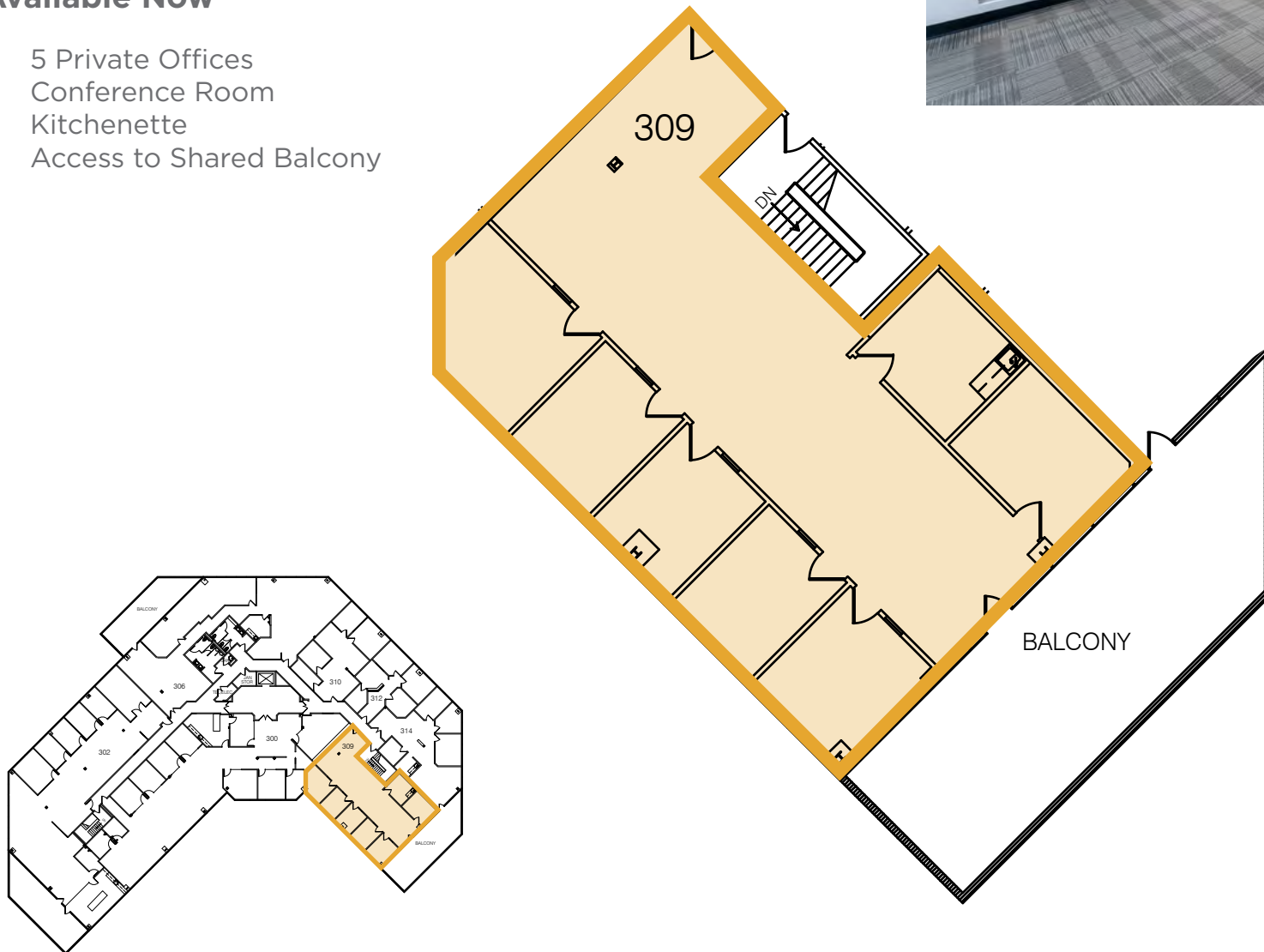
