This Updated Replacement Exhibits is executed and recorded by ADCS, LP, a Texas limited partnership (the "Declarant") pursuant to the Declaration of Condominium for Spring Rose Office Condominiums, recorded in the Office of the County Clerk of Harris County, Texas under Volume 219, Page 402 of the Condominium Records of Harris County, Texas, and Real Property Clerk's File No. 2022-444447 (the "Declaration") as follows:

- 1. Updated Replacement Exhibits. Pursuant to Article IX, Section 9.1, the Declaration is hereby amended to remove Exhibits B and C to the Declaration and replace and supersede them with the Updated Replacement Exhibits B and C attached hereto and made a part hereof. The effect of such replacement is to change the number and size of the Units in Buildings 18930, 18934, and 18944, as set out in the Updated Replacement Exhibits B and C attached hereto. In the event of any conflict between the descriptions of the Units set forth herein or in the Declaration, the descriptions set forth herein shall control. This replacement was contemplated by and is authorized by such Article IX, Section 9.1 of the Declaration.
- 2. Defined Term. The Defined Term "Unit" set forth in Article I, Section 1.1.w is hereby deleted in its entirety and is replaced with the following, as if originally a part thereof, this being a ministerial change that the Declarant is authorized to make:
 - t. <u>Units</u> The 38 condominium units designated on Exhibit "B" attached hereto, the boundaries of which shall be the interior surfaces of the perimeter walls, perimeter floors, ceilings, windows and window frames, doors and door frames that provide access to and egress from Common Areas, and which shall include the portions of the Buildings and the air space within such boundaries as shown on said Exhibit "B", excepting Common Elements. Included within the boundaries of each Unit, without limitation, shall be any finishing materials applied or affixed to the interior surfaces of the interior walls, floors or ceilings (such as, but without limitation, paint, wallpaper, wall or floor coverings and carpet); interior walls and doors separating rooms within a Unit and all utility pipes, lines, systems, fixtures or appliances servicing only that Unit (whether or not within the boundaries of that Unit) including, without limitation, hot water heaters, chilled and

heated water pipes, air handlers, fan coil units and all visible and exposed plumbing fixtures, lines and pipes within the boundaries of a Unit.

3. Binding Effect. Capitalized terms used and not otherwise defined herein shall have the meaning set forth in the Declaration. This instrument is binding upon the condominium, the Association, and all owners of Units, their heirs, successors and assigns, and runs with the Condominium and Property.




