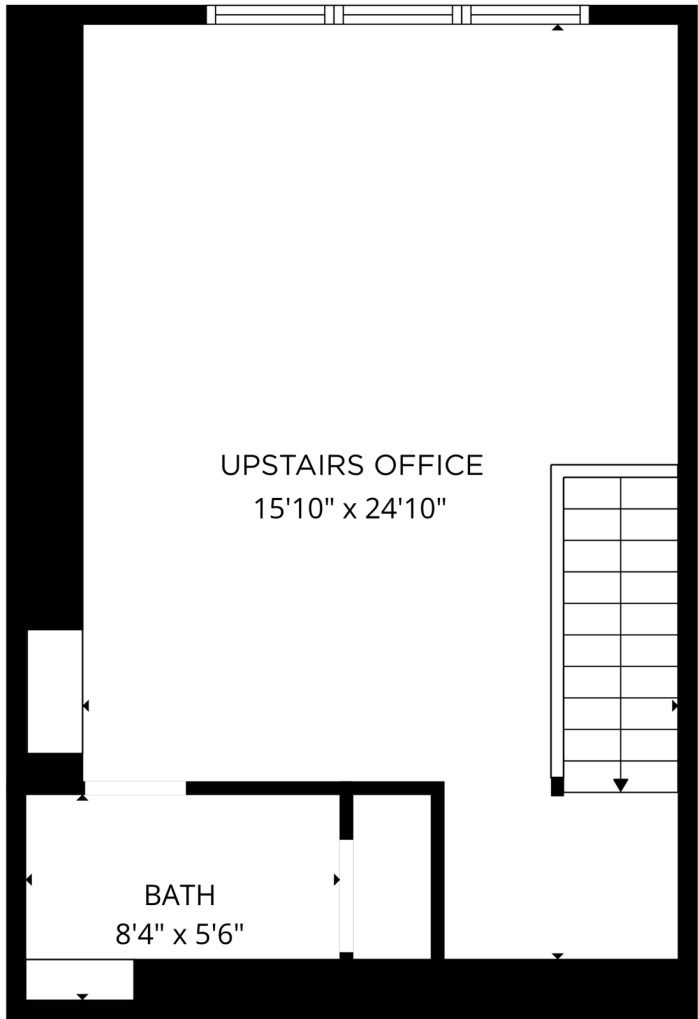

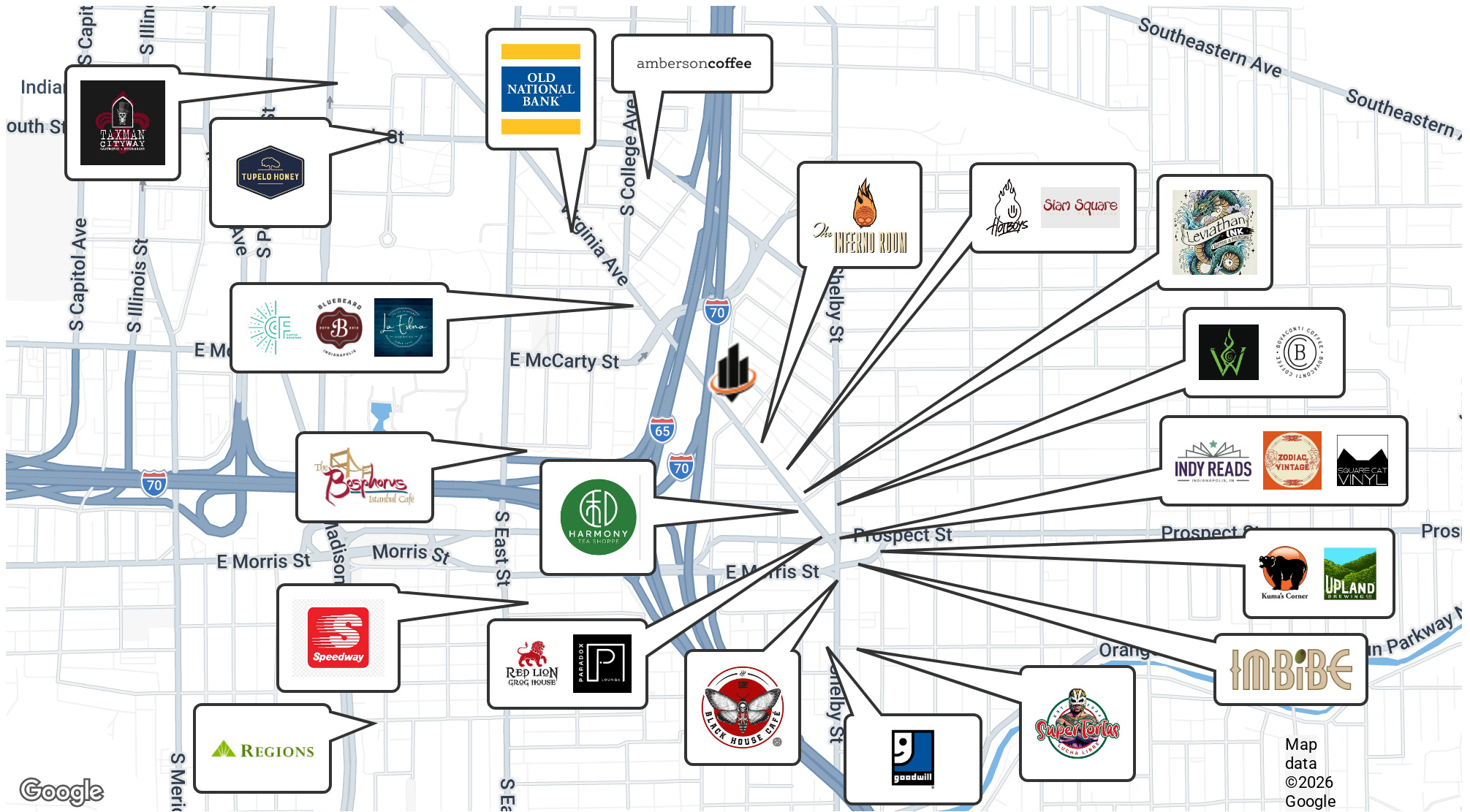

RETAILER MAP



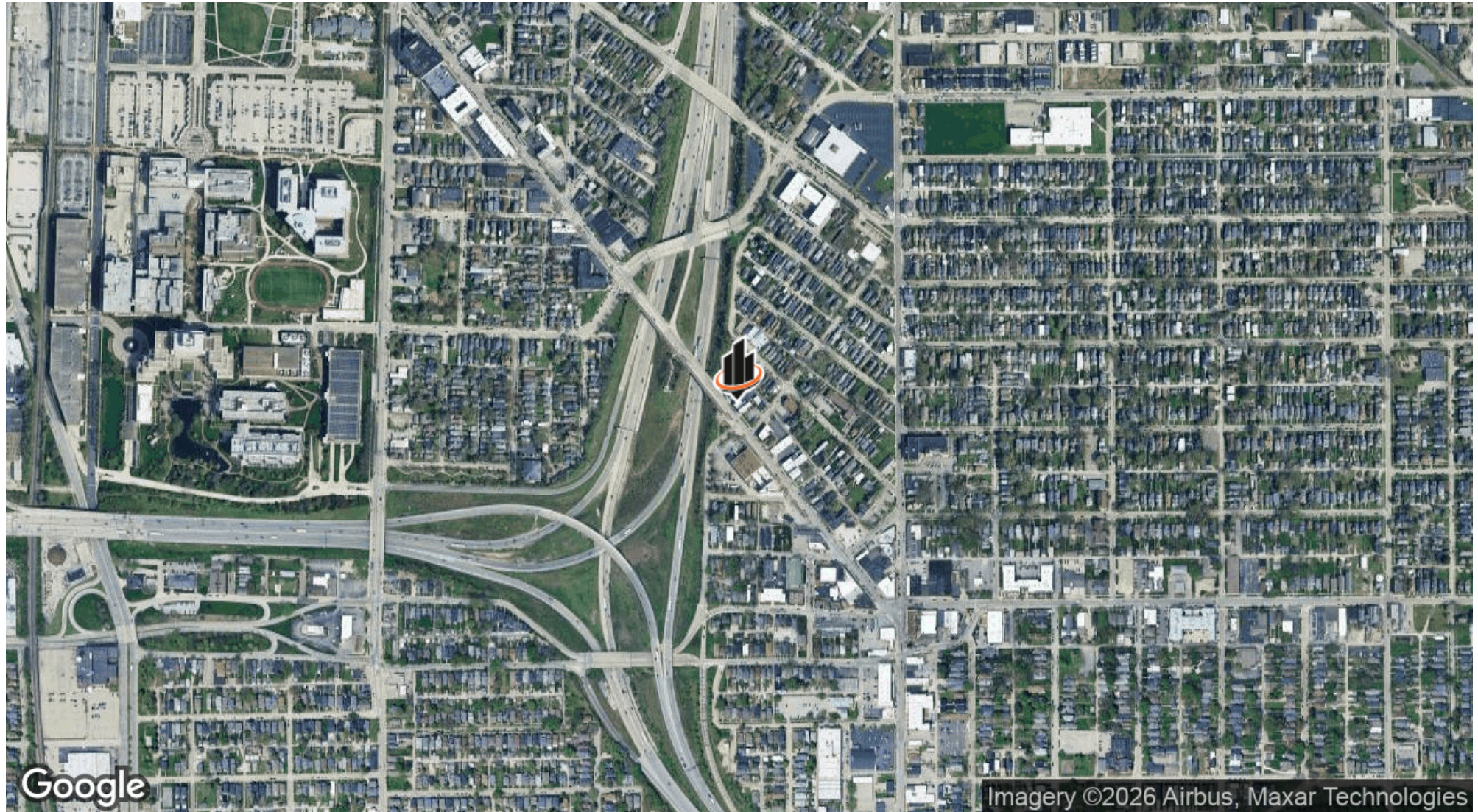
