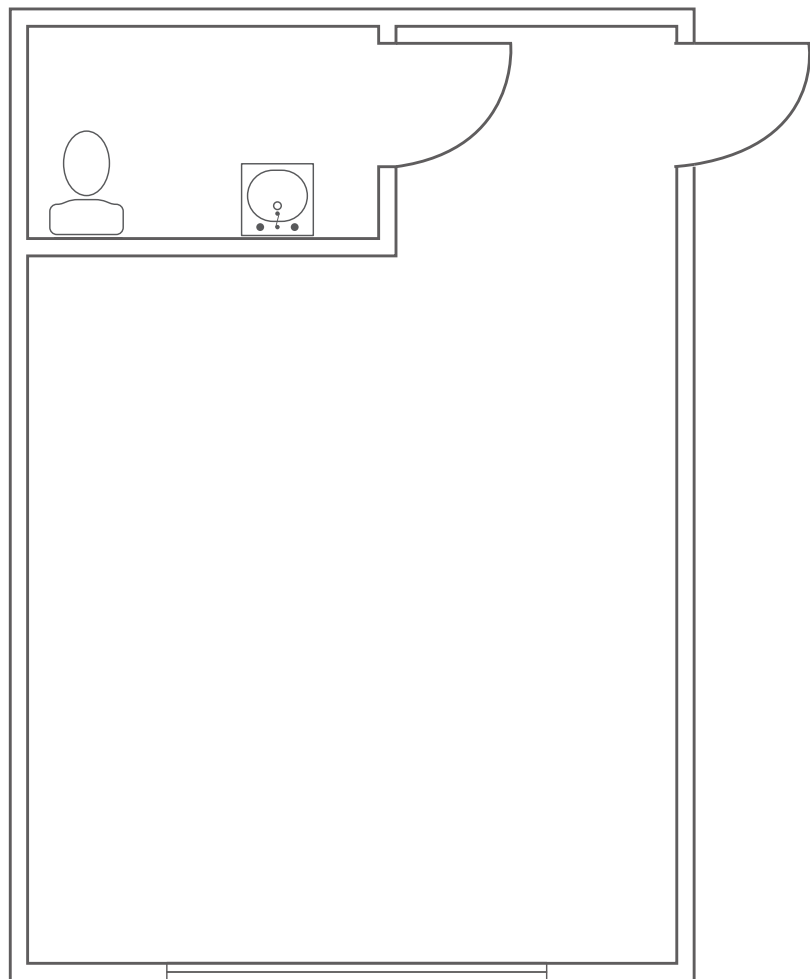

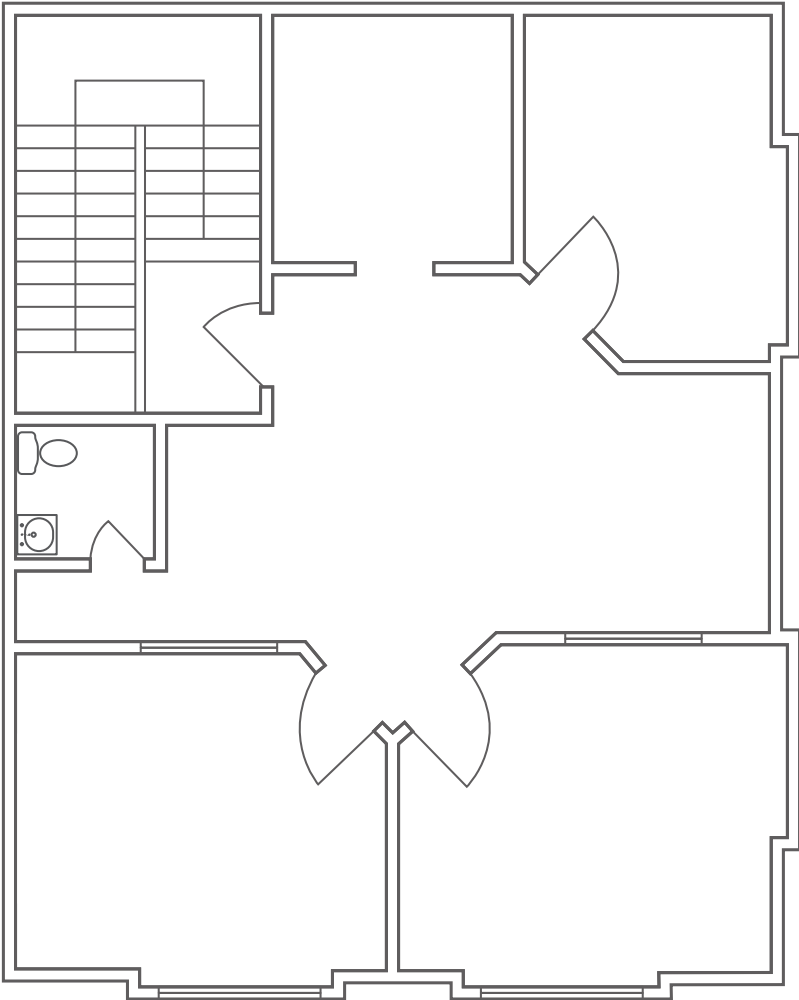


FLOOR PLANS

SECOND FLOOR

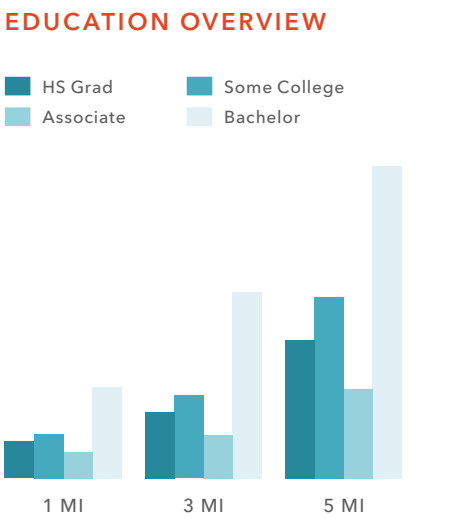
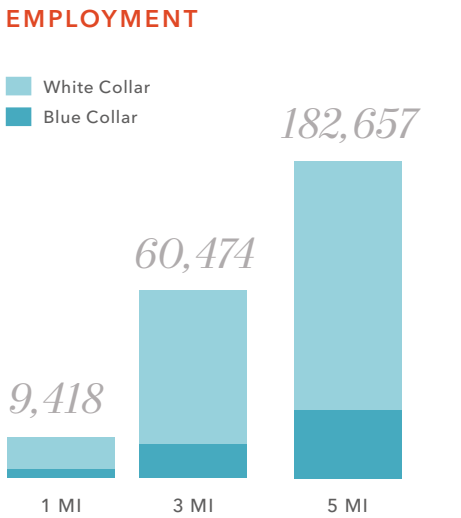
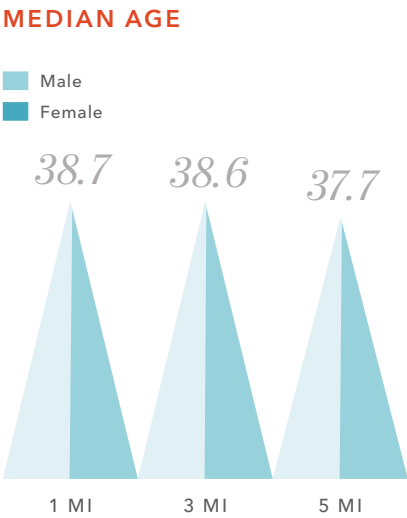
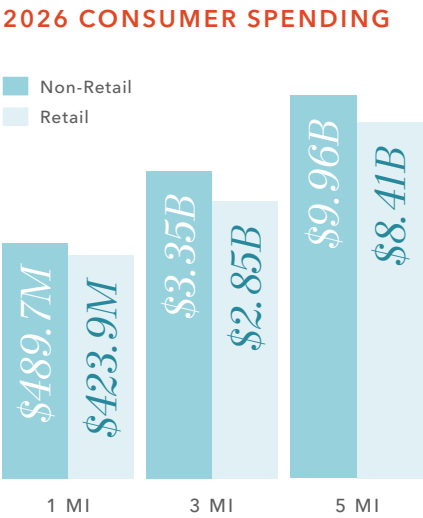
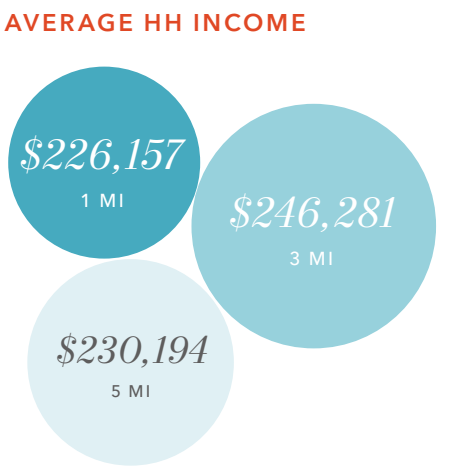
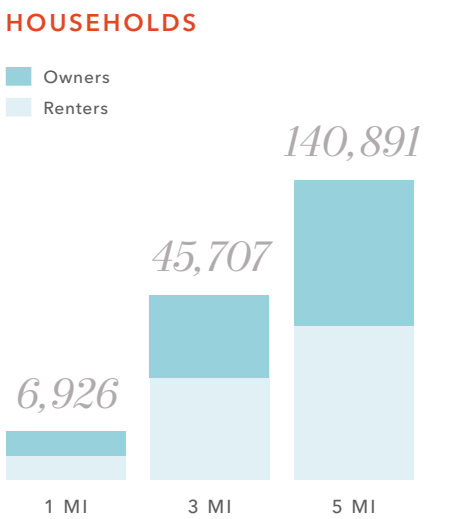
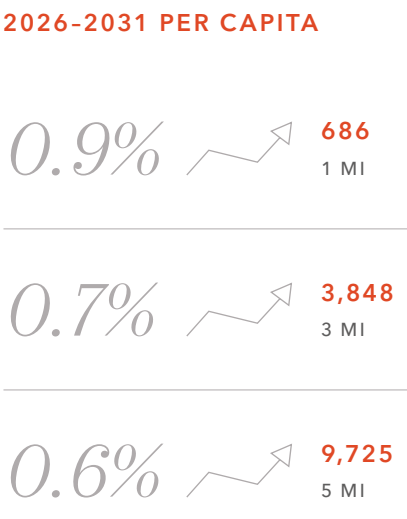
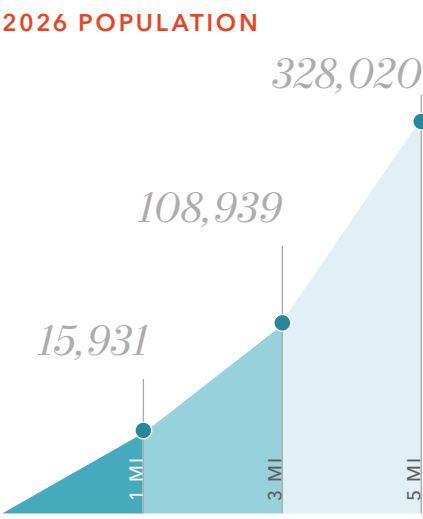
