M&D CRE is pleased to present this 2,635 SF stand-alone restaurant facility at 565 W Bedford Euless Rd offers a true turn-key opportunity for operators seeking a move-in-ready space with minimal downtime. Situated on a combined 0.649-acre lot with 96 feet of prominent frontage, the property combines professional-grade infrastructure with a distinctive aesthetic. Located along a high-visibility Mid-Cities corridor, the site features three access points and on-site asphalt parking serving the Hurst, Euless, and Bedford trade areas.

The fully built-out kitchen is designed for high-volume service and includes a CaptiveAire hood system with Ansul fire suppression, a commercial smoker, dual deep fryers, freezer/warmer, ice machine, and walk-in cooler/freezer. All equipment is supported by natural gas service and a functional Honeywell HVAC unit. The front-of-house features a custom service counter with dual hot-and-cold serving lines, integrated warming drawers, and prep stations, while the dining area offers two seating zones—including a 37' x 17' main room—enhanced by a separate HVAC and ceiling fans for maximum comfort.

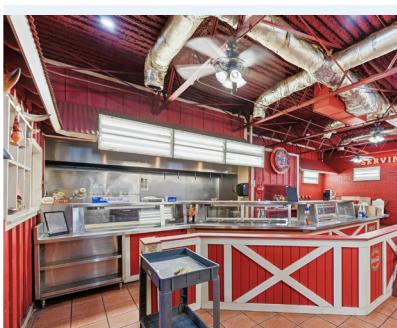

Hurst, TX Overview

Hurst is a well-established Mid-Cities market offering scale, income stability, and consistent consumer demand. Within a 15-minute trade area, the city serves more than 477,000 residents, supported by a strong daytime population exceeding 30,000 and median household incomes near \$76,000 in the immediate area. A predominantly white-collar workforce (62.7%) and low housing vacancy rates (4.6%) reflect a stable, entrenched customer base rather than a transient or speculative market.

Dining demand in Hurst is demonstrably above national averages, with over 75% of local adults visiting family-style restaurants within the past six months and strong brand affinity across casual and quick-service concepts. Annual food-away-from-home spending exceeds \$40 million within a five-minute radius, driven by balanced weekday and weekend traffic patterns. These fundamentals support reliable restaurant performance and long-term commercial viability in a low-volatility suburban environment.

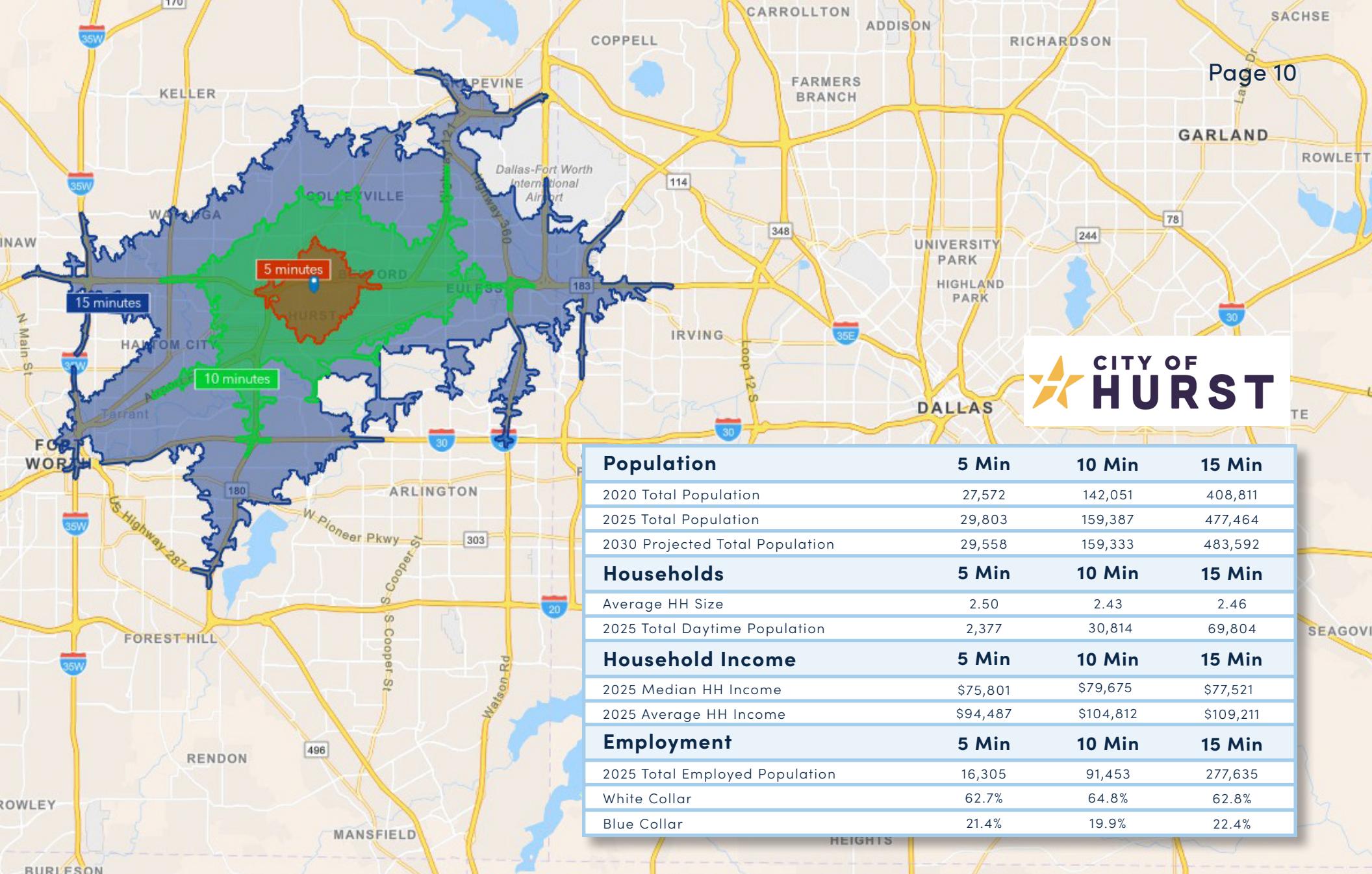
