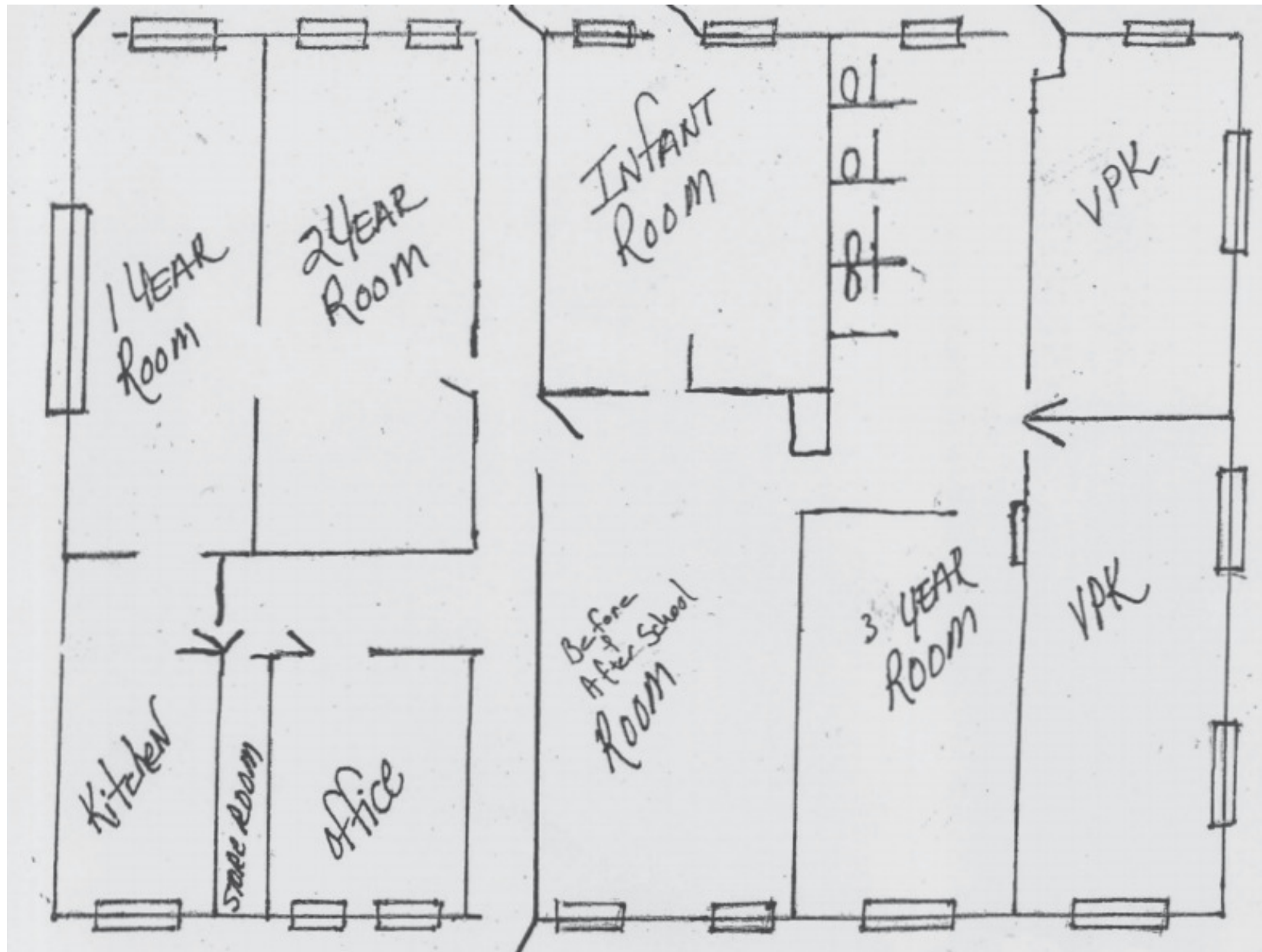

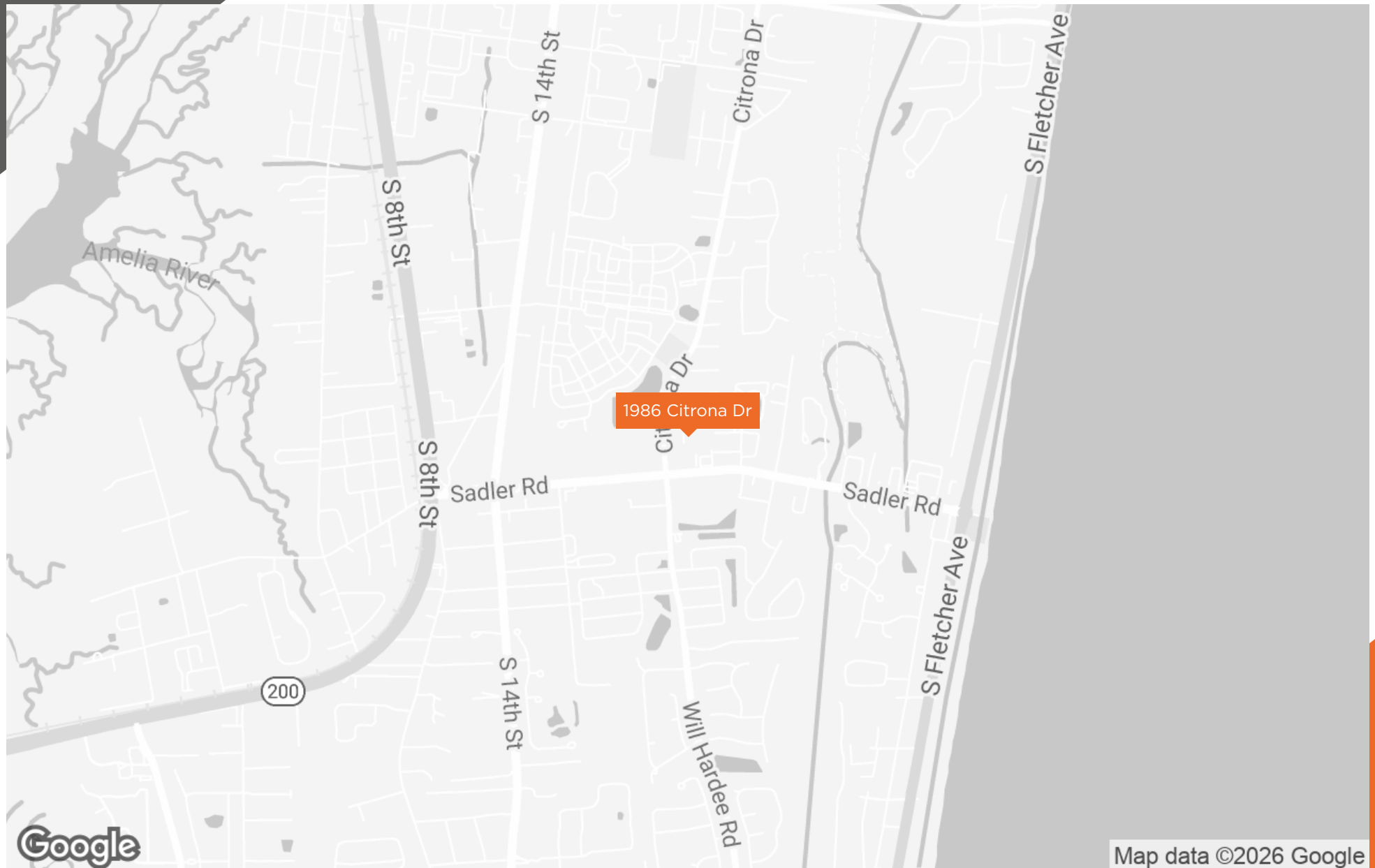

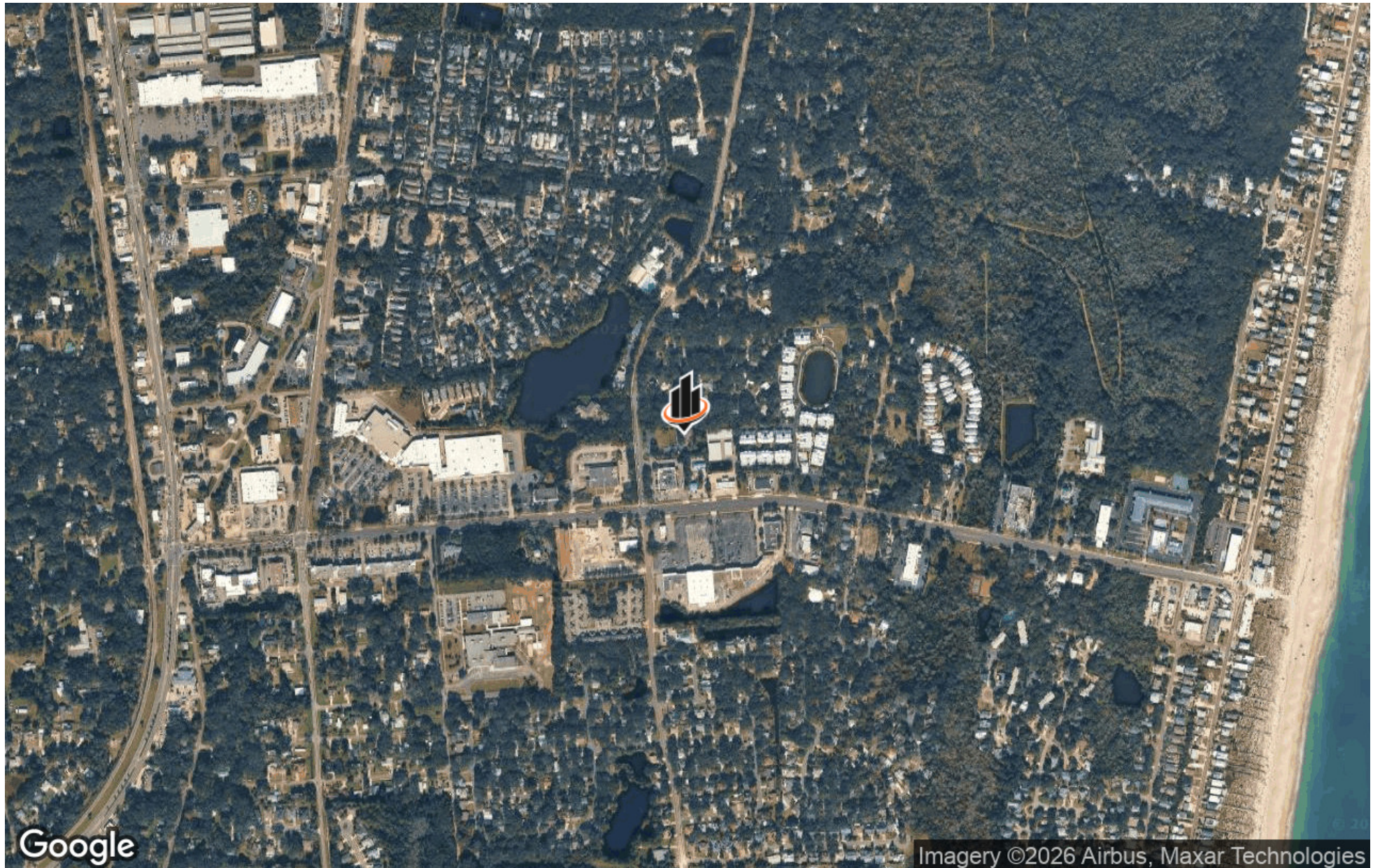
FLOOR PLANS



REGIONAL MAP



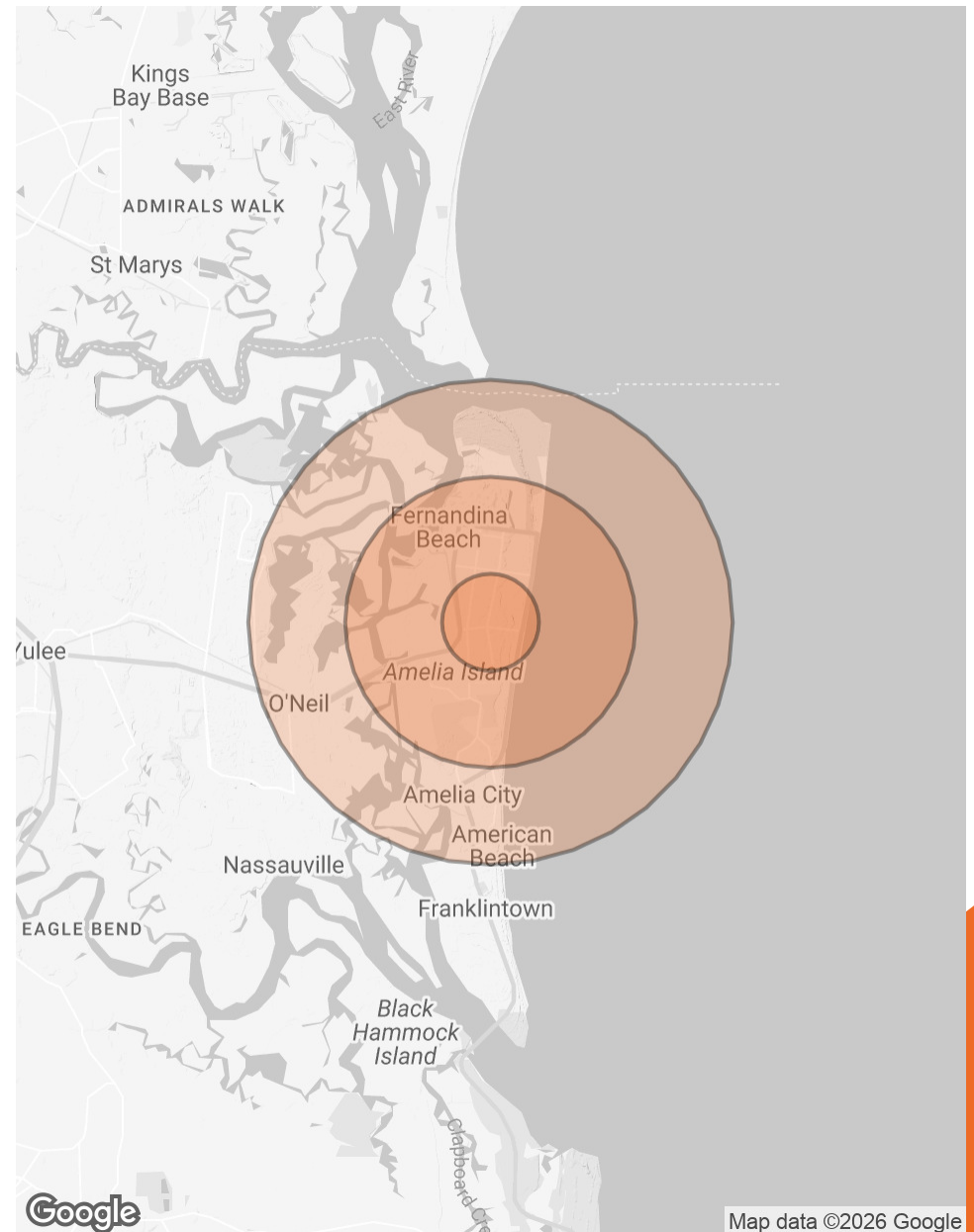
