Currently, 68.4% of the 32,600 housing units in the area are owner occupied; 23.8%, renter occupied; and 7.8% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 30,094 housing units in the area - 68.8% owner occupied, 23.0% renter occupied, and 8.2% vacant. The annual rate of change in housing units since 2010 is 3.62%. Median home value in the area is \$183,971, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 1.60% annually to \$199,185.
