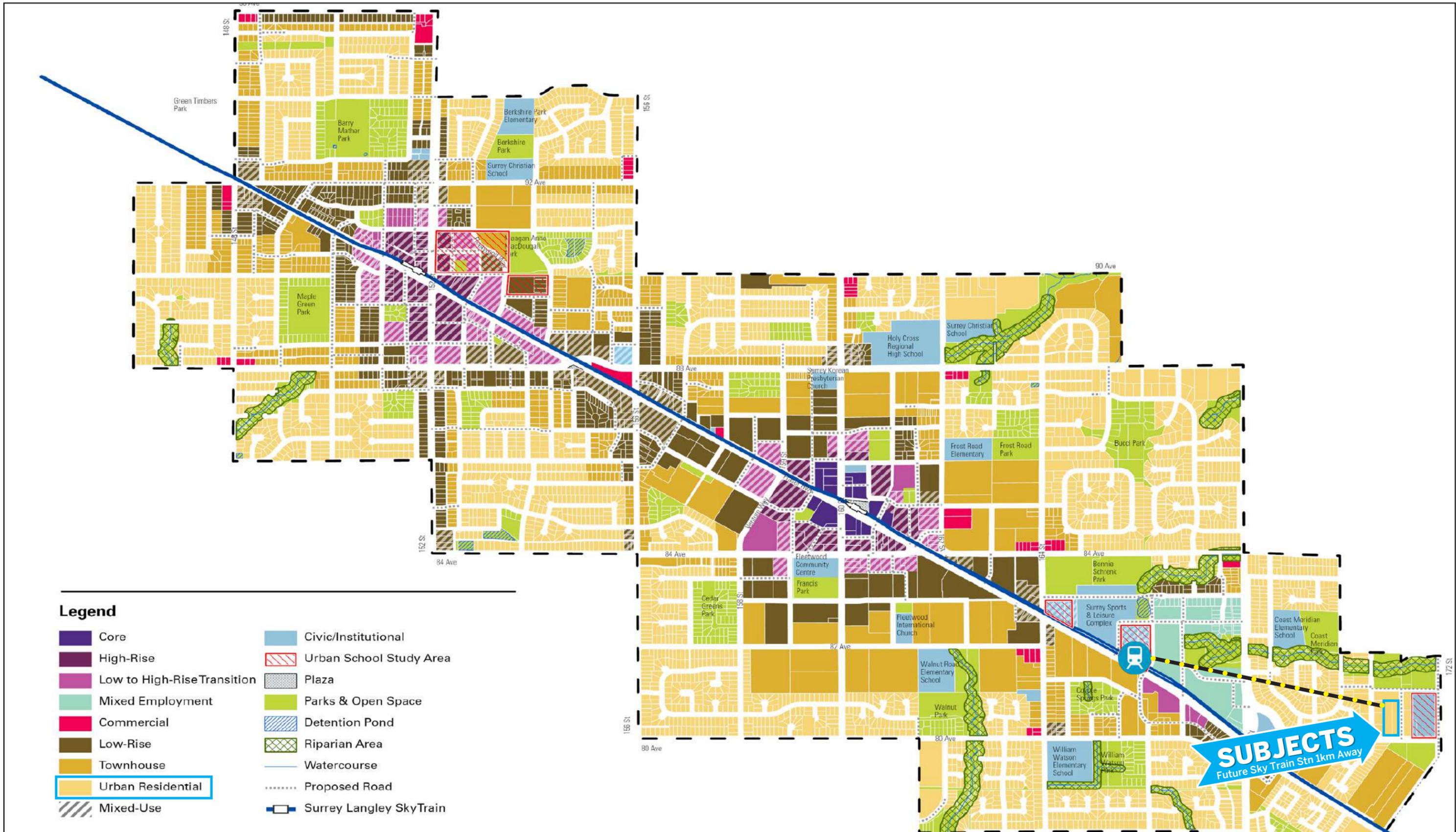

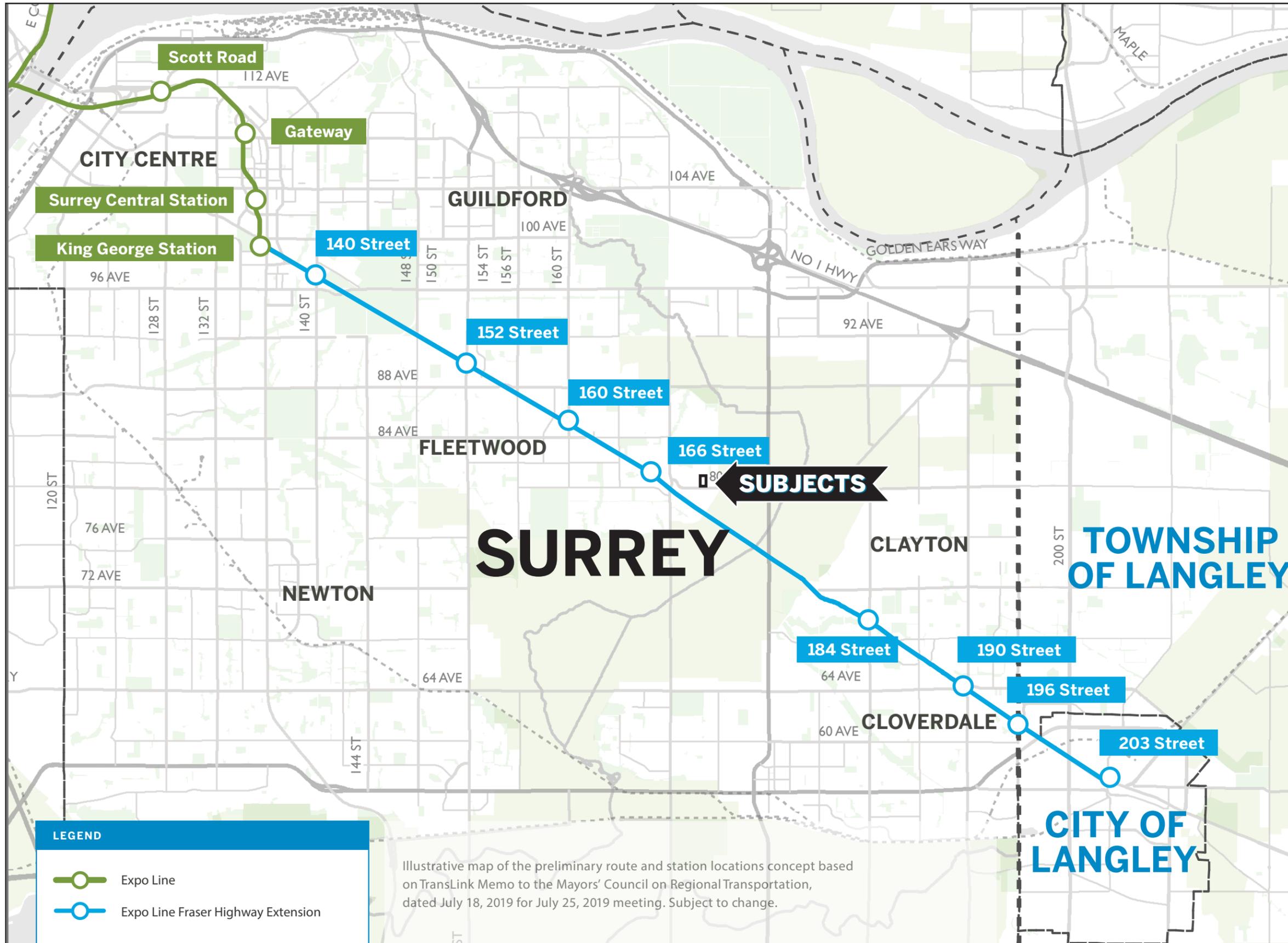

FLEETWOOD LATEST LAND USE MAP: STAGE 1

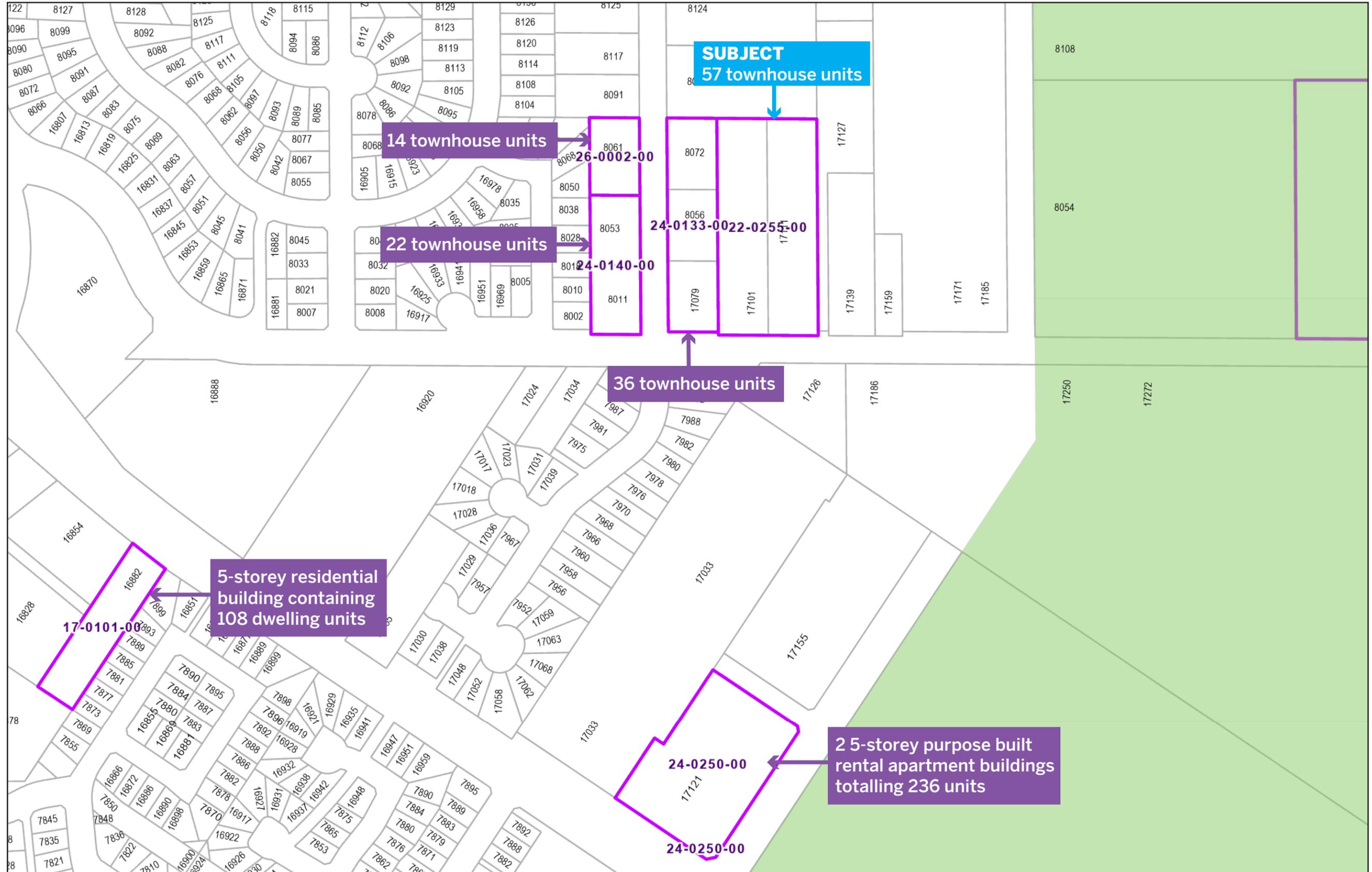

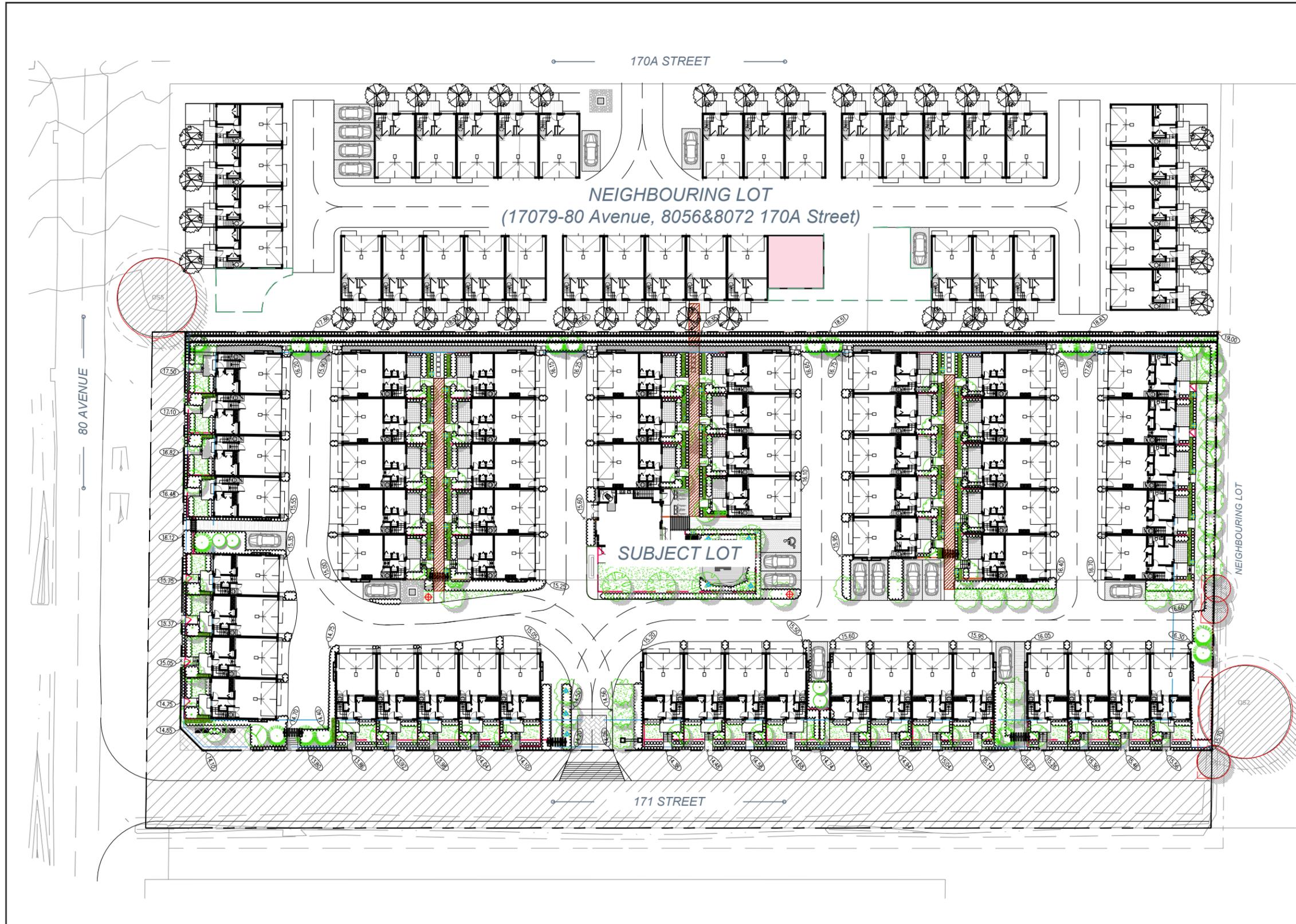

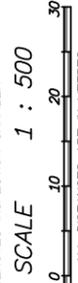
