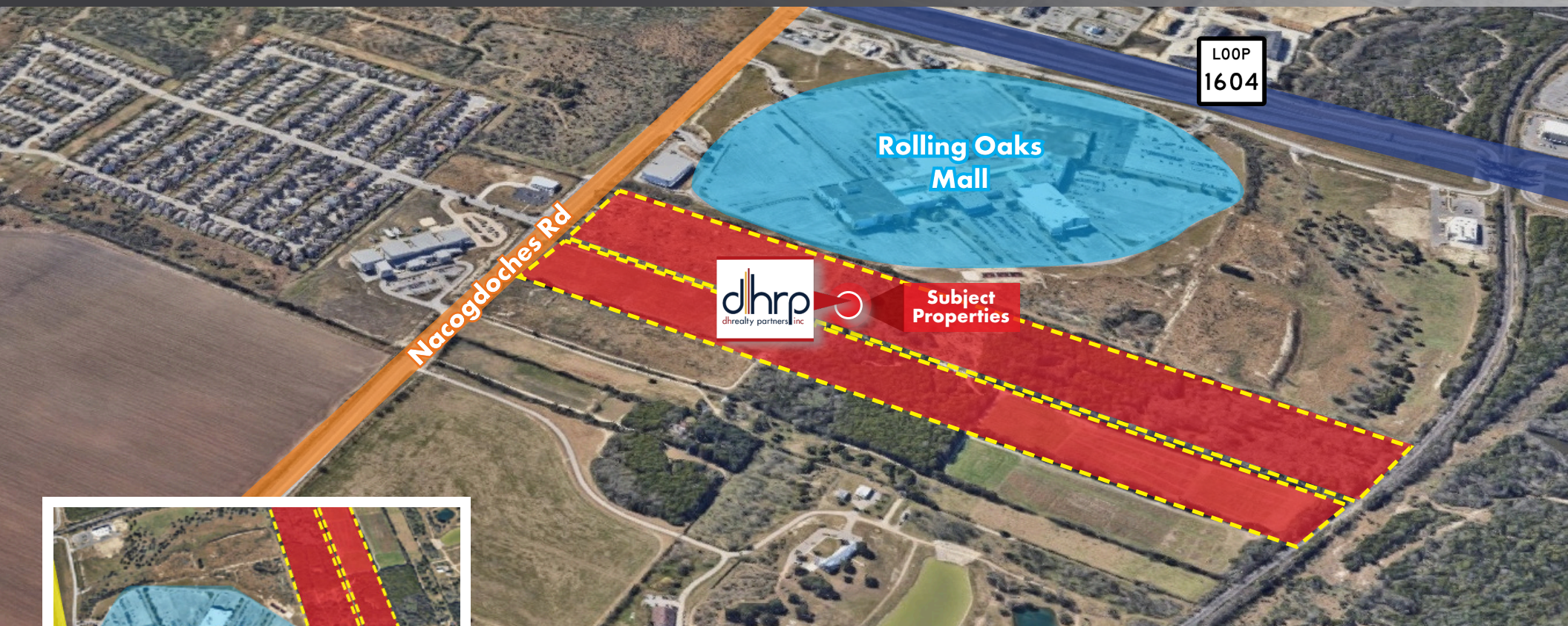

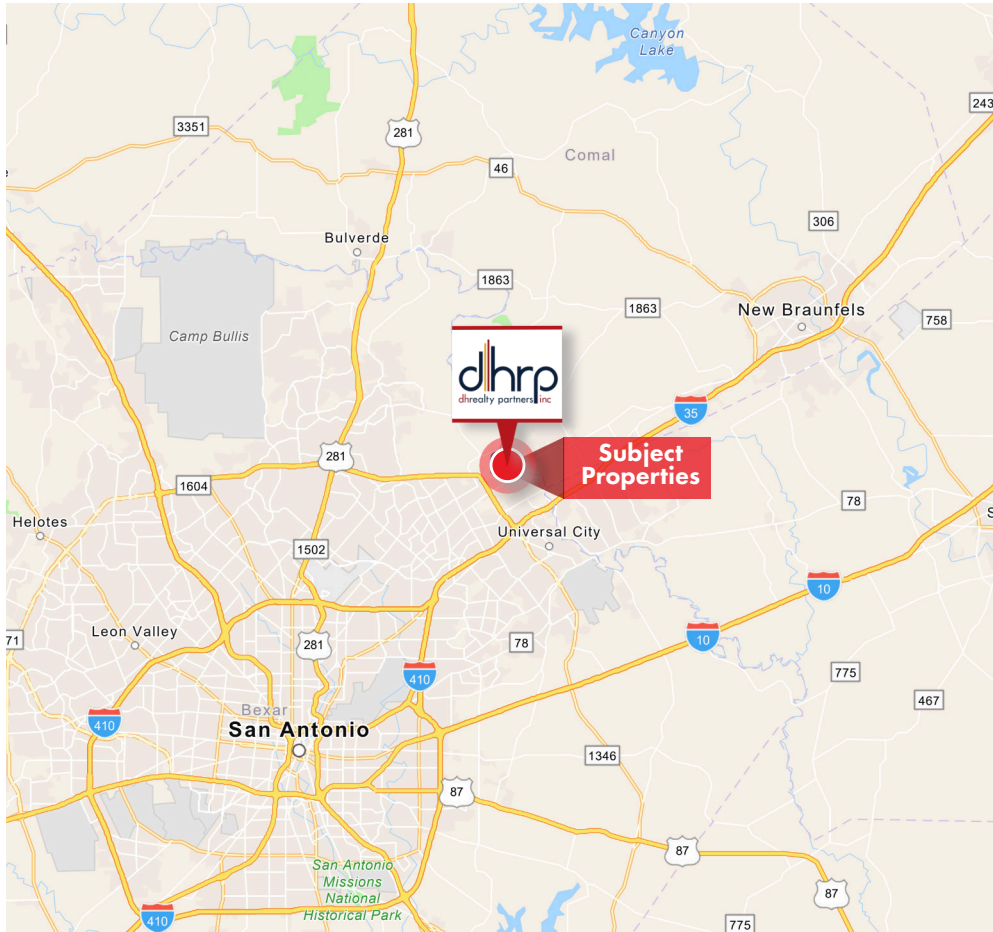

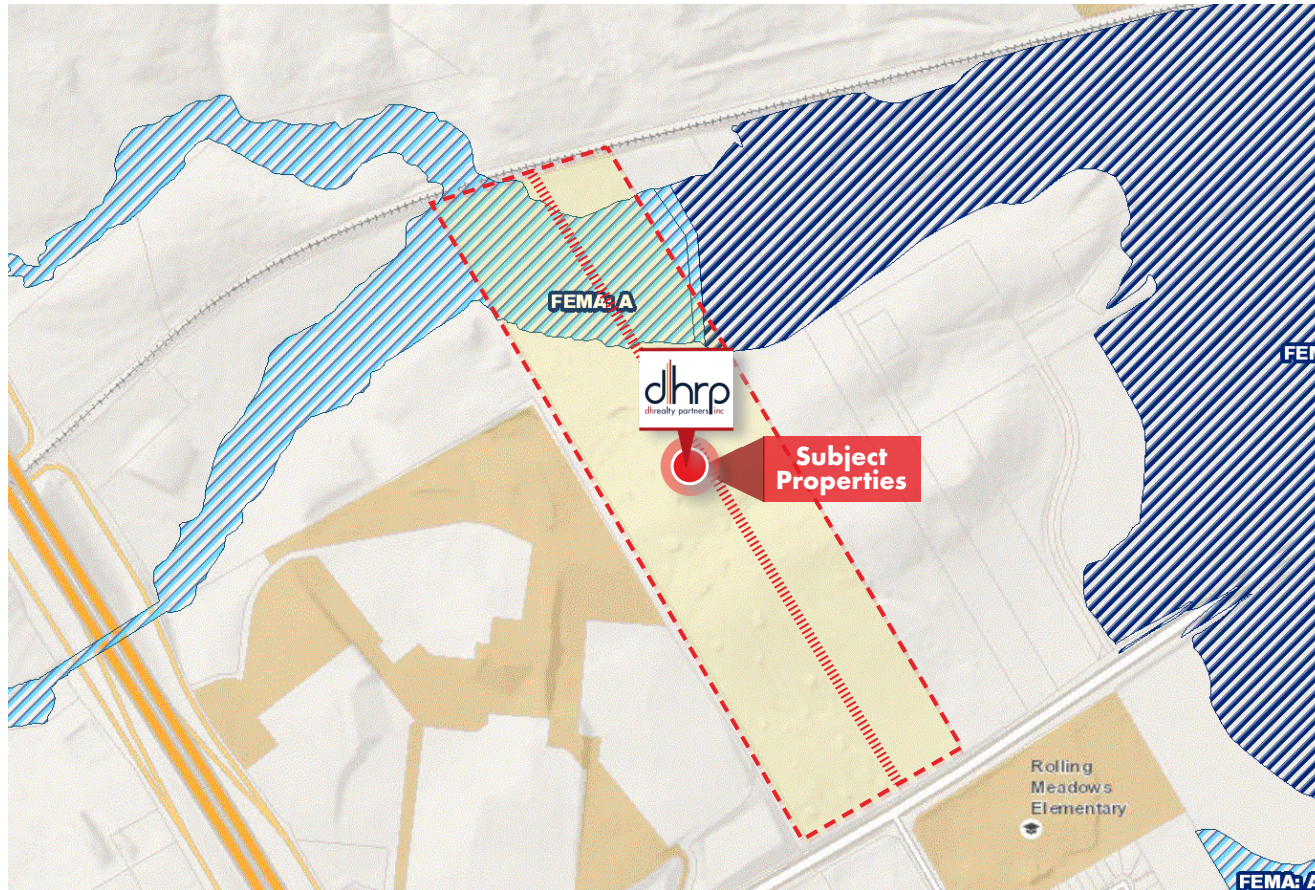

FLOOD MAP



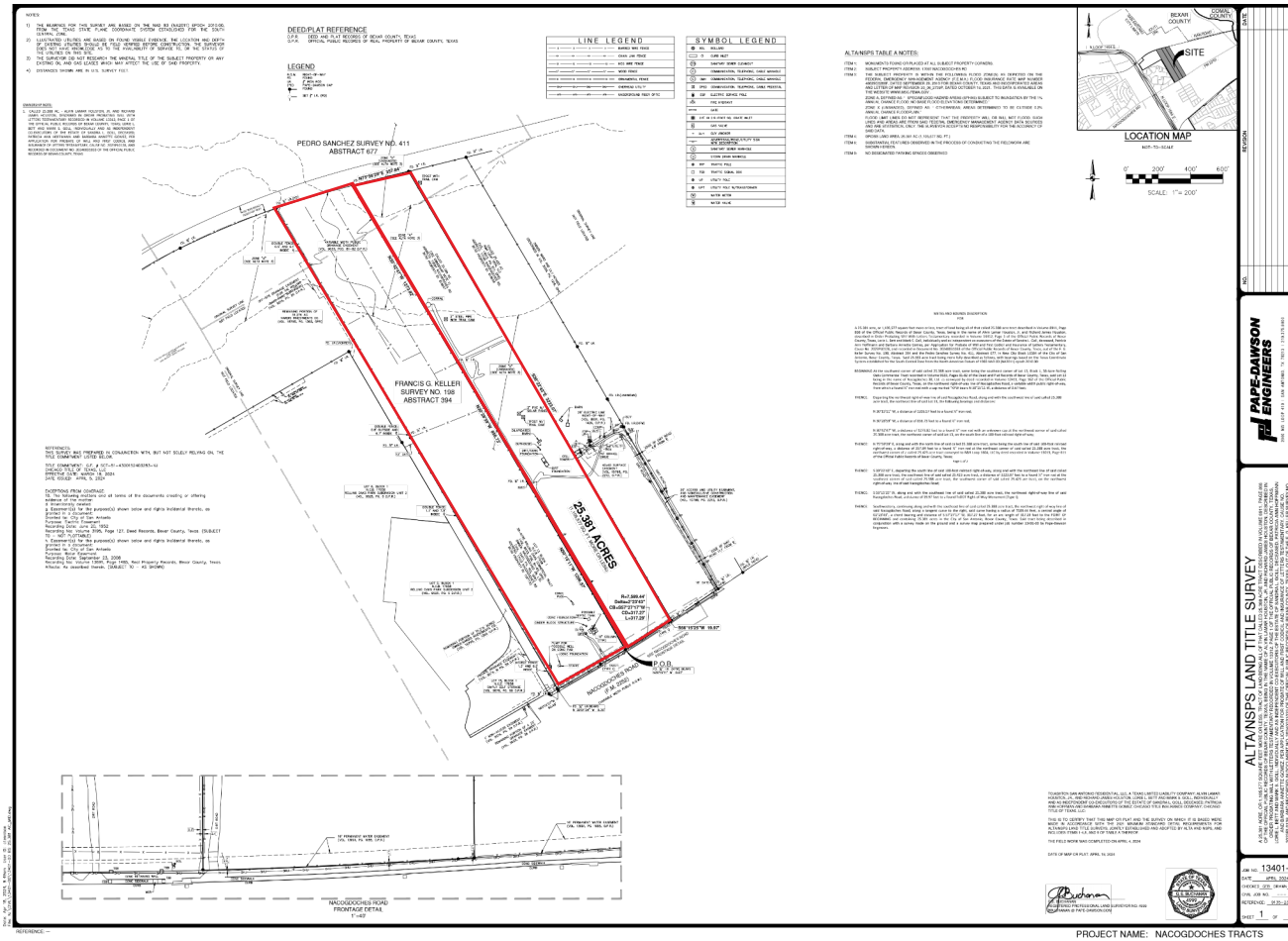

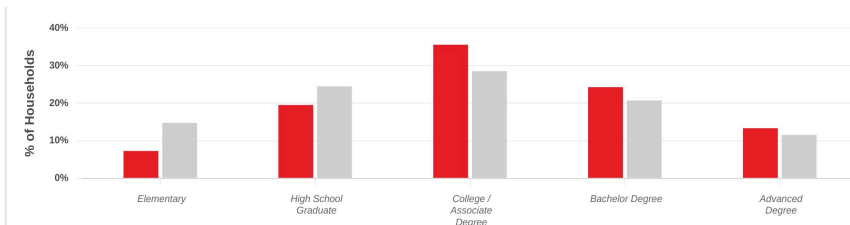

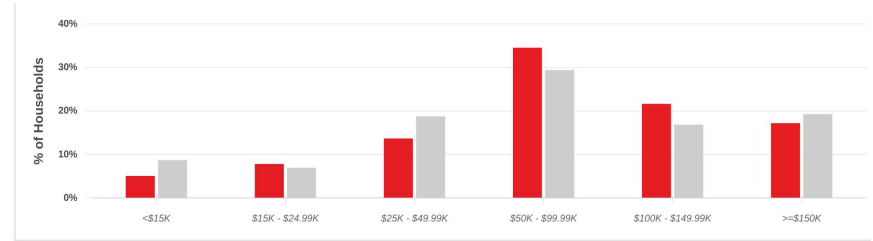

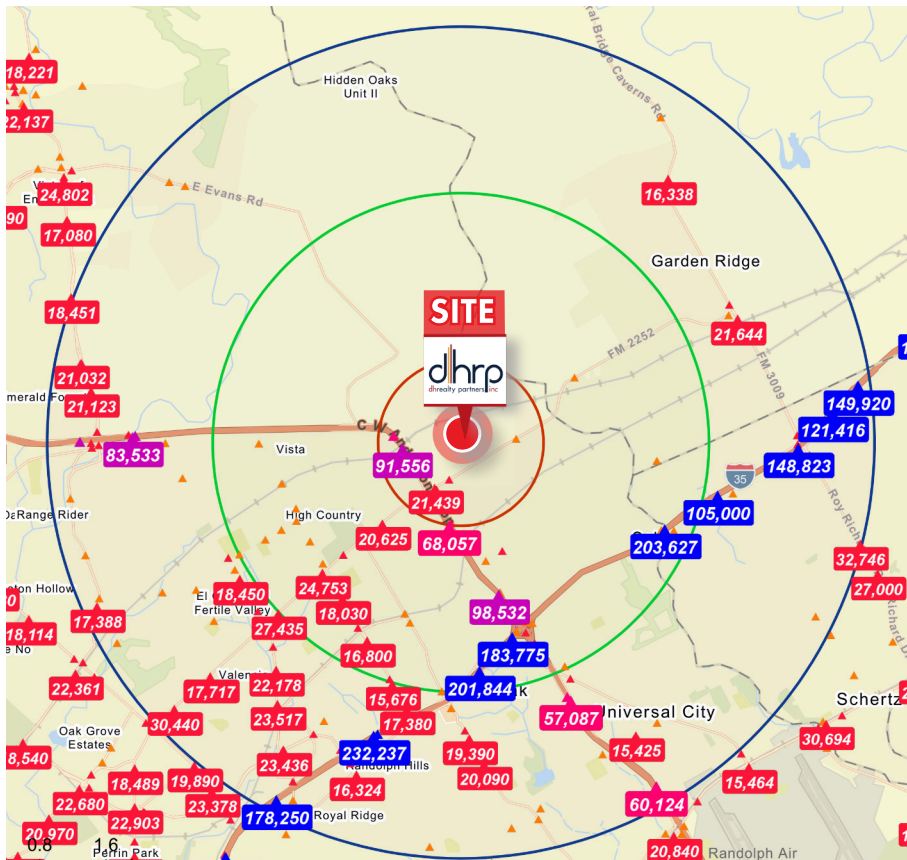
