




### CANNONBALL TRAIL & DICKSON ROAD REALIGNMENT PROJECT

The Cannonball Trail and Dickson Road Realignment Project is a key infrastructure improvement aimed at enhancing traffic flow, increasing roadway safety, and supporting future connectivity. A joint effort between the Village of Montgomery and the Kendall County Highway Department, the project involves extending Gordon Road to connect with a newly aligned portion of Cannonball Trail, creating a four-way stop and vacating the intersection of Dickson and Galena Roads.

This realignment will improve driver safety, reduce congestion, and provide a more organized traffic route through Montgomery. By summer 2025, the intersection will be upgraded to a traffic signal, further enhancing efficiency and accessibility. The project is also part of a larger vision to extend Gordon Road beyond its current endpoint, improving regional connectivity for residents and visitors.

Construction on the new section of Gordon Road is nearly complete, and the closure of the Galena-Dickson intersection is set to begin in late November, weather permitting. Residents and travelers should expect changes in traffic patterns and remain mindful of ongoing work in the area.

The Village of Montgomery is dedicated to maintaining high infrastructure standards and fostering sustainable growth. This realignment reflects the Village's commitment to a well-planned, efficient road network that meets the needs of its citizens both now and in the future.


