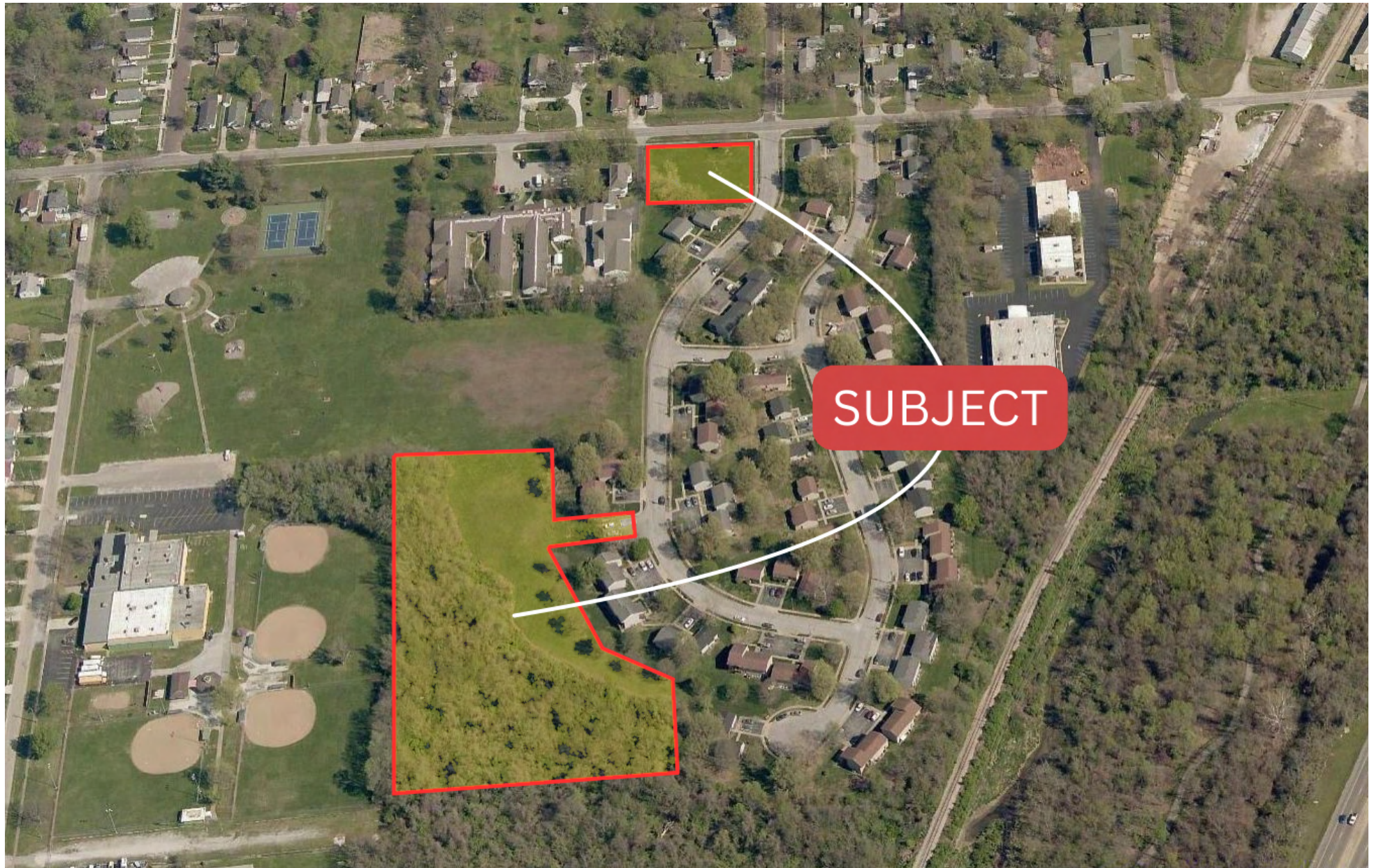

LOCATION MAP

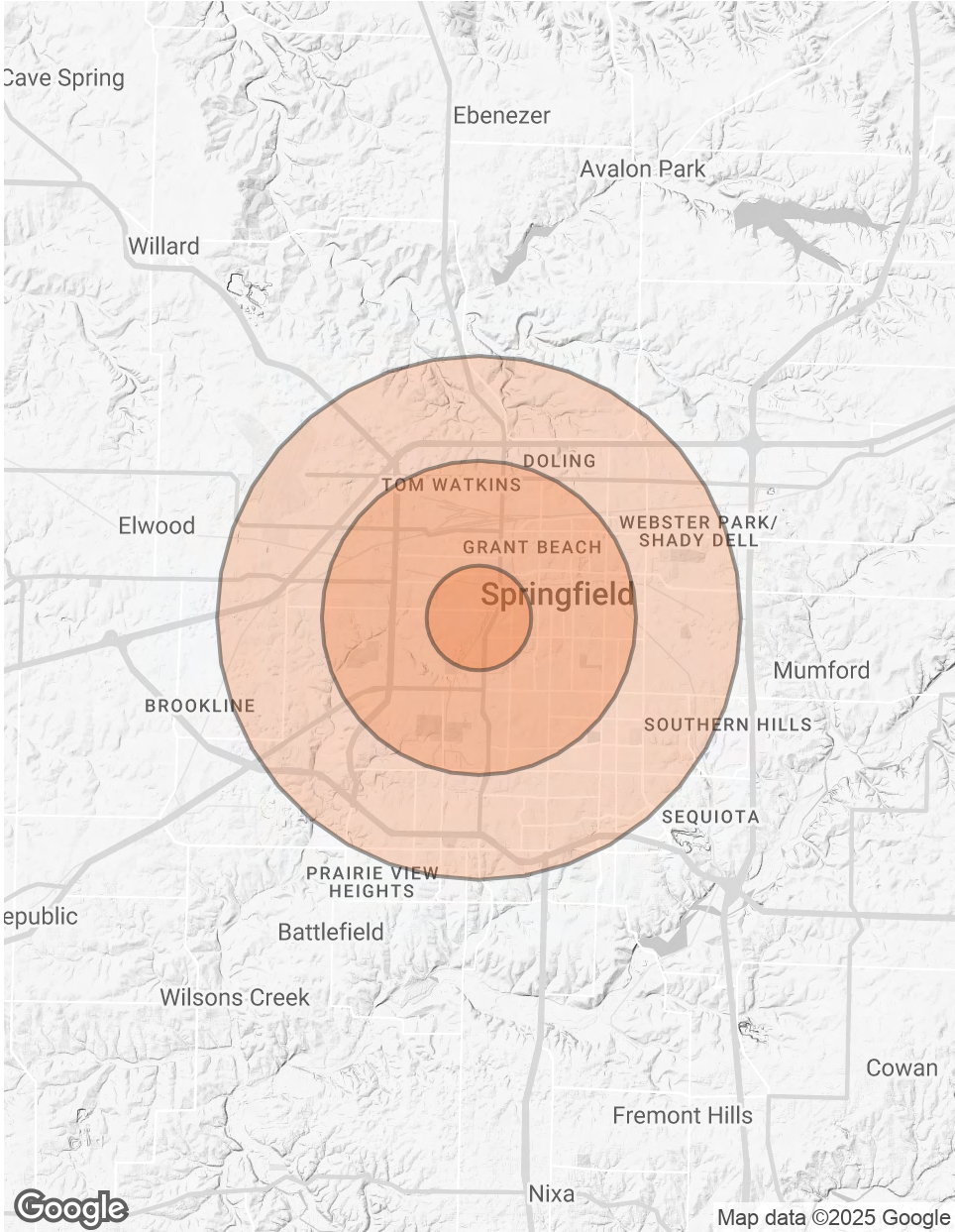
