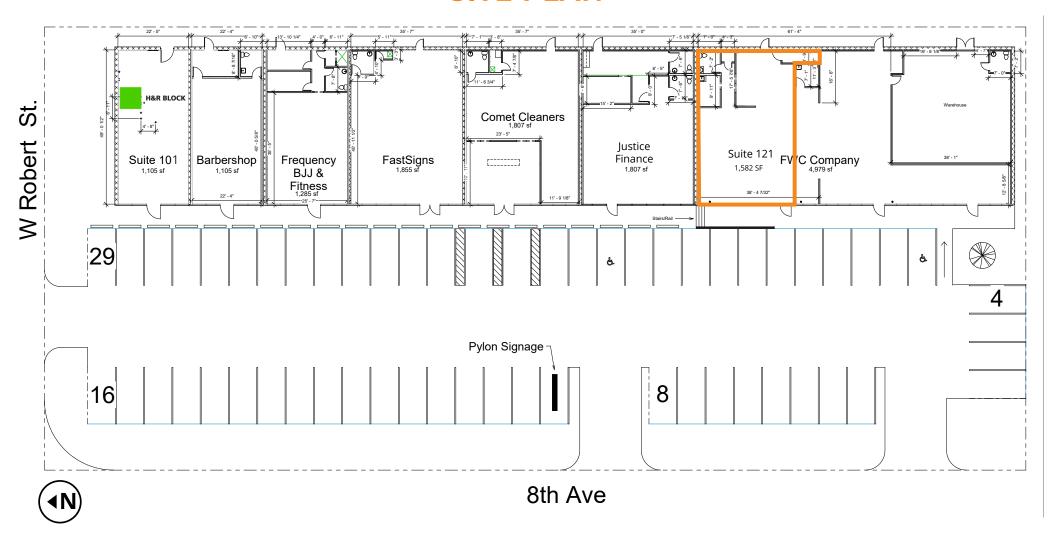

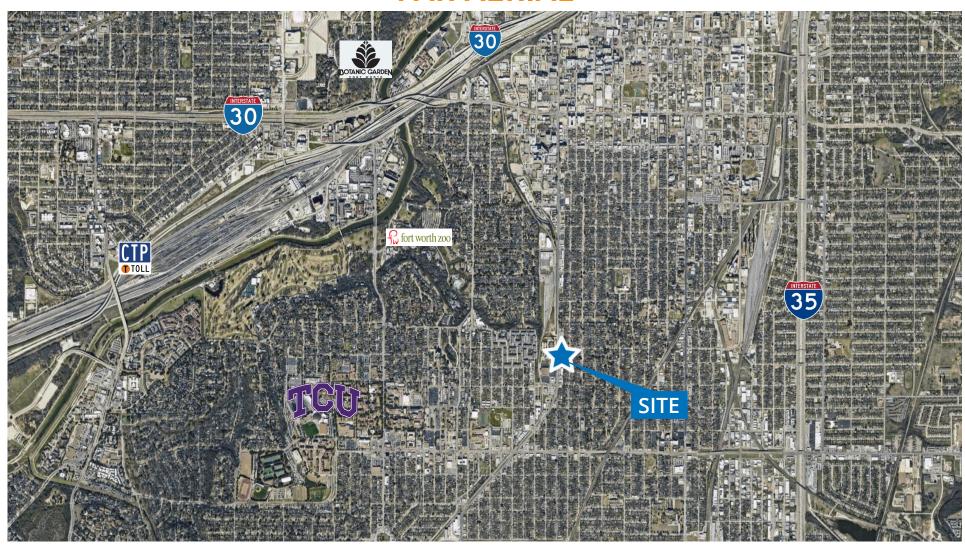

Information About Brokerage Services

11/2/2016

Fexas law requires all real estate licensees to give the following information about brokerage services to prospective buyers, tenents, sellers and landfords

- A BROKER is responsible for all brokenage activities, including acts performed by sales agents spansoned by the broken TYPES OF REAL ESTATELICENSE HOLDERS:
 - A SALES AGENT must be sporsored by a broker and works with clears on behalf of the broker

A BROKER'S MINIMUM DUTIES REQUIRED BY LAW (A client is the person or party that the broker represents):

- Put the interests of the client above all others, including the bioker's own interests;
- Inform the ottent of any material information about the property or transaction received by the broker;
 - Answer the clerifs questions and present any offer to or counter-offer from the client, and
 - Treat all parties to a real estate transaction honeatly and fairly.

A LICENSE HOLDER CAN REPRESENT A PARTY IN A REAL ESTATE TRANSACTION:

usually in a written fisting to sail or property management agreement. An owner's agent must perform the broken's minimum duties above and must inform the cenner of any material information about the property or transaction known by the agent, including AS AGENT FOR OWNER (SELLERILANDLORD): The broker becomes the property owner's agent through an agreement with the owner, information disclosed to the agent or subagent by the buyer or buyer's agent.

AS AGENT FOR BUYER/TENANT: The broker becames the buyer/tenant's agent by agreeing to represent the buyer, usually through a written representation agreement. A buyer's agent must perform the troker's minimum duties above and must inform the buyer of any material information about the property or transaction known by the agent, including information disclosed to the agent by the AS AGENT FOR BOTH - INTERMEDIARY: To so as an intermediary between the parties the broken must first obtain the written agreement of each party to the transaction. The written agreement must state who will pay the broker and, in conspicuous bold underlined print, sat forth the broken's obligations as an intermediary. A broken who acts as an innermediary.

- Most treat all parties to the transaction impartially and fairly.
- May, with the parties' written consent, appoint a different leanse holder associated with the broker to each party (owner and buyer) to communicate with, provide opinions and advice to, and carry out the instructions of each party to the transaction.
 - Must not, unless specifically authorized in willing to do so by the perty, disdose:
 - that the owner will accept a price less than the written seking price;
- that the buyer/tenant will pay a price greater than the price submitted in a written offer, and
- ğ STATE OF institutes the broker in Specifically any confidential information or any other information that a party disclose, unless required to do so by law

SUBAGENT: A license holder acts as a subagent when aiding a buyer in a transaction without an agreement to represent the buyer. A subagant can assist the buyer but does not represent the buyer and must place the inferests of the owner first

TO AVOID DISPUTES, ALL AGREEMENTS BETWEEN YOU AND A BROKER SHOULD BE IN WRITING AND CLEARLY ESTABLISH:

- The broker's duties and responsibilities to you, and your deligations under the representation agreement
- Who will pay the broker for services provided to you, when payment will be made and how the payment will be calculated
