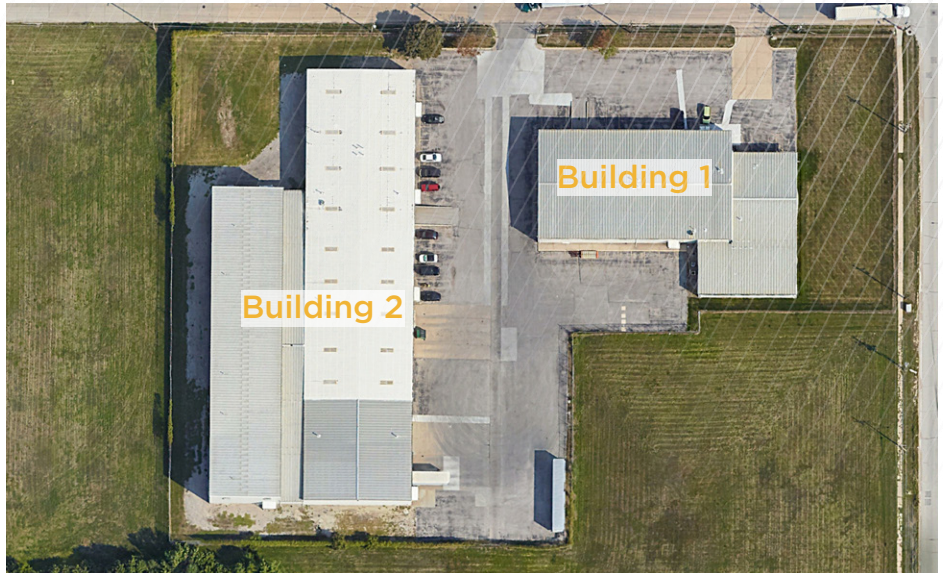
The property is also TIF-eligible and located within the Omaha Inland Port Authority area, offering access to potential local and state economic development incentives.

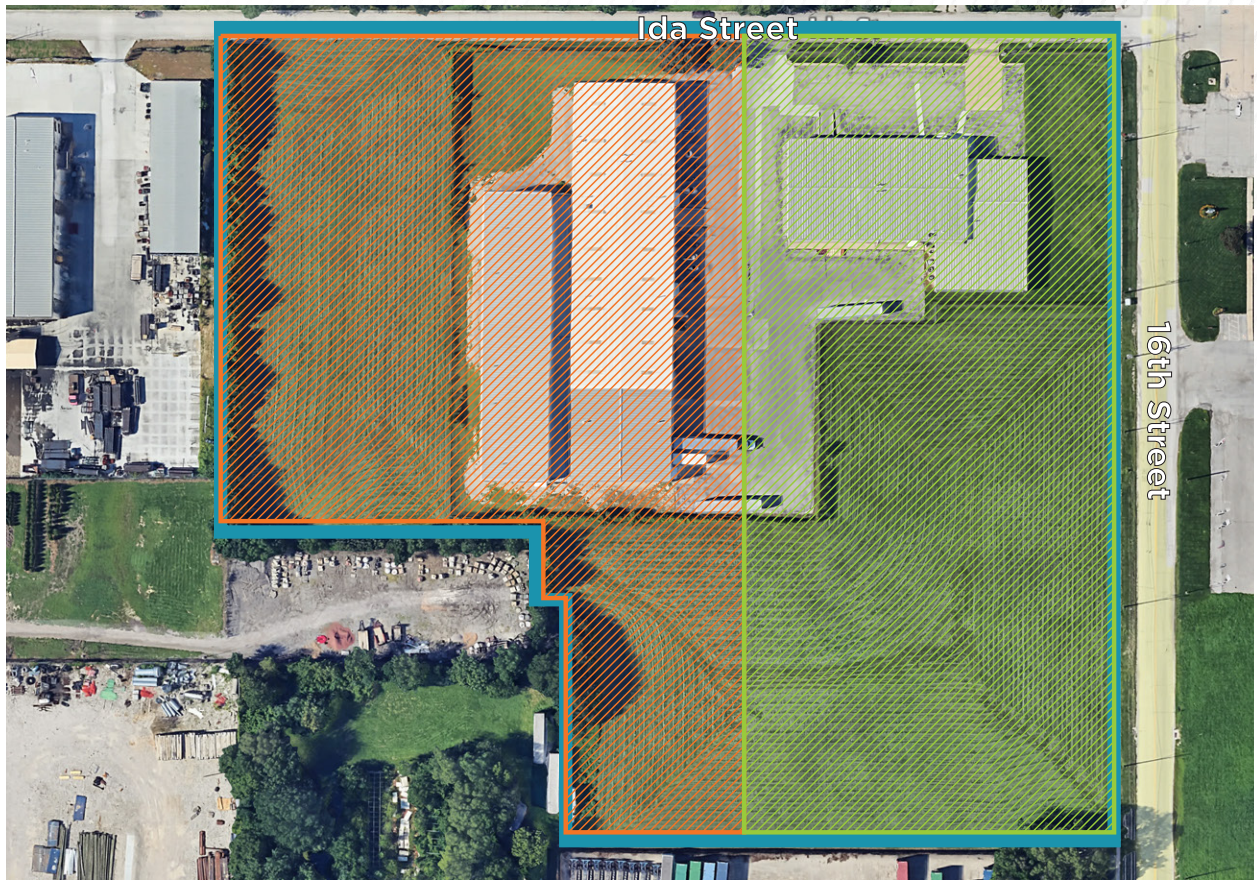
