

BEING a tract or parcel of land situated in the City of Corsicana, Navarro County, Texas, and being part of the William Hamilton Survey Abstract 373, and being that 2.6438 acre tract of land conveyed to Ray's Interstate 66, LLC, by deed recorded in Volume 1428 Page 593 of the Deed Records of Navarro County, and being more particularly described as follows:

BEGINNING at a point for corner at a 1" iron pipe found in the easterly line of Interstate Highway 45 at the southwesterly corner of said 2.6438 acre tract said point also being the northwesterly corner of that 15.525 acre tract of land conveyed to A. H. Vitters, et ux, by deed recorded in Volume 1092 Page 61 of the Deed Records of Navarro County;

THENCE North13° 22' 18" West (North 13° 20' West, deed) along the easterly line of Interstate Highway 45 a distance of 300.0 feet to a point for corner at a spike set;

THENCE North 59° 49' 14" East (North 59° 55' East, deed) along the northerly line of said 2.6438 acre tract a distance of 355.7 feet to a point for corner at a ½" iron rod set;

THENCE South 30L 41' 08" East (South 30° 40' East, deed) along the easterly line of said 2.6438 acre tract a distance of 288.59 feet (288 feet, deed) to a point for corner at a ½" iron rod set;

THENCE South 60° 00' West (record bearing) along the southerly line of said 2.6438 acre tract and the northerly line of said Vitters 15.525 acre tract a distance of 445.0 feet to the PLACE OF BEGINNING and containing 2.6565 acre.
