





Certain uses such as residential and retail businesses are not permitted in this zone in order to promote a viable heavy industrial area which will not be injurious to nor hindered by incompatible uses.

This property sits in an industrial area just north of Highway 12 and State Route 125. Easy access in all directions to get in and get out.
