There is abundant parking in the front and rear, which also includes covered parking.

The building and parking areas have a new solar panel system installed, which is included in the sale, and generates an approximate 220.88 kW, which is approximately a 79% building offset at full occupancy.

Centrally located in Palm Desert, CA, just off of Cook Street and Hovley Lane, this property offers easy access to Highway 111 and I-10 freeway via Cook Street.

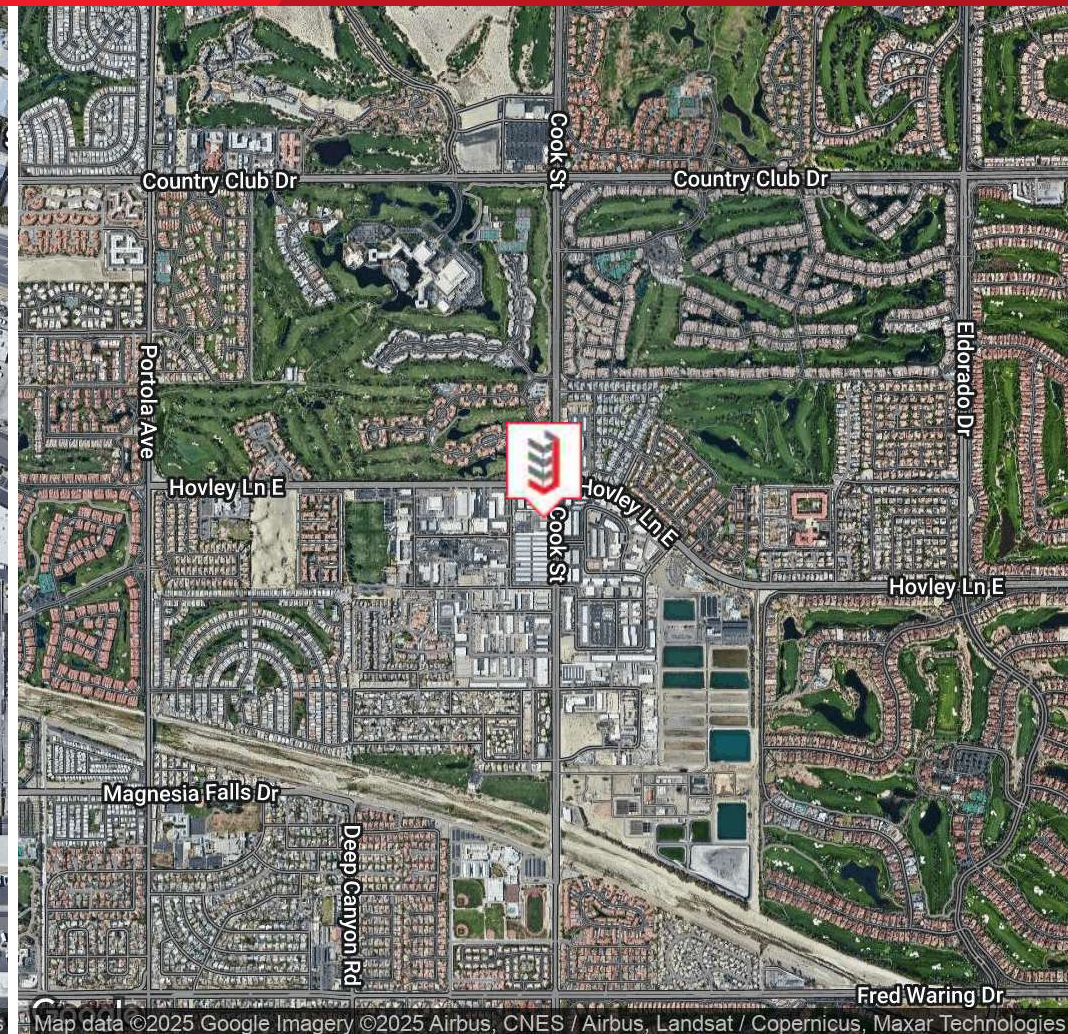
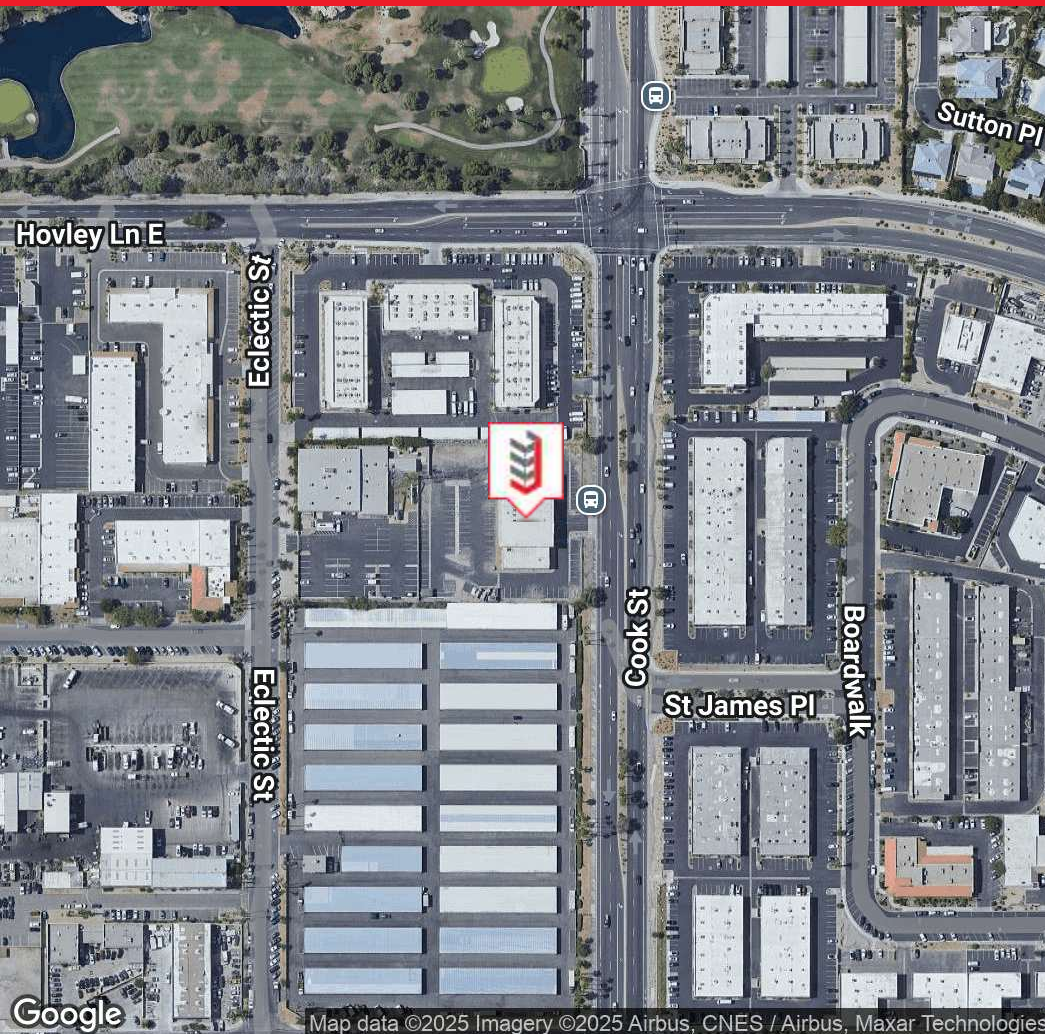
